The Budget Workshop of the Hellsgate Fire District Board commenced at approximately 3:00 p.m.

Board members present included Board Chair Lisa Lamoureux, Board Clerk John Jackson, Board Member Allison Lloyd, and Board Member Jamie Deters. Board Member Blaine Fitzgibbons was absent.

Also present were Fire Chief Randy Haugen and Administrative Manager Angie Lecher. Cris Lecher attended via Zoom as a member of the public.

Fire Chief Haugen presented information regarding the preparation of the Fiscal Year 2027 Budget and provided the Board with a detailed budget presentation. Individual budget categories and line items were reviewed and discussed for accuracy, operational need, and explanation.
