TRAINING RELEASE FORM RULES:

1. Come to class every week and be on time. Trainers will give 24 hours notice if class is to be cancelled for any reason. We ask for the same courtesy if you are unable to attend class.
2. Follow instructions to the best of your ability. Ask questions if you don't understand something. Keep in between conversations are to be kept to a minimum.
3. Do your "homework". The teacher will give you instructions on what to practice at home.
4. There is no smoking on the grounds.
5. You will need both hands and all of your attention on your dog. Leave valuable items at home or in a safe place. This is to include cell phone usage.
6. You are responsible for controlling your own dog. Aggressive behavior from your dog or endangering people or dogs will result in your dismissal from class.
7. Do not be embarrassed if your dog relieves himself. The facility provides "clean up" equipment. Immediately make use of the equipment and do a thorough job.
8. Make sure your dog has had shots to protect him from parvo, distemper and rabies. Proof may be asked at the discretion of the trainers.
9. Keep your dog on leash at all times on the training grounds. He may be well behaved but other dogs may want to fight with a loose dog. Please be respectful of the fellow dog's individual space.
10. Any Electronic or Barking collar or collar resembling is not permitted at Strawberry Fields Dog Company training facility, classes or training areas.
11. If you bring multiple dogs, please plan to bring something to contain them during class. Collapsible crates and x-pens are acceptable.
12. Make sure you bring water for your dog.

For you, the handler:

1. Wear comfortable clothing and **walking** shoes (NO OPEN TOES, SANDALS OR THONGS).
2. Be prepared to do considerable walking/running.
3. Have pockets or fanny packs for treats
4. Bring bite-sized treats that can be eaten quickly. Example- Soft-Kibble or String Cheese.
5. Bring yourself something to drink.

Release of Liability:

I (we) agree Strawberry Fields Dog Company(Sarah Eccleton) the right to refuse this entry for cause which they shall deem sufficient. If I take any steps to make a claim for damages against Strawberry Field Dog Company, its agents, employees or any other released parties, I shall be obligated to pay all attorney's fees and costs incurred as a result of such claim

Strawberry Field Dog Company is following these enhanced procedures to prevent the spread of the Coronavirus (COVID-19).

- All Classes are held outside at our grounds or at public parks.
• Indoor classes, students are required to wear a mask. Outdoor classes students are not required to wear a mask.
• All handlers will be maintaining at least a safe 6-foot distance.
• One handler per dog unless from the same household.
• Each client is required to apply hand sanitizer upon starting the training. (not needed for outside classes but encouraged.)
• All equipment used during training will be cleaned, sterilized, and disinfected.
• All trainers will be ensuring clients and themselves maintain 6 feet or more of distance throughout their time on the premises and will be washing hands and disinfecting before/after ever class.
