Members may address issues during the open forum portion of the meeting. If attendees become disruptive, they may be expelled from the meeting and/or fined.

- **I. Call to Order:** President Christina Calcagno called the meeting to order at 5:00pm.
- **II. Roll Call and Confirm Quorum:** Board of Directors: Christina Calcagno (President), Lupe Agurrie (Secretary). Members: Antonina Gagliano (unit 14), Connor Murtaugh (unit 13), Stewart Polk (unit 12), Brandon Yerkes (unit 11).
- **III. Approval of Prior Minutes:** President Christina motioned to approve November minutes and Secretary Lupe second the motion and minutes were approved.

IV. Unfinished Business:

- 2021 Election Discuss deadline for call for candidates, nomination list, inspector selection and projected March 2022 voting deadline. Call for candidates deadline is 1/16/2022, once those are received the nomination list will be distributed to the members for 30 days, after 30 days ballots will then be distributed and returned back to the inspector of election (Monica Morales owner unit 10), exact date and time have not yet been announced for voting deadline etc. More will be addressed at the next meeting.
