'Ye libe psople of The United States of America, in order to form a more perfect union, establish justice, insure domestic tranquility, provide for the common delense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do andain and establish this Constitution for The United States of America."

"If anyone has been dispossessed without the legal judgment of his peers, from his lands, castles, franchises, or from his right, we will Immediately restore them to him; and if a dispute arise over this, then left it be deated by the five and twenty Jurors of whom mention is made below in the clause for securing the peacs. Moreover, for all those possessions, from which enyone has, without the lawful judgment of his peers, been disseized or removed, by our elected or appointed servants, we will Immediately grant full justice therein." Magna Carta 52

Amendment I: "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

Amendment II: "A well regulated Militla, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed."

Amendment III: "No Soldier shall, In time of peace be quartered in any house, without the consent of the Owner, nor in time of war, but in a manner to be prescribed by law."

Amendment IV: 'The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and selzures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oalh or affirmation, and particularly describing the place to be searched, and the persons or things to be

Amendment V: "No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Millita, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation."

Amendment VI: "In all criminal prosecutions, the accused shall enjoy the right to a speedy and public Irial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously accertained Jaw, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his lavor, and to have the Assistance of Counsel for his defence."

Amendment VII: "In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any Court of the United States, than according to the rules of the common law."

Amendment VIII: "Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted."

Amendment IX: "The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people."

Amendment X: "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the states respectively, or to the people."

Purpose and History
The purpose of the Michigan State Macomb County Committee of Safety is primarily
humanitarian: To protect and defend the unallenable rights endowed upon every living
man and woman by our Creator and Governor of the Universe.

Committees of Safety, historically speaking, empowered the people at the grass roots to return control of their local government to the People. The Independent grass roots "County" Common Law Grand and Trial Jury are the mechanism for the Sovereign Body of the People to govern.

The Common Law Grand Jury exposes the enemies of Liberty both foreign and domestic in an effort to collapse their wail of resistance and take back our Judiclary. The Committees of Safety are needed to fill the power vacuum with "the People", thereby taking back control of our political process at the grassroots level, Both the County Committee of Safety, ark/a Committeeman, and the Grand and Trial Jury County Administrations is the process by which We the People consent to government, it is our unalienable right. unalienable right.

In 1774, the various Committees of Safety called for the First Confinental Congress. Delegaties to that Congress went from town, to county, to Provincial level Committees, before being selected to go to Philadelphia. In Western Massachusetts, Committees of Safety forced the resignations of rouge judges appointed under the Massachusetts Government Act (1774).

The "Committee of Safety" is the very same method that our founding fathers used to take control of their local governments. These "Committeemen" built the nation we inherited that devolved into tyranny as a result of our ignorance and lack of oversight. We the People, through the true elected Committeeman and Committeevam at the Grass Roots, will take control of our local, state and federal governments by simply requiring them to obey the "Supreme Law of the Land" and thereby perform their Constitutional duties.

Goal
The goal of the Michigan State Macomb County Committee of Safety is to maintain safety in the community by requiring our servants in government to obey God's Natural Law, the Constitution for The United States of America (Constitution) and the Constitutional Chain of Command. Especially during a National Emergency, whereas the Peoples' Bill of Rights will be protected and secured by our true Law Enforcer, the County Sheriff.

FEMA has engaged a national "readiness exercise" under the code name of REX 84 which calls for the suspension of the Constitution and the turning of complete control of all local governments over to FEMA while using UN troops to keep law and order during a National Emergency. FEMA's plan leaves out the most important part of rebuilding America, We the People and a Free and Independent Local Government! The end-results of IREX 84 is a New World Order (NWO). he Michigan State Macomb County Committee of Safety has five objectives:

- Protect the unallenable rights and of every living man and woman born in one of the several states of the union defend against both foreign and domestic tyranny,

 3) During a local or national emergency, if there is no Jury administration, the committee
 of safety is to oversee and insure that all positions of power treat people with
 compassion and that rights are not violated,

 4) During a national emergency the Michigan State Macomb County Committee of
 Safety is responsible for assisting the settling of displaced people,
- 5) The committee of safety is responsible for the safety of all people within their county.

Sub-Committees

Sub-committee — educate the people in government by consent and visit schools o require a proper education such as civics, constitution, natural law, trust law, the jury, yourt of record access, et cetera,

Political Committee — support candidates that will learn and obey the constitution and recall all elected representatives that are outside their constitutional authority,

Judicial Committee — oversee the Jury administrators and assist people who are having a problem with a bureaucrat assisting them in gaining access to a grand jury and/or petit y if necessary.

Millia Committee – oversee the establishment and lawful conduct of the local militia to ensure that it is prepared and capable to defend the People of Michigan State Macomb County against attack by enemies foreign and domestic,

Committee of Correspondence - Communicate with other county committees of safety.

Sub-Committee Structure
Each sub-committee will have two officers, Chair and Co-chair. When oveling on
resolutions, I both chairs are not present, signature can be achieved between meetings.
The committee of correspondence will prepare a written report concerning ail
correspondence for approval and advice.

Moderator and Scribe
The general committee will have two officers: Moderator and Scribe. When voting on resolutions, if both officers are not present, signature can be achieved between meetings.

- Dulles of the Moderator
 Schedule regular committee meetings,
 Develop written agendas for conducting meeting,
 Conduct the committee meeting,
 Approve committee correspondence and reports,
 Supervise the preparation of meeting minutes,
 Chairs serve at the pleasure of the committee.

Duties of the Scribe
This position requires some administrative and clerical skills for proper recordkeeping.
Maintain all files and keep minutes. Minutes of the last meeting are to be read at the opening of the meeting and approved by all or corrected and then entered into the record.

Duties of the Treasurer Responsible for collecting dues and donations, over-seeing fund raising, purchasing and giving an account at the beginning of every meeting.

Election of Moderator and Scribe
The election of a new moderator or scribe will be held during the monthly committee
meeting whenever a motion to replace either or both officers is made by majority vote.

Meetings
The COS should meet once a month.

Communications
The Michigan State Macomb County Committee of Safety (Michigan State Macomb County Committee of Safety) should seek out at least one HAM Radio operator. HAM operators are already prepared for emergency communications so they should be easily approachable with our plan. NLA has information on becoming a HAM Radio operator.

Voting Quorum

Each member has one vote,
All voting is done in public by the counting of hands,
Forty percent of the members constitute a quorum,
A majority vote of attending members is required to approve all committee decisions,
Member must be present to vote, proxy votes are a wrongdoing and are unacceptable.

Minutes will be recorded at each committee meeting and distributed to all committee members at the next meeting. The scribe will retain a copy for three years. The minutes will include all reports, evaluations and recommendations of the committee. The minutes will also identify committee members who attended monthly meeting and representatives who were absent.
