Due to the success of vaccines, the diseases they prevent no longer serve as highly visible reminders of the benefits of vaccination. On the other hand, conflicting, inaccurate, and sometimes alarming information about the risks of vaccines are readily available on bookstore shelves, internet sites, and in blogs. Today, parents have questions about immunization and vaccine safety, and these concerns may be serious enough for some parents to choose to not fully vaccinate their children against serious and sometimes deadly vaccine-preventable diseases. Centers for Disease Control's (CDC) National Center for Immunization and Respiratory Diseases (NCIRD) has undertaken a structured series of research projects to gain knowledge about parental attitudes and concerns and the best ways to provide clear, consistent, and timely immunization information to parents to assist them in making informed decisions about vaccination. NCIRD recently launched a new suite of resources, Provider Resources for Vaccine Conversations with Parents, that provides clinicians, health care providers, public health partners, and health educators with messages, materials, and tools they need for the most effective communication practices—in this case, effectively addressing parents' questions and supporting parents in their vaccination decisions. This presentation will provide information on factors that contribute to vaccine hesitancy, CDC's up-to-date qualitative and quantatative research on parent and health care provider knowledge, attitudes and behaviors about vaccination. Dr. Sheedy will also share how this research, combined with sciencebased communications strategies and risk communication principles, was used to inform the development of communication strategies, immunization messages, and materials.

Data and results of the School-based Clinics Pilot Project will be presented, followed by a panel discussion with a Mollen representative, a public health nurse, an immunization initiative Coordinator, a school nurse and a school administrator who were involved in the project.

As the incidence of vaccine preventable disease decreases, both patient and clinician recognition of previously common infections becomes a difficult task. Without familiarity of symptoms and signs of less common preventable diseases timely and accurate diagnosis becomes less certain when breakthrough infections occur. As each vaccine becomes more effective, diseases decrease and the apparent threat of infection dissipates, challenging the ability to counsel patients and parents regarding the balance of benefits and risks of each vaccine. During this session, the successes of effective immunization programs will be compared with ever recurring lapses in vaccine delivery and the specific symptoms and signs of vaccine preventable diseases, including all diseases currently on the Advisory Committee on Immunization Practices (ACIP) schedule will be discussed.

- Recognize the impact of vaccinations with many previously common infectious diseases included on the routine ACIP vaccine schedule;

There are approximately 342,000 children under age 19 in NH for whom vaccine is provided through this program. The program also promotes immunization initiatives for children and adults to assure the opportunity for a lifetime of protection from vaccine preventable diseases.

Immunization of children for selected diseases is required for school and day care entry in accordance with NH Statutes. These laws currently require immunizations for the following diseases: diphtheria; HIB (Haemophilus influenzae Type b) required for child care only; Hepatitis B; Measles; Mumps; Pertussis; Polio; Rubella; Tetanus; Varicella.

The NH Immunization Program is a resource for healthcare providers and the public regarding the importance of vaccination for all vaccine preventable diseases.
