



Herpes zoster (or Shingles) is a painful blistering rash resulting from the reactivation of latent Varicella-zoster virus, the risk for which dramatically increases with age including the disabling complication of post-herpetic neuralgia.



Excellence in Vaccine Management

Foundation Medical Partners, Department of Nursing

In 2017, Foundation Medical Partners, Department of Nursing Team created and implemented a standard of care for vaccine transport for all of its practices. This initiative included the development of vaccine cooler pack out protocols for transportation of refrigerated and frozen vaccines using phase change material.

To maintain a standard of excellence in vaccine storage and handling, the transport guidelines were implemented in all thirteen practices that receive State vaccines. In addition, this team went the extra mile, collaborating with SNHMC Pharmacy, in expanding the initiative to include the twenty-seven practice sites that do not receive State vaccine.

These improvements enhanced staff awareness of the cold chain, standardized vaccine transport, and identified vaccines that may have been exposed to temperature excursions, thus preventing the administration of nonviable vaccines to patients.

Excellence in Childhood and Adolescent Immunizations

Angel Ekstrom, Regional Public Health and Emergency Preparedness Coordinator/School-Based Clinic (SBC) Supervisor for the Central NH Public Health Network

Angel is responsible for organizing and managing school-based influenza clinics for Central NH. She set-out to increase immunization rates for the school-based influenza clinics in 2017—2018 and was determined to distribute clinic forms earlier than usual to give schools an opportunity to include the materials in student packets with other important school paperwork in early August or on the first day of school. Through the countless efforts of Angel and teams of volunteers working 465 hours, they were successful in increasing rates overall by 31% in Central NH. Clinic forms that were sent with other important school paperwork in August or the first day of school yielded a higher completion and return rate than clinic forms that were sent later independently.

Excellence in Immunization Education

City of Nashua Public Health Nurses

In July, 2017, the City of Nashua Public Health Nurses successfully coordinated an Annual Community Health Conference held at the Courtyard Marriott in Nashua, NH. The Conference educated over 100 health care professionals on current, emerging immunization practices and strategies for disease prevention. Timely vaccine updates, vaccine awareness and disease prevention strategies were presented. The event was used as an educational opportunity to inform attendees on vaccine preventable diseases and strategies to promote vaccinations in populations most vulnerable to infections (children, adolescents, the elderly and adults). In planning this event, the nurses demonstrated leadership in the area of public health practice that addresses primary and secondary prevention initiatives. This type of conference allows for health care professionals to enhance their knowledge of disease and the importance that vaccines play in preventing disease outbreaks.

Awards

Excellence in Vaccine Management

Holly Beam, LPN Alice Peck Day Multi-Specialty Clinic-Primary Care

Holly Beam, LPN at Alice Peck Day Multi-Specialty Clinic Primary Care is instrumental in ensuring all health care staff learn and implement proper vaccine storage practices. She finds creative ways to enforce the knowledge. She most recently developed a "mock" drill approach to addressing temperature excursions. She randomly approaches staff, provides a temperature excursion scenario and asks them to address how to handle it by using proper protocols. To ensure all staff are in compliance and no steps are missed, she created a checklist. This approach is so well received, that it has been incorporated into the clinic's yearly competencies and new employee trainings.

Excellence in Adult Immunizations

Manchester Health Department Division of Community Health and Neighborhood Health in Partnership with Walgreen Company

The Manchester Health Department (MHD)'s Divisions of Community Health and Neighborhood Health partnered with Walgreen Company to offer adult influenza and pneumonia vaccines at offsite clinics. The MHD provided adult immunizations at no charge to uninsured or underinsured individuals through the NH Adult Immunization Section while Walgreens provided immunizations to those individuals with insurance. Clinics were held in local schools in conjunction with evening events sponsored by the MHD's Community Schools project. Community health workers affiliated with the Community Schools project provided outreach by sending notices home through the school as well as canvassing the neighborhood to increase awareness the clinics, but also the risk factors for which an influenza or pneumonia vaccine would be strongly recommended. Through this public-private partnership, 69 adults received the influenza vaccine and 12 received the pneumonia vaccine in 2017. An additional 120 children were also vaccinated with the influenza vaccine at these school events during our fall clinics.

Excellence in Influenza Vaccination

The following practices are being recognized as champions for implementing influenza vaccination mandates in their healthcare settings. They require employees receive their annual influenza vaccination or take serious measures to prevent the transmission of influenza from unvaccinated workers to patients. Such measures might include a mask requirement, reassignment to non-patient-care duties, or dismissal of the employee.


