1. Owner agrees to pay Kota's Kamp LLC the Daily or Hourly Rate each day/hour that the Owner's
pet(s) is boarded, groomed, or otherwise cared for by Kota's Kamp LLC. If a pet is present during a

Kota's Kamp LLC agrees to (a) exercise due and reasonable care when caring for the Owner's pet(s) and (b) house the Owner's pet(s) in clean and safe quarters. Owner agrees they are dropping the pet(s) off in good health, free from contagious disease, active on flea/tick prevention, and with all required vaccinations.
- 2. Kota's Kamp LLC agrees to exercise due diligence and care when in possession of Owner's pet(s). Owner agrees to hold Kota's Kamp LLC harmless for any loss or damage of pet(s) including but not limited to disease, death, theft, injury, the pet(s) running away, and other unavoidable damage incurred by pet(s). Owner agrees that Owner will be responsible for any medical and veterinary costs that pet(s) incurs after staying with or being cared for by Kota's Kamp LLC.
- 3. Each time that Owner drops off Owner's pet(s) to Kota's Kamp LLC, Owner will provide Kota's Kamp LLC with a date (hereinafter known as 'Pickup Date') by which Owner will pick up Owner's pet(s) from Kota's Kamp LLC.

- 4. Owner gives Kota's Kamp LLC permission to (a) take photographs of Owner's pet(s) and (b) display photographs of Owner's pets on social media or on the business premises.
- 5. Kota's Kamp LLC will notify Owner immediately if the Owner's pet(s) becomes seriously ill. If the situation allows, Kota's Kamp LLC will first attempt to contact the veterinarian listed above. Owner gives Kota's Kamp LLC the authority to contact any Ohio licensed veterinarian to care for the Owner's pet(s) if the veterinarian listed above cannot be contacted immediately. Owner gives Kota's Kamp LLC authority to administer medicine or general care to Pets. Owner agrees to make payment to Kota's Kamp LLC within 10 business days for any expenses incurred by Kota's Kamp LLC in caring for the Owner's pet(s).
- 6. According to Section 4741.30 of Ohio State Law, if Owner does not pick up their pet(s) within 10 days of the Pickup Date, the pet will be considered abandoned, and owner agrees that Kota's Kamp LLC (a) will own the pet(s) and (b) has the authority to place the pet wherever Kota's Kamp LLC sees fit. Owner will be liable for any costs incurred by Kota's Kamp LLC during this time period.
- 7. If Owner does not pick up their pet(s) the day stated above with no contact to the establishment, an inconvenience charge will apply.
- 8. Owner agrees to pay Kota's Kamp LLC immediately upon picking up pet(s) or after service is completed. Owner agrees that no refund will be paid by Kota's Kamp LLC to Owner for any reason. Kota's Kamp LLC may charge fees in excess of the Service Rate including but not limited to repair costs for property damaged by pet, items necessary for pet(s) care, food, bathing, transportation, unexpected visits, late pick up/drop off, and emergency expenses. Kota's Kamp LLC agrees to provide receipts or documentation of any fee charged in excess of the Service Rate.

The foregoing provisions and terms are acknowledged by Owner and Kota's Kamp LLC to be the entire agreement between the parties. After both parties sign below, this Owner-Pet Sitter agreement will be effective and valid until one party notifies the other party in writing that they no longer wish to be bound by the provisions and terms of this agreement.
