- 1. All contestants must be FFA members in the State of New Mexico as certified by Agriculture Education Advisors.
- Projects exhibited in this department must be constructed by students under the supervision of agriculture education advisors during the school year or summer of the current County Fair.
 Projects may be entered by Individuals or by Chapter if more than one person built the project.
- 3. Exhibitors will pay a \$5.00 Entry Fee for each entry.
- 4. Each entry must have a **BILL OF MATERIALS** submitted with the project when it is brought to the Fair.
- 5. Entries will be received in the Fair Building on Monday from 3:00pm to 6:00pm or on Tuesday from 8:00am to 11:00am.
- 6. Exhibitors can enter more than one item but the items cannot be in the same Class.
- Champion Ribbons may be awarded for each division. Champions will be considered for the Grand Champion Over-All Indoor Exhibit which will be sold at the Junior Livestock Sale on Friday evening. Junior Livestock Rules will apply, exhibitors can only sell two (2) items/animals in the Sale.
