Aaron Aung and Nadia Cole are extremely responsible, resourceful, smart young adults with excellent work ethics. Aaron is an Operations Manager responsible for teams across multiple business divisions with a goal to join the National Guard; and Nadia, a Washington State University Graduate with a high GPA was studying for her law degree. They both have high moral standards, a strong sense of justice, right and wrong. Both are very compassionate and loving individuals. Seraya, our most precious granddaughter, is in very capable hands. Our family's observation on the inside is that they acted on Seraya because they felt she was in **imminent danger**. Our family observed how much Nadia took to loving Seraya and caring for her like her own daughter.

On the day before Aaron was supposed to be leaving for a trip to Montana, Mrs. Aung received a series of alarming text messages from Samara Harmon about the health condition of Seraya and shared that with Mr. Aung. Samara’s text messages suggested that Seraya had a very large swollen belly, and her intestines were about to explode.

Before Seraya left with Aaron for his “trip” to Montana, Mr. Aung and Aaron Aung called the Emergency Room Director at Pullman Regional Hospital to make sure they understood Seraya’s health condition. The report from the Emergency Room Director was that the constipation Seraya was experiencing was normal and that water, prune juice and some other medication will take care of the problem. Additionally, the Director said this was common among children even up to the age of ten and it was not a serious condition. Given this report, it was “good to go” for Seraya on her trip with Aaron. This confirmed the unstable, misleading, personality of Samara which was very familiar to the Aung family.

Before their “gone missing” status, both Aaron and Nadia observed Seraya coming to their home stinking like weed, dog urine, smelling dirty like a garbage truck and unkempt. Seraya would be received with dirty nails, pen-marks, and rashes in her private areas. The baby would have unusual behavior such as saying “go away” when her diaper was being changed. There is suspicion that the Seraya may be getting molested. All this was also observed by Adel Aung, Aaron’s younger sister, since Aaron would complain to her and Nadia.

When Samara lived with Aaron in various residences, she kept their home like a pigsty. Aaron would complain of having to pick up after dirty diapers, sometimes up to two dozen at a time, all over their home. Here is one image of many, how Samara kept one of their residences, a studio apartment in Moscow, Idaho:

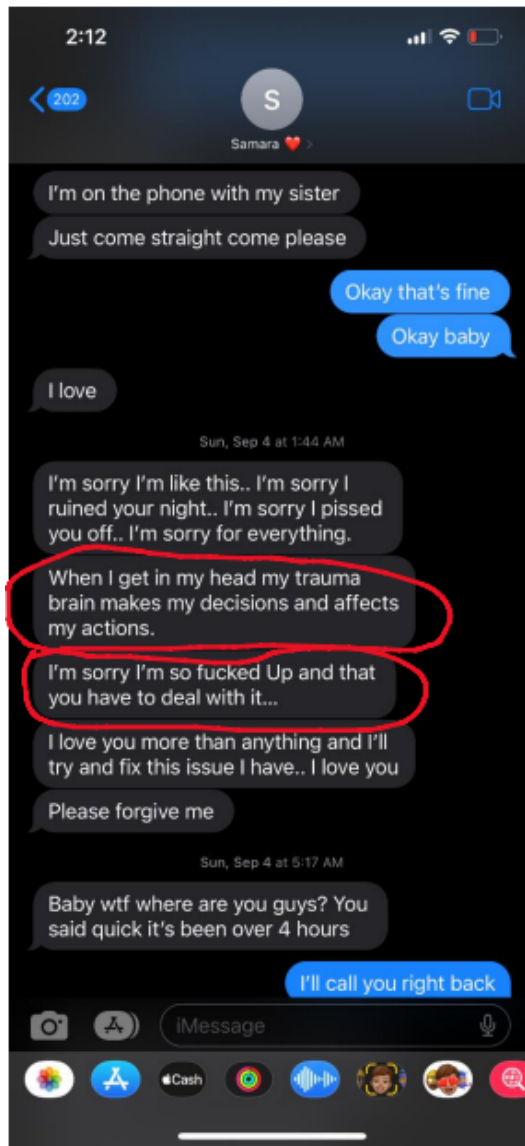


Due to the custody issue surrounding Seraya, we discovered the family court system in the United States is a disaster, often, very willing to hand over almost full custody to dead-beat moms, and essentially “castrating” young, capable men.

Samara’s half-brother is reputed to be a pedophile and he spends a significant amount of time with Samara whom he raped when they were young. Samara has various self-admitted psychological issues which she communicated by text multiple times to Aaron. Here is one she calls “trauma brain.”

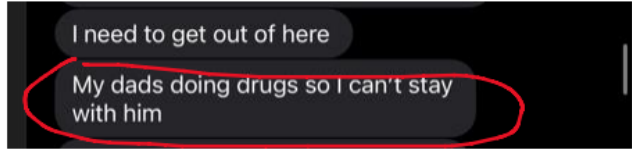


Furthermore, one or more Samara's family is revealed to do drugs to the point of creating toxicity and domestic violence in their family. Here is an excerpt from a document provided to Aaron Aung's attorney:

Samara writes to me, "The way that you go from texting me to being silent and back and fourth like **that scares me**... it makes me think you're texting someone else and then responding to me when the convo with them lightens up... **I'm so ducking scared**. Like **I'm terrified of the thought of you moving on** to someone else and forgetting all about me... **I'm so scared you're gonna lead me on and then never want me back**...can you go ahead and admit you have moved on now? I need to hear you say it. Please tell me you're coming? **Please please please come and get us...My dads doing drugs** so I can't stay with him."

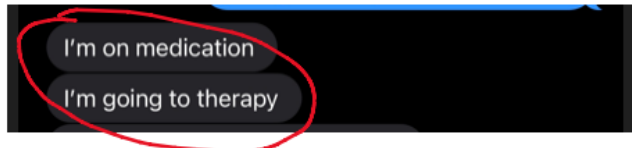


Samara: "Us being only friends doesn't bother you at all,,? It's not hard for you..? I thought everything was being fixed... I thought we would try again.. why did you refuse to see or help me today..?"

Aaron: "What the fuck samara. I thought we agreed to fix things ...**then you wait until I leave to fuck another guy in my place? Ugh.**"

Samara replies, "I know... I'm sorry... **I snapped and I fucked up...**"

Samara writes, "**I'm on medication**. I'm going to **therapy.**"



Samara herself was using heavy cocaine prior to her and Aaron ending their relationship. A private investigation firm hired by Mr. Aung during the custody battle revealed the following:

WITNESS INTERVIEW REPORT: 3/21/23



Toyota of Pullman WA, – (509) 872-3600, IN RE: Joe Harmon 3/16/23 @ 10:30AM Investigator reached out to Toyota of Pullman WA and spoke with “Jesse” and “Dillon”, both service managers. Interview findings:

- Both subjects knew of Joe Harmon, however never witnessed any drug use. Jesse stated he observed some odd and erratic behavior, but nothing overtly drug related. Both subjects were agreeable, however vehemently stated they did not know anything of consequence.

Anson Meagher – (208) 699-4774, Mom cell (509) 990-5261, IN RE: Samara Harmon 3/16/23 @ 11:45AM Investigator called primary number on file for ANSON, no answer, no VM option. Investigator was able to make contact with the target’s mother. Investigator simply gave a call back number and name, as to not alert the mother/target as to the nature of the call, i.e. trying to prevent a no call back scenario. Currently waiting on Anson for call back. Call back received from ANSON, interview findings:

- 3/16/23 @ 12:00PM Investigator spoke with ANSON. Subject stated Samara Harmon offered him cocaine approx. 5 months ago during one of their meetings, however he declined. He then witnessed her “snort a fat line (of cocaine)” in front of him. He stated she is “not the most stable” person, and there “are some issues there, for sure”. He

Our attorney in charge of the custody case in Idaho successfully negotiated with Samara for a 50/50 split custody. This was a private custody agreement. However, in order to achieve this, Samara forced Aaron to agree to the vaccination of Seraya.

When Samara first met Aaron, she was clearly advised about our family values. **We do not vaccinate.** Out of our four kids, only our oldest daughter was vaccinated. We did this because we did not know better back in the 1990’s. As parents, for the safety of our other three children, we did not vaccinate them. They are now strong, healthy, young adults.

When Samara was advised about how our family sees vaccines, she adamantly agreed and maintained that she believed the exact same thing. However, when the custody battle started, she used this as a tool in an attempt to gain greater custody because she knew the State will see her favorably.

Mr. Aung’s father, Dr. Tin Aung, left Burma, in the early 1970’s to escape a totalitarian government and was afraid for his own children’s lives. Mr. Aung now finds himself in a surreal episode having to think that the USA is heading this way, especially in the family court system which now impacts his own kids and grandkids. Mr. and Mrs. Aung have been married for 34 years and fortunately never had to be involved in any family court proceedings prior to the incident with Samara Harmon.

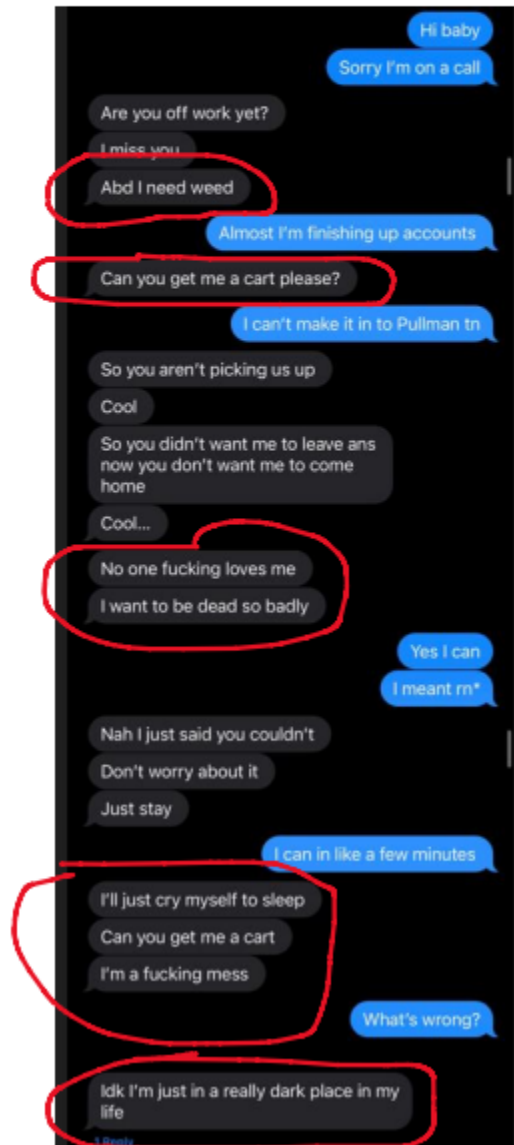
