SONS OF THE REVOLUTION IN THE STATE OF NORTH CAROLINA, INC.

We, the undersigned natural persons of the age of eighteen (18) years or more, do make, and acknowledge, these Articles of Incorporation for the purpose of forming a non-profit corporation under and by virtue of the laws of the State of North Carolina:

ARTICLE I

The name of the corporation is SONS OF THE REVOLUTION IN THE STATE OF NORTH CAROLINA, INC.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purposes for which the corporation is organized are:

- (a) To perpetuate the history, literature and traditional values of the period before, during and after the War of the Revolution.
- (b) To promote educational, literary, patriotic and social interests and activities pertaining to preserving and perpetuating liberty and freedom in our state and nation.
- (c) To establish, for the purpose of preserving among their descendants, the memory of those brave men who periled their lives and fortunes in the War of the Revolution, to wrest the American colonies from British Dominion.

ARTICLE IV

The corporation shall have members which may be divided into such classes as shall be provided in the By-Laws; the persons who may not otherwise qualify under certain rules of ancestry requirements or otherwise but who may have contributed conspicuously to the preservation of history, liberty, freedom and society generally, may be eligible for honorary membership and so long as the recognition of such persons is consistent with the purposes of the corporation. All members shall be accepted, appointed, elected or designated in the manner provided in the By-Laws and in accordance with the rules, regulations and procedures required of the national organization of the Sons of the Revolution.

ARTICLE V

The directors of the corporation shall be elected by the members in the manner provided in the By-Laws.

ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation; and upon dissolution of the corporation, the assets thereof shall, after all of its liabilities and obligations have been discharged or adequate provisions made therefor, be distributed to any association or associations qualifying as an exempt organization under Section 501 of the 1954 Internal Revenue Code.

ARTICLE VII

The address of the initial registered office of the corporation shall be 175 West New Hampshire Avenue, P. O. Box 116, Southern Pines, Moore County, North Carolina 28387, and the name of its initial registered agent at such address is W. Lamont Brown.

ARTICLE VIII

ARTICLE X

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law or (b) a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or any corresponding provisions of any future United States Internal Revenue Law.

ARTICLE XI

Notwithstanding any other provisions of these Articles, the purposes for which this corporation is formed are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code.

ARTICLE XII

The Board of Directors of the corporation shall have full power and authority to adopt By-Laws of the corporation, and as the needs may require, from time to time, to adopt modifications and amendments to the By-Laws in accordance with the procedure that may be prescribed therein.
