Baby Show official Rules and Regulations

1. Entrants register day of show at time specified above.
2. No special clothing needed. (Casual clothes only. No costumes, No make-up.)
3. The decision of the judges will be FINAL.
4. \$15.00 registration fee (cash or money order only).
5. Placing up to fifth in each division

6 months to 1 year - 8:30 A.M. (Reg. 8:00 A.M.)

1 year to 2 years - 9:30 A.M. (Reg. 9:00 A.M.)

2 years to 3 years - 10:30 A.M. (Reg. 10:00 A.M.)

3 years to 4 years - 11:30 A.M. (Reg. 11:00 A.M.)

4 years to 5 years - 12:00 P.M. (Reg. 11:30 A.M.)

if child has reached 5th birthday on or before July 1, 2024 he/she is not eligible for baby show. See Little Miss/Little Master Contest on Tuesday Night.

Little Miss/Master official Rules and Regulations

Pageant will start promptly at 5:00pm

Please arrive at 4:30pm on Tuesday for a brief practice before starting the pageant

Contestants will enter the pageant as a PAIR. No single entries allowed.

Wardrobe:

Girls: Dresses are short dresses, no formal dresses. No costumes or hats and little to no make-up.

Boys: Business casual. This may include jeans and a dress shirt, dress pants and dress shirt with tie or bow tie.

Scoring:

Couples will be scored on how they present as a couple, hand in hand or arm in arm

Personality

Both will be asked a casual on stage question from entry form

Rules:

- Contestant must provide his/her own partner and compete as a couple. Couples must present themselves hand in hand or arm in arm. Individuals will be asked a question and must respond. Contestants will be judged on appearance, compatibility and response to questions all as a COUPLE.
- Child must have reached his/her 5th birthday by July 1st and cannot have reached his/her 8th birthday by July 1st.
- Girls cannot wear any long dresses. (No costumes. No hats. No make-up.)
- Boys cannot wear any tuxes or tux parts. (No costumes, No hats.)
- \$40.00 registration fee (see instructions above)
- Parents will not be on stage with child.
- There will be an on stage interview.
- Contestants must check in 30 minutes before show time.
- Child must come dressed.
- Must be a KENTUCKY resident.
- Winning boy and girl will be eligible to compete at 2024 KY State Fair Little Miss/Little Master Contest in August and will compete as a couple. Contestants are sponsored by the Kenton County Fair Board.

Rules for Miss Pre-Teen

1. Contestant in Miss Pre-Teen must be a Kentucky resident, this winner will go to state in October.
2. Miss Pre-Teen Kenton County Fair must be a Kenton County resident and will NOT go to state in October . But will fulfill all duties in Kenton County and being active in our community. (Attending the fair, local parages and fundraiser events of their choice.)
3. Contestant in Miss Pre-Teen may not have won another 2024 County Fair.
4. Contestant must have reached her 8th birthday by June 20th and cannot have reached her 13th birthday by October 31st.
5. Contest for girls only
6. \$50.00 registration fee
7. Girls will compete on stage wearing a evening gown for poise and elegance.
8. There will be a closed 2 minute interview
9. Parents will not be allowed on stage with child
10. Contestants will need to be dressed and ready for interviews at 5:45pm to start on time.
11. Contestants must come dressed in an appropriate business casual attire for interview
12. Miss Pre-Teen will compete in state competition in October
13. Open stage will be held on Sunday, July 14th from 1pm-3pm. The directores will not be present but you are free to practice on teh stage

Wardrobe

- Interview: A dress, skirt, pants or jumpsuit. Dress as you are going to be interviewed for a job.
- Opening Number/Introductions: Cocktail dress. A short fun dress to introduce yourself on stage. This portion is NOT being judged.
- Swimwear: One-piece and one color
- Evening gown: A floor length gown. No high lows or cocktail dress.

Interviews will start promptly at 5:00pm

Pageant will start promptly at 5:45pm

Wardrobe

- Interview: A dress, skirt, pants or jumpsuit. Dress as you are going to be interview for a job.
- Opening Number/Introductions: Cocktail dress. A short fun dress to introduce yourself on stage. This portion of the pageant will be judged.
- Evening gown: A floor length gown. No high lows or cocktail dresses.

Rules for Miss and Teen division:

1. Contestant agrees to abide by all rules of the local and state contestants now in effect or as announced hereafter.
2. Contestant agrees that the time, manner and method of judging the contest shall be solely within the discretion of the Kenton County Fair Board and that the decision of the judges shall be final.
3. Contestants in Miss Kenton County Pageant (MISS and TEEN) must be a Kentucky resident

4. A contestant in Miss Division, must have reached her 16th birthday by October 31st and cannot have reached her 22nd birthday by or on October 31.
5. A contestant in Teen Division, must have reached her 13th birthday by October 31st and cannot have reached her 16th birthday by or on October 31.
6. A contestant must be single, never married, never had a marriage annulled, and never had any children. (This rule applies until after the state pageant for Miss Kentucky County Fair.)
7. The contestant must be of good moral character.
8. Contestants must not be a winner of another Kentucky County Fair.
9. Winner of Miss Kenton County Pageant will represent Kenton County at the state pageant in January 2024.
10. Winner of Teen Miss Kenton County Pageant will compete at the state competition in October 2024.
11. Miss Kenton County contestants will compete in interview, cocktail (not scored), swim suit and evening gown. Please select a one-piece swim suit in a solid color (no prints) for swim suit competition. Evening gown must be floor length.
12. Teen Miss contestants will compete in a evening gown, cocktail dress and interview competition. A short cocktail dress for opening number/introductions.
13. Judging for pageants will be based on scores from interviews and personality, poise and appearance. For on stage introduction a short cocktail dress (This will NOT be judged for Miss & will be judged for Teen).
14. Open stage practice will be held from 1pm-3pm on Sunday, July 14th. The director may not be present for this.

Wardrobe

- Interview: No interview this year
- Cocktail: On stage introductions will be completed in a cocktail dress that is knee length or above
- Evening Gown: Floor length dress, no cocktails or high low dresses

Rules for Mrs./Ms. Kenton County Fair

- 1) The contestant must be a natural born female, single, married, divorced or widowed and can have children. A birth certificate is required.
- 2) Contestants may not compete in any other pageant system that would prohibit the fulfillment of responsibility through the state during her reign as Mrs./Ms. Kentucky County Fair.
- 3) Volunteers are not to be held responsible in any way for disqualifications of winners and/or contestants. Grounds for disqualification can be BUT are not limited to untrue statements or registration forms, misconduct, obscene, foul language, unruly/unbecoming behavior that is posted on social media and or the internet porn and any other reasons the pageant committee may deem as necessary. The board will make all decisions and they will be final.
- 4) Clothing for the pageant will MODEST, meaning no cut outs in the attire, very MODEST cleavage showing in all attire
(no low cut in tops that go to the belly button), no slits will be allowed higher than mid-thigh, no see-through attire.
- 5) The local Fair Board or sponsor is not responsible financially for transportation, room and reserved seating or responsible for making such arrangements.
- 6) Anyone winning a KAFHS state title is not eligible to compete in that pageant thereafter
- 7) Local fairs cannot accept contestants with out of state residence
- 8) Open stage will be held Sunday, July 14,2024 from 1pm-3pm. The directors will not be present but you are free to practice on the stage.
