Fire Chief

a. Fire Chief Activity Memo March

FC Davis reported the 2025 version of the State Mobilization Plan will be presented to the State Fire Defense Board in May. Through Title III funding, a few places within District 1 were awarded fire mitigation grants. KCFD1 recruitment was opened for two mitigation positions through the Community Risk Reduction program, to start May 1. FC Davis and DAS Hull are developing the 2025-2026 budget, the 2024 Annual Report is complete, labor negotiations continue, and the DC of Operations assessment center will take place in April.

Deputy Chief

a. DC Activity Memo March

DC Hitchcock reported an ambulance will be hired back for the Kingsley Field Air Show in July; the expected attendance is 20,000–30,000 people. Station projects taking place are the Station 1 generator installation, Station 3 roof repairs from the storm (50% covered by insurance), and the Station 4 air line project. The District continues to address the needs of specific frequent flyer and lift assist patients. The CAD rollout was March 18; a lot of extra time and effort was put in by Celeste Aldinger and DC Knutson. In addition, there have been a lot of visits with local high school students recently, the spare ambulance chassis that was in Idaho sold, the new remounted ambulance and the OSFM Type III engine should be received in April. DC Hitchcock attended an OSFM zoom presentation regarding ways local departments and task forces can work better with the state, discussions and plans for fleet maintenance continues to be discussed with the city, the Klamath Interoperable Radio Group (KIRG) completed the county communications plan and all county radios should be reprogrammed within the next month. DC Hitchcock addressed questions from Board members.

a. DC-Training Activity Memo March

DC Knutson highlighted March trainings which included Blue Card professional development recertification, a two-day apartment bundle training with standpipe information, EMS case reviews with Dr. Smestad, NFPA leadership training series, CAD, and building familiarization. Firefighter Beau Baley was able to complete a one-week firefighter academy with the hard work of instructors/firefighters Josh Ryan and Cody Engler.

FM Tramp met with the Klamath Falls City Park Advisory Board regarding the upcoming Moore Park mitigation project. The Oregon Fire Code Committee will be working on 2025 code revisions with an October 1, 2025 implementation date. FM Tramp also reported specialized addressing was developed for the ladder truck, 29 full commercial fire and life inspections we completed, 86% of 1,200 systems are in compliant status, the current radio advertising topic is community risk reduction, and the Prevention Division staff had a booth at both the Home Show and the Sportsman show.
