

North Georgia Winery Tours LLC – Terms and Conditions

1. Age Requirement

By booking and participating in our winery tours, all guests confirm that they are **21 years of age or older**. Minors or individuals under the age of 21 are strictly prohibited from joining the tours or any associated transportation services. All guests must present a valid driver's license showing proof of age.

2. Acknowledgment of Risk

Participation in winery tours involves certain inherent risks, including transportation hazards, personal injury, and risks related to the consumption of alcohol. Guests voluntarily **assume all risks** and agree to hold North Georgia Winery Tours LLC and our drivers harmless from any injuries or damages that may arise during the tour or travel.

3. Release of Liability

North Georgia Winery Tours LLC, including its employees, drivers, subcontractors, and agents, shall not be held liable for any injury, loss, or damage sustained during the tour or transportation. Participants hereby **waive, release, and hold harmless North Georgia Winery Tours LLC** from any claims or demands that may arise, whether due to negligence or otherwise.

4. Alcohol Consumption

Participants assume full responsibility for their alcohol consumption and agree to comply with all local laws. North Georgia Winery Tours LLC is not responsible for any incidents or damages related to alcohol use.

5. Health and Safety

Guests certify that they are in good health and physically fit to participate. All participants must comply with safety instructions provided by drivers or guides to ensure the safety of the group.

6. Medical Emergencies

In the event of a medical emergency, participants authorize North Georgia Winery Tours LLC or its representatives to obtain emergency medical care on their behalf. The participant is responsible for any medical expenses incurred.

7. Indemnification

Participants agree to **indemnify and hold harmless North Georgia Winery Tours LLC**, its employees, subcontractors and agents from any claims, costs, or legal expenses resulting from their participation in the tour or transportation.

8. Additional Fees

- A **\$150 fee** will apply for every hour that exceeds the scheduled tour time.
- **Tasting fees** are not included and vary by winery.
- **Driver gratuities** are not included but are appreciated (recommended 10-20%).

9. Compliance and Removal from Tour

Failure to follow instructions from drivers or guides may result in **removal from the tour without a refund**. Guests are expected to behave responsibly during the tour.

10. Governing Law

These Terms and Conditions are governed by the laws of the State of Georgia. Any legal disputes will be resolved in the courts of Lumpkin County, Georgia.
