The Silver Creek Board would like to welcome all new residents who have moved in during the past few months. We hope you are enjoying your new home and new neighbors. We would like to remind you that this is a deed restricted community. You should have received a copy of the deed restrictions at your closing. Please visit our neighborhood website **silvercreeklouisville.com** to download any neighborhood documents or request forms.

NEIGHBORHOOD COMMUNICATION

The 2020 maintenance fees for all Silver Creek residents will be decreased from \$327 to \$160. This will be a ONE-YEAR reduction only. Residents will also have until October 1, 2020 to pay their respective fees. In 2021, the dues will revert back to an amount assessed in the past few years (\$327) if there is little or no change in the expenses that must be incurred by the HOA.

The Board is able to provide this one time reduction because of limited savings realized over the past years from a few reduced financial demands for items such as repairs and snow removal. We expect to provide the same level of services to our community for the next year but will remain cautious in our spending. We hope this temporary one-year reduction provides some relief to the residents in our community.


