JORDAN RIVER VALLEY TEST HIKE

DATE: SAT, JUNE 19, 2021 OPEN START 9:00AM to 11:00AM

This is a wonderful loop hike that was used very successfully for our last Grand Canyon trip in 2018. It is the only wilderness area in the Lower Peninsula and is located 4 hours 10 minutes from South Bend and 3 hours 40 minutes from St. Joseph. It is definitely possible to do this as a day trip. For those who feel comfortable staying over several area campgrounds and hotels are scheduled to be available.

COURSE: This 18.7 mile course is a very scenic clockwise loop through the Jordan River Valley and features several hills, including the half mile Deadman's Hill at the finish. Much of the course is also on the North Country Trail (NCT). Trekking poles are definitely recommended.

OTHER COURSES: There are three shorter course options that are also good:
Deadman's Hill Loop (3.2 miles): Starts and finishes at Deadman's Hill trailhead.
Pinney Bridge to Deadman's Hill (9.4 miles): Great hike but requires you to provide your own drop off at Pinney Bridge. (Two or three with two cars could make this work.)
Deadman's Hill – Fish Hatchery – Deadman's Hill loop (8.6 miles): Another great hike that starts and finishes at Deadman's Hill trailhead.

AID: There will be two aid stations on the course at Pinny Bridge and at Jordan River Bridge. Please bring your own water and pack your daypack according to the daypack checklist on my website (if you need a copy). You will need your snacks, sun lotion and bug repellent.

CHECK PTS: There will be two check points which are listed below. Hikers will receive a colorful backpack tag to show a successful completion of that segment of the course.

9.1 miles Pinney Bridge15.2 miles Jordan River Bridge

COSTS: There will be no cost for our Utah trekkers and Training Partners in good standing. A special \$30.00 fee will be charged for guests.

LODGING: I have secured lodging at the 4 star resort Shanty Creek Resort located about 25 minutes from the start. This was very popular for our TEST HIKE for the last Grand Canyon trip. The rate for our group is \$194.00 per evening. I know it is high but this is close to what we paid last time. They have 31 rooms set aside for our group on this weekend. You may book your room(s) yourself, call Shanty Creek at 231-533-3083 by Monday, March 15, 2021.
