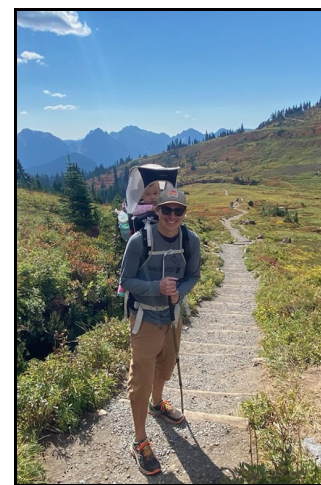

NEXT HIKE: Our next hike is **December 13**. It will be a **Saugatuck** hike starting at **10:00AM**, but the starting location is TBD – It will either be the *Mt. Baldhead* parking lot or the *Butler Hotel* in downtown Saugatuck, depending on the weather. I know many of our hikers will think that I am crazy for picking this location but here is the reason. Saugatuck and nearby Holland (9 miles) are wonderful places to shop in an old fashion outdoor atmosphere complete with music, fire places and wonderful decorations. 2026 HIKING TOUR: I am excited about returning to the great state of Washington as our major tour destination! I am busy finalizing the tour itinerary and gathering bids. Complete trip information should be available very soon. It will be a **12 day hiking tour** September 12-23 and if there's enough interest a second tour will go September 26-October 7. Major destinations being explored are Olympic National Park and Hurricane Ridge, North Cascades National Park, Mt. Rainier National Park, Baker-Snoqualmie National Park, Alpine Lakes Wilderness, Crescent Lake, Olympia, Hama Hama Oyster Saloon, San Juan Islands including Anacortes and Mt. Constitution on Orcas Island, Lake Quinault rain forest, Pacific Crest Trail, and Ron's best of Seattle hike including a terrific REI store.

One of these hikes will require a TEST HIKE to qualify. I am very interested in finding a stunning, challenging hike in the *Olympic Mountains* or on the *Pacific Crest Trail*. I am checking on tour bus access and trail permits. Tentative plans for the TEST HIKE include a hike at our Manistee 21 mile course. NEW TRIP REGISTRATION: Tim and Thom have new registration steps for this trip that they hope will eliminate confusion and too many drops. If you have questions please call Thom at 269.462.0683. The steps are listed below:

1. Everyone on the trip must first register as a Training Partner and pay the annual fee. This fee is separate from your trip deposit. Coach Gunn is available as your personal coach, whether you attend hikes or not.
2. As soon as we can safely estimate the final cost of the trip we will open the trip for registration and accept deposits. This estimated final cost will be adjusted before you pay the balance.
3. Trip deposit will be an amount estimated to cover the expected airfare cost (this likely will go down when we book the group tickets). This is non-refundable and it locks in your spot on a trip. You will have an option to upgrade your class of ticket by paying the higher amount. Doing this in advance eliminates a lot of difficulties and duplicated efforts. We will purchase airline tickets the first week of March.
4. Your balance will be due by July 15th. Everyone's balance due can be determined once we have purchased airline tickets and have secured the rooms at all hotels. This allows you to get the lowest price Coach can find without him taking so much risk.
5. Two trips dates are planned. 40 hikers minimum are required for a trip to stay in the black. If there's enough interest there will be the second trip, if not there will be a wait list.
