increase in effort, but could be patient variation due to conformation. no crackles or

wheezes.

Abdomen moderate cranial abdominal distention and patient grunting on palpation and

possible firmer structure on left cranial aspect

Assessment

r/o food, organomegaly, fluid, FB, gas

CIRDC vs residual pneumonia vs cardiac (though no murmur or other signs noted today) vs other

Plan

Abdominal radiographs most consistent with gastric distention secondary to food, but cannot rule out other underlying changes obscured by the quantity of material in the GI tract. Concern that patient has undergone a longer treatment with additional antibiotics than typically seen and he is still having nasal discharge. Possible contribution of weight gain and a lower dose of doxycycline originally, but dose variation may not be significant.

Unable to take thoracic radiographs at this time. Continue to monitor ins/outs and clinical signs closely - if no improvement by monday recommend thoracic radiographs and reevaluation of treatment plan. Cannot rule out underlying thoracic changes contributing to prolonged CIRDC signs.

Skip patient's pm meal to allow GI tract time to pass material. Start feeding as typical for shelter protocol. if patient continues to have distention recommend repeating radiographs after patient is fasted and or consider smaller, frequent meals.

Plan

Move to isolation. Monitor clinical signs daily until CIRDC has resolved. Begin Doxycycline therapy at 10 mg/kg PO/BID for 10 days.

This dog has been diagnosed with Canine Infectious Respiratory Disease Complex (CIRDC), commonly known as "kennel cough. This infection is similar to the common cold in humans and causes similar signs: coughing, sneezing, runny nose and sometimes runny eyes. For most dogs, the illness is mild and typically runs its course in 10-14 days. An antibiotic has been started to prevent and treat any bacterial infections causing the infection. Your dog will be contagious to other dogs while it is ill. Therefore, we strongly recommend that you keep this dog separated from any other dogs in the home and do not take it to places where they are likely to interact with other dogs such as groomers, dogs parks, and boarding facilities until your veterinarian has told you it is safe to do so. Uncommonly, this infection can progress to more severe illness like pneumonia, and you should take your dog to your veterinarian if they are showing signs of more severe illness such as constant coughing, lethargy, not eating, or difficulty breathing.

Scar tissue noted at distal pelvic limbs and tail. No exudate noted.

Pt has decreased ROM in pelvic limbs and abnormal conformation in all 4 limbs. Muscle wasting in pelvic limbs. Crepitus at stifles and hips. Thickened carpi and elbows. Symmetrical ambulation.

a: chronically fractured femoral heads; abnormal conformation; rock foreign bodies - moving through, intestinal parasites

p: pt will always have abnormal gait issues. Surgical consult could be beneficial but may not be a surgical candidate due to other issues.
