Minutes:

Treasurer's Report:

Programs:

We discussed a TAPP event at the Grove Theater Nov. 6^{th} 5:30 – 7:30. Natalie presented the plan and asked for the club's support in publicizing the event.

We discussed arrangements for the Oct 30th meeting (The Liminal Plan with Chloe Akers) at the Clinton Community Center. We should arrive at 5:00 for setup. Ann Mostoller will check with the community center for a mic and the projector. Ann Mostoller will bring paper products and drinks, Ann Miller will bring rotisserie chickens, Pat will bring deviled eggs and charcuterie, Laura will bring a salad.

Nov 27th business meeting at the Apple Blossom (Clinton). We should verify that we will be ordering from the menu with the restaurant. Holiday party – potluck and news quiz (printed quiz). We brainstormed some ideas for a venue. Ann Miller reported she met with the ORUUC admin – the rental is \$30/hour, we need to provide event insurance, and if the party is a "private" party we can serve alcohol without additional cost or permits. Other ideas were the Museum of the Appalachia \$175/hour with a 3-hour minimum, and the Presbyterian Church social hall. We will work on the party to cover the cost of the venue – the club to provide meat and beverages. Sides/deserts can be potluck.

Fund Raising:

Gloria's fundraiser will be either on 11/3 or 11/10. Her campaign would prefer a reception-type event, rather than a dinner. The club's role is to assist with the fundraiser – we are not hosting or funding the event. The target is @100 people and her campaign
