Legislative Update With Sam McKenzie

May 20th, 2024, 5:30pm at the Clinton Community Center

Rose Weaver told us about the upcoming Juneteenth/Freedom Day celebration happening on June 15th at the Old Scarboro School Site on Hampton Road from noon to 6:00pm.

We also welcomed Glenda Whitfield, the East TN Vice-President for the TFDW, and Edee Webb, the new President of the TFDW. Edee congratulated the ACDWC on our 75th anniversary.

Sam McKenzie, the Tennessee State Representative for District 15 in the Tennessee General Assembly and the Chairman of the Tennessee Black Caucus of State Legislators, spoke to a well-attended ACDWC group about the recent legislative session.

Sam attended Austin-East High School in Knoxville before graduating from Fisk University with a B.S. in Physics. After Fisk University, Rep. McKenzie graduated from the University of Memphis with a M.S. in Physics. Currently, Rep. McKenzie is retired from the Oak Ridge National Laboratory where he was the Environment, Safety, Health, and Quality Group Leader. He is currently a small business owner in Knoxville. He is on the Board of Directors at Tennova Healthcare, ORNL Federal Credit Union, and the Fisk University Board of Trustees. He is also the former District Representative for the Omega Psi Phi Fraternity, and a member of Sigma Pi Phi Fraternity, Beta Theta Boulé. Prior to serving in the Tennessee General Assembly, Rep. McKenzie was on the Knox County Commission from 2008 until 2016.

Rep. McKenzie expressed his appreciation that Anne Backus is running against John Ragan. He related that Rep. Ragan repeatedly presents bills to cure a problem that doesn't exist. An example was the Diversity Equity and Inclusion (DEI) issue that resulted in the total defunding of the DEI program at UT. He also related that Ragan sponsored legislation that would forbid the discussion of any aspect of reparations for past slavery related issues, no one has requested reparations. Sam shared that stopping bad bills was a lot of what the progressive parts of the legislature spend time on, and John Ragan is one reason we're moving backward as a state in many statistics.

Despite the dismal legislative session, Rep. McKenzie was pleased with the watered-down red flag law, also called Jillian's Law, which does provide some limited protections in regard to mentally unbalanced folks who shouldn't have access to guns. Jillian's Law was named for a student shot and killed by a mentally ill person who was released before being adequately diagnosed. He expressed frustration that UT could work out how to solve dormitory shortage with purchased hotels; however, the state cannot do similar creative problem solving to address prison overcrowding.

Sam feels that the treatment of Tennessee State University was extremely harmful. The leadership was entirely removed based on allegations of fiscal irresponsibility. Nothing was said about the severe underfunding of the historically black institutions in Tennessee.
