### The Liminal Plan – With Chloe Akers

Following dinner there will be a talk by Chloe Akers, the founder of The Liminal Plan.

The Liminal Plan was founded in January 2023 from the belief that Tennessee's democracy is broken. 60 out of the 99 members of Tennessee's House of Representatives ran unopposed in our last election. Without any check on their power, politicians no longer act on behalf of the people who elected them. Instead, they make laws based on the demands of extremist special interest groups. Not only do these laws put Tennesseans at risk, they also endanger our economy by limiting business development. Worse yet, the majority does not support this type of extreme legislation.

The gap between what the people want, and what our laws actually say, is widening. The Liminal Plan creates critical space for moderate voters to call for change in a way that meets their perspective.

The Liminal Plan is committed to focusing its efforts on two issues where the will of the voters is NOT reflected in legislation: access to healthcare, especially in our state's rural communities, and greater gun safety.

The Liminal Plan was founded by Chloe Akers, a Tennessee native and former criminal defense attorney who had no idea she'd ever work in politics. As a criminal defense attorney, her journey began by studying the Dodds decision and "Tennessee's Trigger Ban." This study led to an Instagram video, millions of followers, and a realization of the gap between the electorate in Tennessee, with over 80% of Republicans favoring some access to abortion rights, and the total ban passed by the legislature. She realized that law was only the latest symptom of a much larger gap between voters and many Tennessee laws.

After investigating, indications are that Mayor Frank is considering a removal of county funding for our libraries, threatening their very existence.
