

TRAVELER AGREEMENT

This Traveler Agreement ("Agreement") is entered into between **Prowess Travel LLC** ("Prowess Travel," "we," "us," or "our") and the undersigned traveler ("Traveler," "you," or "your") in connection with the travel services, tours, cruises, accommodations, transportation, and related arrangements purchased from Prowess Travel.

By signing this Agreement, you acknowledge and agree to the following terms:

1. Acceptance of Terms & Conditions

I acknowledge that I have received, read, understood, and agreed to be bound by the Prowess Travel Terms & Conditions, including but not limited to policies regarding payments, cancellations, changes, travel documentation, health requirements, luggage, special assistance, itinerary modifications, supplier arrangements, and other applicable travel policies.

I understand that the Terms & Conditions form an integral part of my travel agreement with Prowess Travel.

2. Assumption of Travel Risks

I understand that travel involves certain risks, including but not limited to transportation delays, weather conditions, natural events, political circumstances, illness, accidents, personal injury, property loss, and other circumstances beyond the control of Prowess Travel.

I voluntarily accept these risks and acknowledge that I am responsible for making an informed decision regarding my ability to participate in the selected tour or travel program.

3. Health and Physical Requirements

I confirm that I am physically and medically able to participate in the travel services I have selected.

I understand that escorted tours may involve walking, stairs, uneven terrain, extended travel days, changing climates, and other physical activities. I agree to consult with my healthcare provider regarding any medical concerns before departure.

I further understand that Prowess Travel may require a traveler to seek medical evaluation or discontinue participation when, in the reasonable judgment of Prowess Travel, its representatives, suppliers, or medical professionals, continued participation may endanger the traveler or other participants.

4. Release of Liability

To the fullest extent permitted by applicable law, I release and discharge Prowess Travel, its owners, employees, representatives, agents, affiliates, tour managers, guides, and suppliers from liability for claims, damages, losses, injuries, expenses, or demands arising from my participation in travel services, except where such liability cannot legally be excluded.

This release applies to risks arising from circumstances including, but not limited to, transportation, accommodations, activities, excursions, weather conditions, acts of third parties, and events beyond Prowess Travel's reasonable control.

5. Supplier Services

I understand that certain travel services, including airlines, hotels, cruise lines, transportation providers, restaurants, guides, and optional excursions, may be provided by independent third-party suppliers.

Prowess Travel acts as an organizer and intermediary of travel arrangements and does not control the actions, services, standards, or policies of independent suppliers.

6. Travel Documents and Responsibilities

I acknowledge that I am responsible for obtaining and maintaining all required travel documents, including passports, visas, permits, health documentation, and any other entry requirements.

I understand that failure to obtain proper documentation may result in denied boarding, denied entry, missed services, additional expenses, or cancellation, and that such consequences are my responsibility.

7. Personal Conduct

I agree to conduct myself in a respectful and responsible manner throughout my trip and to follow the instructions of Prowess Travel representatives, tour managers, guides, transportation providers, hotels, cruise operators, and local authorities.

Prowess Travel reserves the right to remove any traveler whose behavior threatens the safety, comfort, or enjoyment of other travelers or interferes with the operation of the tour.

Any costs resulting from such removal shall be the responsibility of the traveler, and no refund will be provided for unused services.



8. Binding Arbitration Agreement

I agree that any dispute, claim, or controversy arising out of or relating to my travel arrangements, this Agreement, or services provided by Prowess Travel shall be resolved through binding arbitration, except where prohibited by applicable law.

The arbitration process shall be conducted in accordance with applicable arbitration rules and procedures. By agreeing to arbitration, I understand that I may be waiving the right to pursue certain claims in court or participate in a class action proceeding, to the extent permitted by law.

9. Emergency Contact Authorization

I authorize Prowess Travel to contact my designated emergency contact person if reasonably necessary due to an emergency, safety concern, or significant disruption affecting my travel.

I confirm that the emergency contact information I provide is accurate and that the designated person has agreed to be contacted.

10. Acknowledgment and Acceptance

By signing below or electronically accepting this Agreement, I confirm that:

- * I have reviewed and accepted the Prowess Travel Terms & Conditions.
- * I understand the risks associated with international and domestic travel.
- * I voluntarily agree to the terms contained in this Agreement.
