Notes from the Adjutant's Desk



Legion office will be open again beginning the 6th of January 2026.

2026 Renewals: We are running ahead of last year as we start the New Year. As of this date, we have 779 paid members. Department Life Members currently are down to 44 members. Current membership breakdown, WWII – 11; ROK – 113; Vietnam – 485; the remainder is made up of current war eras. These are estimates as some members do not have a war era listed.

Membership: We need to talk with our younger members that have served since the Gulf War. They will become the backbone of our VSOs in a few years. Without these younger veterans we will no longer have a strong voice in Congress. Without a strong voice in Congress, we will keep losing funding for the Department of Veterans Affairs and the VA Health Care System.

If you are a member of this group of veterans or know a veteran from these conflicts, please ask them if they are a member of a VSO (veteran service organization) and if not, ask them to please join. They may not be using VA service now, and may wish to in the future, may find that VA services have been cut back due to a lack of a strong voice in Congress.

Legion Insurance: It is easy to sign up, just go to their website and enroll. Legion Insurance covers you while you are traveling to and from a Legion Activity. Remember, if you have not paid your 2025 dues, you are now listed as expired. This means that your insurance lapsed on the 31st of December. Same for Legion Magazine.

Military Service: We still are trying to update our membership roster as to branch of service and the war era that you served. National has been printing on back of renewal slips the data that is in the Legion database. Please check and add as needed so we can correct our database. Thanks, it makes it so much easier to reach out to you if needed.

VSO Web Sites to visit: Nebraska's Department of Veterans Affairs, VFW, DAV, AMVETS web sites are great places to find current and helpful information on what Congress is currently working on and how it could affect you as a veteran. The VA website has many tips on filing claims and links to other VA services to which you are entitled. These agencies do an excellent job of keeping track of Congressional activities that can or will affect veterans.

VA News: (veteransaffairs@messages.va.gov). The Nebraska Department of Veterans Affairs and your local County Service Office are here to serve you. They can pull up your records of military service and help track your claims you may have filed. If you have not visited with your service officer, now would be a great time to stop and visit with him/her. The 2025 Nebraska Legislature may have passed legislation that may have affected you and your benefits.

2026 Auto Renewals: A new law is in effect. As you renew your auto for 2026, you should be able to get a discount on 2026 auto taxes for one car. Check it out.

This will be my last report, as I plan to retire as Adjutant for Post 3. It has been a pleasure to serve you as your Adjutant for the last 8 plus years.

Lincoln CBOC/VA News



Your local Community Clinic and VA Hospital should be back to normal operations on January 5th, 2026.

The Lincoln Clinic is now closing at 5:00 pm. Be sure you double check appointment times, if you have one that shows a time after 5:00 pm.

Flu shots are now being given through walk-ins, or urgent care. When you have an appointment, you will be asked if you wish a flu shot, or to update any other vaccines that show up as overdue on your VA Health records. Covid shots are being given by appointment only. If you wish a Covid shot, call your clinic and request an appointment.

Remember that most community clinics do not have a Finance Office. The Lincoln CBOC does not have a finance office on site. If you have a billing question, you need to call the number that is listed on the Copay notice you might have received. You should find a finance office in most of the VA Hospitals, but they may have limited hours. This is true for the Omaha VA hospital.

Currently there are no mask requirements at VA clinics and hospitals. Masks are available for those who wish to wear them at the front doors of the clinics.

Express Care Walk-in service is for those who wish to have a nurse check out minor items. Times might be different at your local clinic, so give them a call and see if they offer Express Care Walk-in service. This care is available to those who might wish to see a VA nurse without an appointment during normal hours. The Lincoln Clinic treats 300 a month as walk-ins.

With the signing of the PAC act, more veterans have become eligible for services, not only for those who served “boots on the ground”, but anyone who has served since the Gulf War.

If you have any questions, call your local service officer, VSO, county, or state. It only takes a few minutes to see if you might qualify for an increase, or a new VA disability rating. The Veteran Affairs web site is a great place to visit. You can find out the latest information affecting Veterans. You can track claim status, file for travel pay, view your VA account, payments received, or Co-pay owed. You can make the Co-pay payments online.

The Lincoln Clinic does not have an Advocate on site. If you need to talk to an Advocate, you will need to contact their office by phone. The numbers to call are posted on the door of the Advocate Office in the Lincoln Clinic based on your questions.

There are many ways to serve your fellow veterans. The VA systems has the need for volunteers. The local clinics or hospitals can always use volunteers for greeters or escorts. Hours given by the volunteers are credited with saving the VA Health System at Omaha, Lincoln, and GI are the equivalent of 25 full-time staff employees. This is based on an hour of service being credited at the rate of \$31.50 dollars per hour.

Food drive to collect food items for our homeless veterans in the Lincoln area is still ongoing. Items requested are shelf ready, power bars, easy to open items (pull tabs), etc. Please do not bring in food items that are past their expiration date, they just must be thrown away. A can opener would be nice. Other items that our Homeless Veterans could use are hygiene care items. They should be the small size that would fit easily into a backpack.

As the weather has changed from fall to winter, our homeless veterans could use warm clothing, hats, gloves, underwear, etc. Volunteer Services has a list of the most requested items. In Lincoln, they can be reached by calling 402-486-7938 or texting Ty.Andrews@va.Gov

The VA can use more volunteers at your local clinic or hospital. You can volunteer to help veterans in local clinic or hospital, or a veteran home. They can always use a monetary donation, or you can donate activities bags for younger kids to have when they come to the clinic or hospital with a parent for their appointments. There is always a need for the younger kids who come with parents, or grandparents, when too young to be left at home alone.

Clinics and hospitals can always use books or magazines for patients. You would need to check with your local hospital, clinic or veteran's home volunteer office to see what items they need or allow. This would be a great project for your church, school, or youth group.

The only animals that should be brought into a VA Health clinic or hospital are trained service animals that qualify under DAV requirements. Other pets or comfort dogs do not qualify and should be left at home.

Thanks for your service to your fellow Veterans and thanks for your service to this great country.

Regular Meeting of American Legion Post 3

December 9, 2025 - Lincoln Elks Lodge #80

Commander Ron Hindmand opened the December 9, 2025, meeting of American Legion Post 3 at 7:00 PM at the Lincoln Elks Lodge 80 with 24 Legionnaires present.

Introduced were unexpected visitors at tonight's meeting --- Department Commander, Judy Walters, and National Executive Committeeman, Jim Costello.

Also introduced was a recent transfer into Post 3 --- Lynn Anderson. He did a brief self-introduction.

Veterans of the various war eras were asked to stand and be recognized.

The minutes of the November 11, 2025, meeting were read and approved.

In the absence of the Finance Officer, Commander Hindmand gave an abbreviated financial report for November.



Area C Oratorical Contest

The American Legion Area C Oratorical contest was held on 7 December in the Seward Civic Center. For the first time since COVID, four districts in the area had a contestant. Post 3 was represented by our District 15 winner Tera Thoms. We had three members of Post 3 along with two of their wives that were in the audience encouraging these citizens of our United States.

As at the District level, contestants had to prepare and present an eight-to-ten-minute oration on some aspect of the US Constitution with emphasis on a citizen's duties and obligations. Then they prepared and presented a three-to-five-minute oration on an assigned topic drawn from preselected four topics related to some aspect of the US Constitution. T.J. Mueller from District 12 was the 1st place winner. Frank Kovaks from District 10 placed 2nd, and Reed Novotny from District 11 placed 3rd. Our District 15 winner, Tera Thoms, finished 4th. Additionally, Tera was given \$100 by Post 3 for her participation in the Area Contest and another \$100 from the Nebraska American Legion Department. Tera will also receive a \$400 scholarship from Post 3 after high school graduation and upon registration in advanced education.

Tera is a high school junior being homeschooled. Her prepared oration was "Ratification of the 27th Amendment". She plans to attend the University of Nebraska and major in biochemistry upon high school graduation with aspirations of becoming a medical doctor.

The Department Contest will be held on 17 January as part of the Mid-Year Convention. We are sending out the agenda for this year's Mid-Year in Norfolk with this month's Newsletter. It would be a great opportunity to hear four young people representing the four Areas in the Department if you can attend. It is great to hear these future leaders speak on the United States Constitution giving us great hope for the future.

Wreaths Across America



The tradition of laying wreaths on veterans' graves began in 1992, when the Morrill Worcester Wreath Company from Harrington, Maine, donated 5,000 wreaths to be placed on the headstones of an older section of Arlington National Cemetery. This act of generosity sparked a movement that has grown significantly over the years.

Each December, on National Wreaths Across America Day, the graves of deceased soldiers are decorated with fresh evergreen wreaths, each adorned with a traditional red hand tied bow. These wreaths are respectfully placed on headstones as a gesture of remembrance and honor.

Today, this tradition is observed at over 5,200 locations across all 50 states, 24 countries, and 7 seas. Lincoln has participated as a location for Wreaths Across America since 2010. As part of the program, Wreaths Across America sends a large ceremonial wreath to each state capitol, symbolizing the collective remembrance and gratitude for veterans.

The Nebraska Capitol Wreath ceremony took place on Monday, December 8, 2025, in the State Capitol Rotunda. Members of the Post 3 Honor Guard posted the Colors, and the Lincoln Lutheran High School Choir performed the National Anthem along with several other songs. The Pledge of Allegiance was recited, and Governor Jim Pillen read his Proclamation of Wreaths Across America.

Greg Osborn, Chairman of the Wreaths Across America Planning Committee, presented the Capitol Wreath to Governor Pillen. This wreath remained on display at the Capitol until the beginning of the new year.

The actual wreath-laying ceremony was held at Wyuka Cemetery on a cold December 13, 2025. The public was invited to attend a short program. The VFW Honor Guard posted the Colors, the National Anthem was sung, and the Pledge of Allegiance was recited. Chief Master Sergeant (retired), Teri Clark, of the Nebraska Air National Guard, served as the keynote speaker. Wreaths were presented in honor of veterans from the six military service branches and the Merchant Marines.

Following the opening ceremony, volunteers placed over 2,000 wreaths on veterans' graves in the three soldiers' circles of the Nebraska State cemetery. The event was made possible thanks to the dedicated individuals who contributed their time and effort to pay tribute to our veterans.

U.S. Army Cpl. Thomas William Neiswinger Identified



On Sept. 25, 2025, the Defense POW/MIA Accounting Agency identified the remains of U.S. Army Cpl. Thomas William Neiswinger, missing from the Korean War.

Neiswinger entered the U.S. Army from Indiana and served with F Company, 2nd Battalion, 38th Infantry Regiment, 2nd Infantry Division. On Sept. 6 and 7, 1950, elements of Neiswinger's 2nd Battalion launched attacks on a prominence called Hill 209 along the Naktong River in South Korea.

After failing to secure the hill due to strong enemy resistance and in torrential rain, the U.S. troops pulled back, but not without suffering casualties. Neiswinger was among those reported missing in action on Sept. 6, 1950. Renewed efforts later brought the area under American control, but by that time, the heavy rains had been continuing for days, and the floodwaters from the Naktong River were sufficient to cover up any recent graves in the area, impeding efforts to recover the remains of fallen soldiers.

In Sept. 1951, during post-war search and recovery efforts, members from the 565th Quartermaster Graves Registration Company recovered three sets of remains from a group burial near the village of An-Dong, South Korea. One of the sets of remains could not be associated with any unresolved casualty from the Korean War and was declared unidentifiable, and in 1956 was interred as a Korean War Unknown in the National Memorial Cemetery of the Pacific in Hawaii.

In May 2021, as part of Phase 3 of the Korean War disinterment project, DPAA personnel accessioned this Unknown to the DPAA laboratory for analysis. There, based on the laboratory analysis and total circumstantial evidence, the remains were identified as those of Neiswinger.

Today, he is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific. His name is also inscribed on the Korean War Veterans Memorial Wall in Washington, DC, which was updated in 2022 to include the names of the fallen.

Army Corporal awarded the Medal of Honor



Corporal Joe R. Baldonado distinguished himself by acts of gallantry and intrepidity above and beyond the call of duty while serving as an acting machine gunner in 3d Squad, 2d Platoon, Company B, 187th Airborne Infantry Regiment during combat operations against an armed enemy in Kangdong, Korea on November 25, 1950.

On that morning, the enemy launched a strong attack in an effort to seize the hill occupied by Corporal Baldonado and his company. The platoon had expended most of its ammunition in repelling the enemy attack and the platoon leader decided to commit his 3d Squad, with its supply of ammunition, in the defensive action.

Since there was no time to dig in because of the proximity of the enemy, who had advanced to within twenty-five yards of the platoon position, Corporal Baldonado emplaced his weapon in an exposed position and delivered a withering stream of fire on the advancing enemy, causing them to fall back in disorder.

The enemy then concentrated all their fire on Corporal Baldonado's gun and attempted to knock it out by rushing the position in small groups and hurling hand grenades. Several times, grenades exploded extremely close to Corporal Baldonado but failed to interrupt his continuous firing.

The hostile troops made repeated attempts to storm his position and were driven back each time with appalling casualties. The enemy finally withdrew after making a final assault on Corporal Baldonado's position during which a grenade landed near his gun, killing him instantly.

Baldonado's extraordinary heroism and selflessness at the cost of his own life, above and beyond the call of duty, are in keeping with the highest traditions of military service and reflect great credit upon himself, his unit and the United States Army.

Corporal Baldonado's remains were never recovered, but on March 18, 2014, President Barack Obama presented the Medal of Honor to Corporal Baldonado's brother, Charles.






