


American Legion Riders Lincoln Chapter 3

Old Business:

- Director Discussed plans to finalize our efforts at the ABATE bike show that starts on the 16th. Talked about wrist bands that cost \$15 each, please pay Ray Paulson if you get one. Motion to pay \$14 for renting one table and two chairs at the ABATE show by Streeter, second by Bruce Gubser, motion approved. Please show up when you are scheduled to help,
- Treasurer Lori Gubser advised the procedure to be used to account for the sale of raffle tickets at the Bike Show. We only bought 1000 raffle tickets, discussed getting additional tickets and membership wished to limit tickets sold to 1,000 at this time. When 1,000 are sold, we will stop our raffle efforts this year.

New Business:

- Bruce Gubser Discussed the hand drawn art picture that was donated by Ray Paulson, looking for ideas to use this for the benefit of the Chapter, tabled discussion.
- Director Discussed selling raffle tickets at the Hickman Legion Fish Fry, to be held on February
 23rd, March 8th and March 22nd. We will sell tickets at the Feb 23rd fish fry to see how it goes.
- Director discussed a dinner ride in March. Ride Captain will make arrangements and send out a ride order.
- Secretary Discussed attendance at the Department of Nebraska 2024 Legacy Run on July 12th, 13th, and 14th. 900 + or miles run across Nebraska. Proceeds to benefit the American Legion Veterans and Children Foundation (VCF). Starts in Lincoln at Department HQ on the 12th, goes to Ogallala for first night's stop, then through Scottsbluff, Chadron and to Valentine for second night's stop, then return to Lincoln on third day. Asking for a minimum of \$50 donation for each rider. Motion by Streeter, second by Bruce Gubser, to donate \$500 to the VCF. The check to be delivered by Streeter to John Arias, the State Liaison for ALR for the Department on July 12th at start of run.
