#### **Commander's Call**



Membership! Membership! Membership!

As Commander of Post 3, I feel my most important responsibility is membership. Maintaining our membership, growing our membership, and taking care of our membership. Serving as your Post 3 Commander is an honor and privilege. With that honor and privilege also comes a tremendous amount of responsibility to you,

the membership of Post 3, and the Department of Nebraska. We remain Nebraska's largest Post and I thank you for your continued membership and support that allows us to claim that spot.

The membership goal for 2024 is 1107 members as set by The American Legion Department of Nebraska. As of this writing, there are 1045 veterans (paid up at least through 2024) who make up this Post. If you are among those 1045, I thank you for your support of Post 3 and The American Legion. There are 47 members who paid their dues in 2023 but have not yet renewed for 2024. What can I do to help? Is there a financial hardship? We might be able to help with that. We typically have around 20 to 30 members attend our monthly meeting. If you live in the Lincoln area, I ask that you seriously consider getting involved with the Post and its activities. Your membership is not only supporting our local Post but The American Legion nationwide. The American Legion has a strong voice in Congress which ultimately helps all our veterans.

Do you know a veteran who is not a member of The American Legion? Have you asked them to consider joining us? I ask you to make it a goal to bring one new member into The American Legion by the end of the year.

We all have time, treasures, and talents we can give to this organization. If you have recently retired and are looking for something to do, look no farther. You have found it. Do you have family or work responsibilities that prevent you from attending our regular meeting? Hey, we get that! I have been there and done that. Do you have an hour a month to deliver birthday cards to veterans living in a senior community or assisted living facility? I have something right up your alley. There are many other opportunities to share your talents and time. You will be able to help the community and the Post while staying active. Please consider staying a part of our Legion family.

The American Legion is only as strong as its membership. We must continue to lead the way to ensure that our veterans, our military service members, and our community are assisted in whatever way we can.

The Post 3 family includes the Legionnaires, the Auxiliary, the Sons of the Legion, and the American Legion Riders. Members come from many locations, backgrounds, and occupations. Together, these members work to organize a multitude of local veteran and community events. As I have stated in previous newsletters, historically, our membership is reduced by 8%-10% annually due to death and non-renewals. While much of this reduction is due to members joining Post Everlasting, we can't do much about that.

What you can do is get involved with our Post goal. This won't require much of your time and won't cost you any money. All you must do is ask your neighbors, friends, and family members to join the Post 3 family if they are not already a member. If just about 10% of you would recruit, reinstate, or renew a member, we would make our goal. Again, I ask you to make a personal goal of bringing in one new member this year.

In 1919, The American Legion was founded on the four pillars: Veterans Affairs and Rehabilitation, National Security, Americanism, and Children and Youth. These programs and the men and women who make them work, make a difference in the lives of our fellow Nebraskans each year. Our founders made this our mission and it's what we do as Legionnaires. Please get involved with the Post and remember that we are making a difference in the lives of our veterans and their families by being members of this great organization.

As always, keep our veterans in your thoughts and prayers, particularly those who may be in need. Keep our active-duty service men and women in your thoughts and prayers, wherever they may be dispersed.

#### **Notes from the Adjutant's Desk**



Welcome to spring.

For those who served in Vietnam, 29 March was a special day, Vietnam Memorial Day. That marks the day that the last US Troops left Vietnam on the 29<sup>th</sup> of March 1973. Many of us did not get a welcome homecoming. Vietnam Veterans are living in the so-called

Golden Years, still haunted by their service there. We need to call upon Congress to remember that we answered the call, when Uncle Sam called us to duty in a country that most of us had never heard of. Now we only ask Congress to live up to their end and fully fund the Department of Veterans Affairs.

As far as Post 3 2024 renewals are concerned, we currently stand at 1049 paid members – 95% of our goal of 1107.

Again, thanks to those who have let us know they had not received their 2024 membership cards. We have only had a few this year. If by chance you have not received your 2024 membership card and have sent a payment, please let us know. Mail does get lost or damaged, going both ways. We try to get cards out within a day or two of receipt of payment.

The American Legion National leadership has raised National dues \$5.00 a year beginning July first, 2024. Department of Nebraska most likely will raise their dues at their 2024 Department Convention this summer. At this time, Post 3 will not be raising its dues for 2025, remaining at \$11.00 dollars. The Post 3 dues beginning July 1st will be \$56.00 dollars. (National - \$23.50, Department - \$ 21.50, Post 3 - \$11.00)

Want to save 20 or 30 Dollars? As of this date, we have 14 members who have taken the opportunity to extend their membership for two or three extra years, saving themselves \$20 or \$30.

To take advantage of this opportunity, you need to log onto MYLEGION.ORG. When there, click on renew, and it should bring up current renewal status, paid for 2024, etc. It then should allow you the opportunity to renew for an additional two or three years. If you have questions, give us a call.

Again, thanks to those who have provided the request for phone numbers and email information. We have many members who do not have a phone number or an email address on file. Same goes for branch of service, or war era. National has been printing on the back of the renewal slips, the data that is in the Legion data base. Please check and add as needed so we can correct our database. Thanks, makes it so much easier to reach out to you if needed.

Memorial Services: The Honor Guard is again busy with memorial services and flag details. Thanks to all who have taken the time to help our fallen brothers and sisters. We get many requests, some with short notice. With a great bunch of guys and gals, we can support 95% of these requests.

As our Veterans enter their golden years, this would be the time to review their memorial plans with their family. Locate your DD214 or other discharge papers. You have earned the right to burial in a VA cemetery or request a VA headstone for a private cemetery. You can do all this now by going to the VA web site and filling out the forms. If you need assistance, see your local county Veteran service officer, the Nebraska Department of Veterans Affairs or give me a call.

Again, Thanks for your Service and Thanks for being a member of Post 3. Remember to also thank your fellow Veterans for their service.

#### **Lincoln CBOC/VA News**

The Clinic is just about back to normal after the water pipe break. It is still advisable that you sign in through the MSAs to learn where your appointment will be held.

Flu shots and Covid shots are currently being given by appointment only. You need to call your local clinic to schedule an appointment. VA clinics and hospitals no

longer require the wearing of masks to enter clinics. Masks are available for those who still wish to wear them.

Express Care is a walk-in service for those who wish to have a nurse check out minor items. Express Care hours run from 3 pm to 7 pm at the Lincoln clinic. This care is available to those who might wish to see a VA nurse without an appointment during normal hours.

Want to serve your fellow Veterans? The VA can use more volunteers to help at your local clinic or hospital. Or you can donate to your local clinic, hospital, or veteran's home. They can always use a monetary donation, or you can donate activities bags for younger kids to have when they come to the clinic/hospital with a parent for their appointments. There is always a need as some younger kids come with parents, grandparents, etc., and are too young to be left at home alone.

Clinics and hospitals can always use books, magazines, etc. for patients. You would need to check with your local hospital, clinic or veteran's home volunteer office to see what items they need or allow. This would be a great project for your church, school, or youth group.

The Nebraska Department of Veterans Affairs will be holding claims clinics this spring. They will be hosting one Fremont this month. I would view their website to check on the dates and locations.

Many Veterans Service Organizations (VSO) hold claim clinics throughout the state during the year. You just need to call their state HQs to find a date and location that works for you. It's never too late to file a new claim or appeal a claim or claim rating.



#### Regular Meeting of American Legion Post 3 Lincoln Elks Lodge #80 March 12, 2024

Commander Bruce Gubser opened the March 12, 2024 meeting of American Legion Post 3 at 7:00 PM at the Lincoln Elks Lodge 80 with 26 Legionnaires present.

New Post 3 member and first-time attendee Ranier Aumer was introduced.

Veterans of the various war eras were asked to stand and be recognized.

Steve Bartos reported that he had submitted the applications for only 10 Lincoln area boys to attend Boys State this year ---- down considerably from what used to be 15-20. He did say, however, that there might be one or two more boys from Pius X High School who have an interest.

Ed Schnabel gave an abbreviated financial report, and it was approved and filed for review.

Membership was reported as 1044 --- a little over 94% of goal.

NEC-man Fred Craigie indicated that the national commander had visited Nebraska this past weekend, and Fred passed out commander's pins to all.

William Jackson gave an Americanism report.

Gerry Wolf reported for the Honor Guard. He indicated that they remain busy --- but perhaps a little less busy just recently. He indicated that they would assist the Auxiliary at their upcoming event at Calvary Cemetery.

It was announced that Voiture 103 of the 40/8 would meet next Tuesday.

Commander Gubser reported for the Legion Riders. He said that they were having amazing success with their Rifle Raffle and that there were exceptional ticket sales at the recent ABATE show.

Commander Gubser also indicated that the Birthday Card Program in the senior living facilities continues.

Upon inquiry, there was some additional discussion about the meaning of the CPR acronym for the Consolidated Post Report and the kinds of things that can be reported on it.

The Chaplain read TAPS, and the meeting was closed in proper form at 7:40 PM.

#### A Message From National Commander, Daniel J. Seehafer



Dear American Legion Family members and friends,

If the trend continues, the 2024 membership year can be a special one for The American Legion. Departments and posts have recruited and renewed about 15,000 more members than we had at this time last year. While our direct mail efforts have been less successful, this only demonstrates the proven success of personal contact, even if it's by phone.

A larger American Legion benefits all Americans. This means more Legionnaires to engage in Buddy Checks, as we commit to "Be the One" to stop veteran suicide. It means more Legionnaires to operate great programs such as Boys State, Junior Shooting Sports, oratorical contests and American Legion Baseball.

Trends can be deceiving, however. In the past, we have started the membership year strong only to lose momentum in the final stretch. "Wait till next year," has been the battle cry for many losing teams. I reject that mentality. There is no time like the present and our membership year runs through June 30.

"Rocky" fans of a certain age are familiar with the song "Eye of the Tiger." The chorus is meant to channel the passion and commitment it takes to win. Generations ago, it took Eye-of-the-Tiger dedication to make The American Legion the largest and greatest veterans organization in the country. We still are.

My predecessor set a goal to recruit 75,000 new members during the 2023 membership year. We surpassed that. The goal for 2024 is 78,000 new members and it is perfectly achievable.

Any Legionnaire who recruits two new members to our organization will receive a "Be the One" dog tag coin from me.

If you are not a current member, you can join simply by clicking here. You can renew just as easily here. If you want to beat inflationary dues increases, consider a Paid Up for Life membership. You could also join more than 10,000 other Legionnaires and try our new three year membership option.

As I said earlier, personal contact matters. Legionnaires who are welcomed by active and engaged posts in their communities are more likely to stay Legion. One of the highlights of my time in The American Legion was when my post, 157 in Horicon, Wis., was recognized for "100 percent" and "All Time High" membership awards during years that I served as its commander and adjutant. It was never about "me." It was always about "we."

As The American Legion observes its 105th birthday, I can think of no better manner of celebrating than to put our organization on the path for growth. With your help, I know that we can do just that.

#### **Soldier Accounted for from Korean War**





On March 22, 2024, the Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Pvt. 1st Class Jimmy D. Smith, 21, of Muskogee, Oklahoma, killed during the Korean War, was accounted for Sept. 11, 2023.

In July 1950, Smith was a member of Medical Company, 7th Cavalry Regiment, 1st Cavalry Division, Eighth U.S. Army. He was killed in action after his unit engaged in defensive actions near Changchongni, Republic of Korea (South Korea), on July 30. Due to intense fighting, his body could not be recovered at that time, and there was never any evidence that he was a prisoner of war. With no further information the Army declared Smith killed in action on July 30, 1950.

In early 1951, the Army began recovering remains from the area and temporarily interred them at the United Nations Military Cemetery (UNMC) Pusan. One set of remains recovered during this period was designated Unknown X-340 Tanggok (X-340), recovered in the vicinity of Nae-dong, South Korea, near where Smith went missing. A tentative association was made between X-340 and Smith, but definitive proof could not be found, and X-340 was determined to be unidentifiable. The remains were sent to Hawaii where they were buried at the National Memorial Cemetery of the Pacific, known as the Punchbowl, in Honolulu.

In July 2018, the DPAA proposed a plan to disinter 652 Korean War Unknowns from the Punchbowl. DPAA disinterred Unknown X-340 as part of Phase Two of the Korean War Disinterment Project and sent the remains to the DPAA laboratory for analysis.

To identify Smith's remains, scientists from DPAA used dental and anthropological analysis, as well as circumstantial evidence. Additionally, scientists from the <u>Armed Forces Medical Examiner</u>

<u>System</u> used mitochondrial DNA (mtDNA) analysis.

Smith's name is recorded on the Courts of the Missing at the Punchbowl, along with the others who are still missing from the Korean War. A rosette will be placed next to his name to indicate he has been accounted for.

Pfc. Smith will be buried in Kingsburg, California, on a date to be determined.

#### Medal of Honor Recipient, Victor Vifquain





Jean-Baptiste Victor Vifquain (20 May 1836 – 7 January 1904) was a Belgian-born veteran of the American Civil War and the Spanish–American War. He was awarded the Medal of Honor for capturing a Confederate flag during the Battle of Fort Blakely.

Vifquain was born as Jean-Baptiste Victor Devuyst in Saint-Josse-ten-Noode, Belgium on 20 May 1836. His father, Jean-Baptiste Joseph Vifquain, was an engineer and served under Napoleon during the Napoleonic Wars. Vifquain received military training at the Royal Military Academy in Brussels, and served in the Belgian Army for a year. In 1857, he moved to the United States and settled in Saline County, Nebraska.

Upon the outbreak of the Civil War in 1861, Vifquain joined the Fifty-third New York Infantry so he would not have to wait for a Nebraska unit to be created. The infantry unit was disbanded before it could become involved in the fighting. Following the disbandment, Vifquain and three colleagues snuck into Richmond in an unsuccessful attempt to kidnap Confederate President Jefferson Davis. In 1862, the governor of Illinois appointed Vifquain to be the Ninety-seventh Illinois's adjutant.

Vifquain commanded the Ninety-Seventh Illinois during the Battle of Fort Blakely. On April 9, he advanced towards and jumped onto the parapet of the Confederate fort. Surviving a barrage of Confederate gun fire without serious injury, Vifquain ordered a general charge of the fort by his unit. During the ensuing fighting, Vifquain used his sword to sever the halliard holding up the fort's Confederate flag while the flag-bearer of the Ninety-Seventh Illinois planted the Union flag in its place. The flag-bearer was killed by Confederate gun fire immediately after placing the flag. Vifquain was concealed by the falling Confederate flag during the attack, so he was not targeted. Vifquain survived the battle and was awarded the Medal of Honor for his actions.

Near the end of the Civil War, Vifquain yet again attempted to capture Davis. He successfully captured a train believed to be carrying Davis near Selma, Alabama. Davis was not actually a passenger, but Vifquain was able to secure three-thousand heads of cattle and two-thousand horses from the train. Vifquain ultimately achieved a rank of brevet brigadier general by the time he was mustered out of service in October 1865.

After the end of the Civil War, Vifquain ran for a seat in Congress, but did not win the election. He also attended the Nebraska Constitutional Convention. Vifquain founded the Daily State Democrat in 1879 and was appointed US consul to Columbia by President Grover Cleveland in 1886. He would later serve as the leader of multiple diplomatic posts in Panama.

In 1891, he was selected to be the adjutant general of his home state of Nebraska. Vifquain returned to active military service during the Spanish–American War. He served as commander of the 3rd Nebraska Infantry Regiment following the resignation of Colonel William Jennings Bryan. His regiment remained in Cuba at the end of the war to aid in the occupation of the island. Vifquain died in 1904 at his house in Lincoln, Nebraska. Vifquain is buried in Calvary cemetery in Lincoln, Nebraska.

#### **Honoring Victor Vifquain, Civil War Medal Of Honor Recipient**

Past Department President (2022-2023) of the Nebraska American Legion Auxiliary, Vicki Ozenbaugh, chose the project of having a wreath placed at each of the Medal of Honor recipients buried in Nebraska.

To complete Vicki's project, she is conducting a special service at each of the Medal of Honor recipient's grave site to lay the wreath made in honor of the individual. A short history of the Medal of Honor is shared as well as the history of the individual and when their Medal was presented. The local Post and Unit are involved with the service, which concludes with the military gun salute and taps.

Further statistics shows there were fifteen recipients from the Civil War, eight from the Indian Wars, two from the War with Spain, four from World War II, one from the Korean Conflict, and three from Vietnam. This represented twenty-six serving in the Army, two in the Navy, and five in the Marine Corps.

On March 22<sup>nd</sup>, members of the Lincoln American Legion Auxiliary, Unit 3, and members of the Post 3 Honor Guard assisted Vicki in laying a wreath and conducting a ceremony for Victor Vifquain, a Civil War Medal of Honor recipient buried at Calvary cemetery, Lincoln.
