## **Notes from the Adjutant's Desk**



While Winter is mostly behind us, March can still bring some nasty weather. If Lincoln receives an ice or snow storm, the Post 3 office will be closed. If you need my services, please text me, as I can do all services from the safety of my home. Stay home, stay safe, and text me. Thanks!.

Renewals, A BIG THANK YOU to those of you who have

renewed for 2023 your membership in Post 3 and THE American Legion. The third mailing of dues notices for 2022-2023 was sent out by the American Legion National Headquarters during the second week of November --- and a more recent notice went out in early February.

Current membership near the end of February stands at 1049 members. If you happen to be one of the few whose dues were received after the most recent cut-off date, you might receive a dues notice. If you know that you have paid your 2023 dues, just throw the notice away.

If you have not paid your 2023 dues, please pay them. We need you and want you as a member.

Post 3 membership currently stands at a little more than 85% of our assigned goal for 2023. We are down to under two hundred renewals to make 100%. To make 100% will require the 150 +/- members who have not yet renewed for 2023 to pay their 2023 dues. Then, we need to replace the 55 members who have died this past year. If only one in five members would bring in a new or transferred member, we could be recognized as a 100% Post for 2023. Time to hit the street and find those who earned the right to be a Legionnaire.

For those of you who have not paid your 2023 dues, please take the time to review the reverse side on the notice. These notices have been changed, and they have now added the basic information that the American Legion has on file for you --- branch of service, war era, phone number, and email address. If some of your information is not correct, please correct the information and mail the form with your 2023 dues payment to 123 South 84<sup>th</sup> Street, Suite L, Lincoln, NE, 68510, and I will see that it gets corrected. Thanks for your help.

Does your 2023 membership show your correct years of service?

The 2023 card that we are mailing out should be correct. If the years are not correct, please let us know and we can get it corrected for you. We have fielded many calls about the total years of membership not being correct. It takes a lot of work to double-check what is printed on the 2023 cards, so if your is not correct, please email or text me, and I can correct the years for you.

You can double-check your card from 2022 to see if the 2023 card has added one year for you. If not, let me know; and I will mail out a new card with the correct years and have National update your membership record. (edschnabelasa@gmail.com 402-480-8542)

#### Two Kinds of Buddy Checks.

The Veterans Administration (VA) has a Buddy Check program, and the American Legion has a Buddy Check program. The difference between the two is that one is a social event, and the other is a veteran contact of some kind --- phone call, email, card, etc.

The VA started theirs to bring notice to the number of veterans committing suicide each day. In Lincoln, it is held at a local establishment on the 22<sup>nd</sup> day of each month as that was the daily average of veteran suicides when the program was started. Veterans can gather for light refreshments, conversation, and support.

The American Legion Buddy Check is a program where the local posts try to make personal contact with members that they have not seen for a while. It can be a one-day event or scheduled at some other interval by the members of the post.

As most of you know, we had a frozen water pipe in our office building during the Christmas season and had to vacate the office for about a month while the landlord completed repairs to the "flood damage." We took advantage of the misfortune to do a little updating and rearranging --- and are now putting the finishing touches on the office.

We hope to hold an open house for our refurbished Post 3 Office from 10:00 AM to noon on March 16<sup>th</sup>. Drop by and see where the work gets done to keep Post 3 functioning.

Again, Thanks for your Service and Thanks for being a member of American Legion Post 3 --- and remember to thank your fellow veterans for their service.

## Lincoln CBOC/VA News



A note to my fellow Vietnam veterans who happen to serve in theater, but outside of South Vietnam or served in the Middle East Gulf Wars.

On August 10, 2022, President Biden signed the <u>PACT Act</u> into law, extending VA health to

eligibility to many veterans and expanding benefits to eligible veterans. The PACT Act expanded benefits for exposures to toxic substances. This PACT Act now PRESUMES that exposure to toxics substances caused many health problems to those who served in these theaters. If you have filed a claim for Agent Orange, or other toxic agents and it was denied, you need to file a claim update and get a new review.

For me, my service in Thailand is now covered for toxic exposures and allows me to file new claims for many of my health problems, without needing to prove my service caused them.

This is a major change; the VA now PRESUMES that service is a direct cause for many health problems.

The PACT Act adds to the list of health conditions that we assume (or "presume") are caused by exposure to these substances. This law helps us provide generations of Veterans—and their <u>survivors</u>—with the care and benefits they've earned and deserve.


You can file a claim for PACT Act-related disability compensation or apply for VA health care now. Call <u>800-698-2411</u>

Visit the VA web site and read the list of medical problems that are now presumed to have a link to service in these theaters. If you have any, contact your Service Office to file a new or updated claim.

Masks are still mandated at the VA Hospitals and Clinics. They are providing them as you enter the buildings.

## **KOREAN WAR - UNITED STATES NAVY**

### **Unaccounted For – Ensign Jesse Leroy Brown**





Ensign Jesse Leroy Brown, who entered the U.S. Navy from Mississippi, was the first African-American aviator with the U.S. Navy and a member of Fighter Squadron 32, embarked aboard the USS Leyte (CV-32).

On December 4, 1950, he piloted a single-seat F4U-4 Corsair that took off from the Leyte as a section leader in a flight supporting the withdrawal of Marines near the Chosin Reservoir, North Korea. Arriving in the target area, Ensign Brown made a bombing run on a target and after making his pass and while still at a low altitude, his aircraft was hit by enemy ground fire and began to trail smoke.

He managed a crash-landing. However, he was mortally wounded during the landing. Rescuers arrived at the crash site but were unable to remove Ensign Brown from the aircraft. He died while still inside the cockpit during the attempt to extricate him. Because the Leyte was relocating and needed to depart, rescuers were ordered to return to the ship and could make no further attempts to recover Ensign Brown's remains.

Prior to the ship's departure, pilots were directed to drop munitions on the downed aircraft to destroy the wreckage and Ensign Brown's remains. However, this only damaged the aircraft, and did not completely destroy it.

Today, Ensign Brown's body has never been recovered but he is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific.

Based on all information available, DPAA assessed the individual's case to be in the analytical category of Deferred.

"Devotion" is a 2022 American <u>biographical war</u> film based on the 2015 book "Devotion: An Epic Story of Heroism, Friendship, and Sacrifice" by <u>Adam Makos</u>, which retells the comradeship between Naval officers <u>Jesse Brown</u> and <u>Tom Hudner</u> during the <u>Korean</u> <u>War</u>.

#### **NEBRASKAN AWARDED THE MEDAL OF HONOR FOR VIETNAM SERVICE**





For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as a rifleman with Company M in action against enemy forces. While serving as point man for the 2d Platoon, Pfc. Coker was leading his patrol when he encountered five enemy soldiers on a narrow jungle trail. Pfc. Coker's squad aggressively pursued them to a cave.

As the squad neared the cave, it came under intense hostile fire, seriously wounding one Marine and forcing the others to take cover. Observing the wounded man lying exposed to continuous enemy fire, Pfc. Coker disregarded his safety and moved across the fire-swept terrain toward his companion. Although wounded by enemy small-arms fire, he continued to crawl across the hazardous area and skillfully threw a hand grenade into the enemy positions, suppressing the hostile fire sufficiently to enable him to reach the wounded man. As he began to drag his injured comrade toward safety, a grenade landed on the wounded Marine.

Unhesitatingly, Pfc. Coker grasped it with both hands and turned away from his wounded companion, but before he could dispose of the grenade, it exploded. Severely wounded, but undaunted, he refused to abandon his comrade. As he moved toward friendly lines, two more enemy grenades exploded near him, inflicting still further injuries. Concerned only for the safety of his comrade, Pfc. Coker, with supreme effort, continued to crawl and pull the wounded marine with him. His heroic deeds inspired his fellow marines to such aggressive action that the enemy fire was suppressed sufficiently to enable others to reach him and carry him to a relatively safe area where he succumbed to his extensive wounds.

Pfc. Coker's indomitable courage, inspiring initiative, and selfless devotion to duty upheld the highest traditions of the Marine Corps and of the U.S. Naval Service. He gallantly gave his life for his country.

Interesting Veterans Statistics off the Vietnam Memorial Wall

There are 58,267 names now listed on that polished black wall, including those added in 2010.

The names are arranged in the order in which they were taken from us by date and within each date the names are alphabetized. It is hard to believe it is 36 years since the last casualties.

The first known casualty was Richard B. Fitzgibbon, of North Weymouth, Mass. Listed by the U.S. Department of Defense as having been killed on June 8, 1956. His name is listed on the Wall with that of his son, Marine Corps Lance Cpl. Richard B. Fitzgibbon III, who was killed on Sept. 7, 1965.

There are three sets of fathers and sons on the Wall.

39,996 on the Wall were just 22 or younger.

8,283 were just 19 years old. The largest age group, 33,103 were 18 years old. 12 soldiers on the Wall were 17 years old

5 soldiers on the Wall were 16 years old.

One soldier, PFC Dan Bullock was 15 years old.

997 soldiers were killed on their first day in Vietnam ..

1,448 soldiers were killed on their last day in Vietnam ..

31 sets of brothers are on the Wall.

Thirty one sets of parents lost two of their sons.

54 soldiers attended Thomas Edison High School in Philadelphia. I wonder why so many from one school.

8 Women are on the Wall. Nursing the wounded.

244 soldiers were awarded the Medal of Honor during the Vietnam War; 153 of them are on the Wall.

Beallsville, Ohio with a population of 475 lost 6 of her sons.

West Virginia had the highest casualty rate per capita in the nation. There are 711 West Virginians on the Wall.

The Marines of Morenci - They led some of the scrappiest high school football and basketball teams that the little Arizona copper town of Morenci (pop. 5,058) had ever known and cheered. They enjoyed roaring beer busts. In quieter moments, they rode horses along the Coronado Trail, stalked deer in the Apache National Forest. And in the patriotic camaraderie typical of Morenci's mining families, the nine graduates of Morenci High enlisted as a group in the Marine Corps. Their service began on Independence Day, 1966. Only 3 returned home.

The Buddies of Midvale - LeRoy Tafoya, Jimmy Martinez, Tom Gonzales were all boyhood friends and lived on three consecutive streets in Midvale, Utah on Fifth, Sixth and Seventh avenues. They lived only a few yards apart. They played ball at the adjacent sandlot ball field. And they all went to Vietnam. In a span of 16 dark days in late 1967, all three would be killed. LeRoy was killed on Wednesday, Nov. 22, the fourth anniversary of John F Kennedy's assassination. Jimmy died less than 24 hours later on Thanksgiving Day. Tom was shot dead assaulting the enemy on Dec. 7, Pearl Harbor Remembrance Day.

The most casualty deaths for a single day was on January 31, 1968 ~ 245 deaths.

The most casualty deaths for a single month was May 1968 - 2,415 casualties were incurred.

For most Americans who read this they will only see the numbers that the Vietnam War created. To those of us who survived the war, and to the families of those who did not, we see the faces, we feel the pain that these numbers created. We are, until we too pass away, haunted with these numbers, because they were our friends, fathers, husbands, wives, sons and daughters. There are no noble wars, just noble warriors.

## **Oldest Recruit In The History Of Parris Island**



The average age of a United States Marine Corps recruit is 21 years old. When Paul Douglas enlisted in 1942, he left behind his wife, child, and career and reported to Marine Corps Recruit Depot Parris Island at the ripe age of 50.

After completing boot camp, Douglas proudly wrote "I found myself able to take the strenuous boot camp training without asking for a moment's time out and without visiting the sick bay." Following a recommendation from his commanding officer (and a strong recommendation from his old friend Frank Knox,) Douglas was commissioned as a captain in the Marine Corps, after seven months as an enlisted Marine.

Douglas went on to serve in the battle of Okinawa, often being remembered by Marines for running around the battlefield with the vigor of a much younger Marine. He was promoted to major during the battle of Okinawa.

Douglas had been hit by a machine gun in his left forearm and was evacuated by the men that he had dedicated his life to serving. After being hit, he proceeded to use his uninjured hand to take off his major rank insignia so that he wouldn't receive special attention.

Douglas expressed passionate interest in returning early to his men to continue serving on the front lines. He was hospitalized in San Francisco and subsequently moved to Bethesda, Maryland where it took more than 14 months to be dismissed from the hospital and was medically retired from the Marine Corps, only regaining partial use of his left hand.

Because of his brave actions under fire and unselfish service he was promoted to lieutenant colonel a year after he retired in January of 1947. After returning to Chicago as a war hero, Douglas won his spot as Illinois state senator in 1949. Even in public office Douglas continued to advocate for the Marine Corps, and proudly kept the Marine Corps standard displayed in office.


