## **Notes from the Adjutant's Desk**



A BIG THANK YOU to those who have renewed for 2023. On the other side of the story, sorry to say we did not hit the 90% target date. This is the first time we have missed a target for 2023.

The fourth mailing of dues notices for 2022-2023 have been mailed out by the American Legion National Headquarters. Current membership stands at 1086. If you happen to be one

of the few whose dues were received after the February cutoff date, you might receive a dues notice. If you know that you have paid your 2023 dues, just throw the notice away.

If you have not paid your 2023 dues, please pay them. Post 3 memberships currently stand at 89% of our assigned goal for 2023. To make 100% will require the 150 members who have not yet renewed for 2023 to pay their 2023 dues. Then we need to replace the 55 members who have died this past year. Time to hit the street and find those who earned the right to be a Legionnaire.

Those who have not paid your 2023 dues, please take the time to review the reverse side on the notice. These notices have been changed; they have added the basic information that they have on file for you: branch of service, war era, phone number and email address. If some of your information is not correct, please correct the information and mail the form with your 2023 dues payment to 123 South 84<sup>th</sup> Street, Suite L, Lincoln, NE 68510. I will see that it gets corrected. Thanks for your help.

If the 2023 card that was mailed out showed an incorrect number of years, please let us know. We have fielded many calls about total years of membership not being correct. You can double check your card from 2022 to see if the 2023 card has added one year for you. If not, let me know and I will mail out a new card with the correct years and have National update your membership record.

During February and March, the POWs held by North Vietnamese were released from captivity and flown home.

## **Lincoln CBOC/VA News**



The VA no longer requires the wearing of masks to enter clinics. Masks are available for those who still wish to wear them.

The Pact Act: On August 10, 2022, President Biden signed the PACT Act into law, extending and expanding VA health eligibility to many veterans. The PACT Act expanded benefits for exposures to burn pits, Agent Orange, and other toxic substances. This

PACT Act now PRESUMES that exposure to toxics substances caused many health problems to those who served in these theaters. If you have filed a claim for Agent Orange or other toxins and it was denied, you need to file a claim update and get a new review.

If you have not filed a claim under the PACT Act, go to the Veterans Affairs web site. There you will find answers to your questions about what the PACT Act means for you or your loved ones. You can also call 800-698-2411 (TTY: 711). You can file a claim for PACT Act-related disability compensation or apply for VA health care now. If you are awarded a new disability or have one upgraded, you will or should receive back pay to September 2022.

If you had service in Vietnam or the Middle East, visit the VA web site and read the list of medical problems that are now presumed to have a link to service in these theaters. If you have any, contact your Service Office to file a new or updated claim.

One of the forms that the VA would like to have on file for all veterans who use its hospitals and clinics is an Advance Directive Durable Power of Attorney for Health Care and Living Will. Form VA 10-0137 can be picked up at your local clinic or hospitals. This form allows you to inform the VA who you might wish to make health care decisions if you become disabled. Not required, but it might be something that you may want to think about.


#### Just a few items:

How about these pointers to help you perceive the real notion of our existence. Who or what made the Universe? How was it accomplished?


Why is there an Earth with its teeming biosphere of organic life encompassing humans, animals, and plants? Where are we going? When did we become aware that our existence was not an accident?

Later that day, similar certificates and medals were given to Beau Belgum and Anna Hoff, Air Force JROTC Cadets at Lincoln Northeast High School.





# Remains Of WWII Service Members Arrive At Offutt

For the first time in more than two years, airmen on Tuesday bore the flag-draped coffins of World War II service members off an Air Force cargo plane at Offutt Air Force Base.

About 50 airmen and civilians — including Gov. Jim Pillen and Rep. Mike Flood — saluted as nine transfer cases were carried to two waiting trucks from an Alaska Air National Guard C-17 that had just flown in from Europe.

The remains had been disinterred from graves marked "unknown" at the Rhone American Cemetery in France, or from recently excavated air crash sites in Germany. Forensic anthropologists from the Defense POW/MIA Accounting Agency lab at Offutt will work to identify them.

"They are all recoveries of either aircraft crashes or battlefield losses," said Dr. Franklin Damann, the Nebraska lab director.

Typically, Damann said, about four Air Force flights per year ferry remains from Europe. But they had not been able to land at Offutt since 2021 because of a runway reconstruction project that concluded last September.

"This is the first thing we're doing with the new runway at Offutt," Damann said.

The Offutt lab, which opened in June 2013 in the former World War II-era Glenn L. Martin Bomber Plant, is one of two labs where the accounting agency identifies the missing from U.S. wars since World War II. The other is in Hawaii. Reporters received a tour of the Offutt lab, where bones and personal effects were laid out on tables for matching, cataloging and eventual identification.

The two labs identify about 200 missing service members each year using DNA, historical and dental evidence, said Fern Sumpter Winbush, the accounting agency's principal deputy director.

The annual budget for the work is more than \$130 million.

She said the identification effort represents a promise to service men and women that even if they are lost in combat, they will not be left behind. "Not only are we promise-keepers, but we also put action to these promises," Sumpter Winbush said.

"We don't spare any expense, personnel- or resource wise to honor those who made this sacrifice.


The Offutt lab's job is primarily to identify remains from the European theater of World War II. Most remains from the Pacific, or from the Korean and Vietnam Wars, are identified at the Hawaii lab.

However, the Offutt lab has taken on several special projects, including a six-year effort from 2015 to 2021 to identify sailors and Marines who died aboard the battleship USS Oklahoma during the Dec. 7, 1941, attack on Pearl Harbor. Of the 429 service members who died aboard the Oklahoma, 394 remained unidentified after the war.

The accounting agency was able to identify 361 of them in the largest such project in its history.

# **Soldier Accounted For From Vietnam War**





The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Pfc. Thomas F. Green, 19, of Ramona, California, killed during the Vietnam War, was accounted for Aug. 23, 2022.

In October 1971, Green was assigned to the 68th Aviation Company, 52nd Aviation Battalion, 17th Aviation Group. On Oct. 26, Green was serving as the door gunner on a CH-47B Chinook helicopter when it went down over water in bad weather while flying from Tuy Hoa to Cam Ranh Bay in Vietnam. Remains of four of the 10 Soldiers on board were recovered during search and rescue operations following the crash, but Green was not accounted for.


An unsuccessful recovery attempt was made in 1974 when divers from the Joint Casualty Resolution Center dove on what was believed to be the crash site. A number of investigation and recovery efforts took place between 1994 and 2021 with a June 2021 recovery mission finding possible human remains and material evidence.

To identify Green's remains, scientists from DPAA used anthropological analysis, as well as material and circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis.

Green's name is recorded on the National Vietnam Veterans Memorial in Washington, D.C., and the American Battle Monuments Commission's Courts of the Missing at the National Memorial Cemetery of the Pacific in Honolulu, along with others who are unaccounted-for from the Vietnam War. A rosette will be placed next to his name to indicate he has been accounted for.

Green's remains were buried in Ramona, California on Feb. 23, 2023.

## POW Earned The Medal Of Honor For Saving His Entire Unit



On Apr. 24, 1951, Cpl. Hiroshi Miyamura — known as "Hershey" to his men — and his squad of a dozen machine gunners and five riflemen were stationed on a Korean hill to delay the Chinese attack everyone knew was coming. The hillside was pocked with trenches and craters and littered with razor wire. At 4 in the morning, the quiet was broken by the sound of bugles and whistles as waves of Chinese regulars swarmed across the Imjin River. One of those waves breaking against Miyamura's position.

Suddenly, he was in charge of a suicide mission.

Born and raised in Gallup, New Mexico, the son of Japanese immigrants, Miyamura served in World War II with the famed 442<sup>nd</sup> Regimental Combat Team, a Japanese-American unit that became the most decorated unit for its size and length of service in the history of America, but did not see action. He joined up again when the Korean Conflict broke out in 1950 and was trained in heavy weapons and sent to Korea.

For hours that morning, the Chinese waves beat against Miyamura's position. Their overwhelming numbers came straight at Miyamura as his machine guns slowly eliminated the enemy squad, one man at a time. As their ammunition dwindled, Miyamura, who was directing fire, firing his carbine, and hurling grenades at the attackers, ordered his squad to fix bayonets.

At one point, the Chinese began attempting to flank the remnants of the small unit, so Miyamura attacked — by himself.

"Chinese soldiers had been cautiously moving up the slope when Miyamura suddenly appeared in their midst," Brig. Gen. Ralph Osborne, would later announce. "Jabbing and slashing, he scattered one group and wheeled around, breaking up another group the same way."

He then returned to his squad and began tending to the wounded, but he soon realized his position was hopeless. He ordered a withdrawal.

As the men readied to pull out, another wave of Chinese struck and Miyamura moved to an untended machine gun and fired it until he was out of ammunition. He disabled the machine gun to keep out of enemy hands and was about to join the withdrawal when the Chinese again hit his position. He bayoneted his way to a second, untended machine gun and used it to cover his men's withdrawal until he was forced to take shelter in a bunker and kept fighting. The area in front of the bunker was later discovered to be littered with the bodies of at least 50 of the enemy combatants.

When the fighting hit a lull, Hershey found himself alone.

Now wounded in the leg by grenade shrapnel, he began to work his way back from the front at times meeting — and besting — Chinese troops in hand-to-hand combat until, exhausted and weakened, he fell into a roadside ditch and was captured.

For the next 28 months, he struggled to survive in a North Korean POW camp, believing his entire squad had been killed or wounded. He also naively feared he would face a court-marshal for having lost so many of his men. (In fact, several of the squad had survived). So, when he was finally released at the end of the fighting, he weighed less than 100 pounds and faced freedom with some trepidation.

Instead, he was awarded the **Medal of Honor**.

The award had been kept secret for fear of enemy retaliation, so few ever knew of Hershey's actions on that lonely Korean hill. So it was with some surprise that Miyamura was informed by Gen. Osborne of his MOH.

"What?" he is reported to have said. 'I've been awarded what medal?'

On Oct. 27, 1953, then-Sergeant Miyamura — he had been promoted while in captivity — received his award from President Dwight Eisenhower at the White House and returned to Gallup where the city's schools were let out, businesses had been closed, and some 5,000 people greeted him as he got off the train.

Gallup had declared "Hiroshi Miyamura Day."


