
Remember, we do not have an Auxiliary meeting in January.




PRISONERS OF WAR AND MISSING IN ACTION

Following Their Lead.



Over the course of my military career, I have heard numerous stories of the selfless acts of those POW / MIA soldiers who sacrificed and gave of themselves for the betterment of their fellow soldiers. The current path that our country is heading down is a very dangerous one --- where patriotism, faith in God, and family values are being shamefully pushed to the side for a more individual-centric, Godless lifestyle. This path can be likened to the journeys that many soldiers experienced during their time at war ---

especially our POW/MIA soldiers.



But, like those POW/MIA soldiers, we, as a society, can take actions to better our odds of long-term success. It involves selfless sacrifice, speaking truth in the face of adversity, and being the light that inspires others around us to keep on pushing through the darkness to the all-embracing light on the other side.

Those were selfless souls who endured innumerable travesties while in enemy hands. They defied the odds to not have their spirits broken and inspired their fellow soldiers. They are the prime

examples that we need to be looking toward as we find ways to correct our country's path.

When we are met with hatred for our country from the very people who live and thrive off this beautiful land, we must find a high road. We must become well versed in the values and beliefs upon which our ancestors founded this country. The same values and beliefs that encouraged our beloved POW/MIA soldiers to endure day after day of excruciating injustice.

Ask yourself what you can do to inspire those around you to be proud of the amazing country that we live in. Think about what the POW/MIA soldiers did during their internments to encourage their fellow soldiers to keep believing in their country --- and then try to incorporate that spirit of Americanism into your day-to-day life. Set an example that inspires others to believe in all the greatness that our country has to offer --- the very same greatness that inspired our POW/MIAs to keep on pushing. With all of that said, I'd like to share the story of one inspirational POW, Captain Gerald Coffee.

On February 3, 1966, CPT Coffee and his navigator, LT Robert Hanson, were shot down and quickly captured by the North Vietnamese off the coast of Nghe An Province, 60 miles south of Hanoi. LT Hanson would succumb to his wounds suffered from the ongoing battle between the North Vietnamese and the Americans before reaching their prison camp.

Coffee endured a ten-day trip to Hoa Lo (aka the Hanoi Hotel), stopping at every village along the way to be brutally beaten by the village residents. Coffee spent seven years in a 3'x6' prison cell, where he endured frequent torture and interrogation. But, he maintained hope. He noticed an etching in the wall which read "GOD = STRENGTH," which proved to be a catalyst to the turning point of his captivity.

He pushed on with an optimistic attitude, inspiring his fellow American POW's through various forms of communication. At one point, he and his prison mates began whistling "Yankee Doodle," which --- in turn --- provided inspiration to many others within the prison camp by instilling in them the knowledge that they were not alone. They were all in it together. They established a system of tap codes and were able to encourage each other through tapping inspirational messages through the walls.

Coffee, along with 90 of his fellow POWs, were finally released on February 12, 1973, when the North Vietnamese communists finally signed the Paris Peace Accords, which called for the release of all American POWs. Coffee went

home to his family in Jacksonville, Florida, where he went on to become an inspirational speaker. His main speaking topics were on the invincibility of the human spirit and the importance of faith when faced with adversity.

Hopefully, the story of Gerald Coffee is inspiration enough for all of us to go out and radiate our love for this country and the values and beliefs upon which it was founded, inspiring many others to feel the same burning love of country.

God has truly blessed our country, and it is up to us to ensure its lasting success for generations to come.

PARK ENTRY PERMITS AVAILABLE TO DISABLED VETERANS



As a result of recently passed legislation by the Unicameral, disabled veterans who are legal residents of Nebraska and who have been deemed 50 percent or more service-related or 100 percent disabled non-service connected and receive a pension from the Veterans Administration, are

eligible for one (1) perpetual Disabled Veteran's Lifetime Annual Park Entry Permit at no fee.

An application form and signature from a Veteran's Service officer is required. The application can be presented in person when applying for this permit.

Nebraska Game and Parks Service Centers can provide information and print out the application for the guests. However, the guests need to send the application to the Department of Veterans Affairs if they need certification. Or, they can send it to the Permit Section in Lincoln if they have already met the qualifications as a result of prior application for a disabled veteran Hunt/Fish permit.

To apply for a Disabled Veteran's Permit via the mail, fill out the application and have it signed by a Veterans Service Officer. Mail the completed application to the Nebraska Game and Parks Commission, PO Box 30370, Lincoln NE 68503-0370.

FISHER HOUSE OPENS IN OMAHA

Manager Colleen Vonderhaar has announced the official opening of the Omaha Fisher House.

The Fisher House provides a place for families to stay --- free of charge --- while their loved one is receiving medical treatment through the VA system. The Omaha Fisher House, located on the VA Medical Center campus at 4101 Woolworth Avenue in Omaha, features 16 fully furnished family suites, each equipped with a private bathroom.

OMAHA FISHER HOUSE

Frequently Asked Questions

Who owns the Fisher House?

The Fisher House Foundation builds and furnishes the house and then donates the house to the VA as a gift. The VA operates and maintains the house.

Does it cost anything to stay at a Fisher House? There is no cost to stay at a Fisher House.

What is the criteria to stay at the Fisher House?

Family members/caregivers of a hospitalized Veteran who live 50 miles or more from the Medical Center qualify to stay at the Fisher House. Guests must be able to care for themselves and follow the house rules.

How many rooms are there?

There are 16 suites, each guest room has a private bathroom.

What do families do about meals during their stay?

The Fisher House has a well-equipped kitchen for families to use during their stay. Some food items and meals are donated from the community, but families are ultimately responsible for providing their own meals.

Can I have a guest/visitor stay with me?

Only those guests who are on the Fisher House referral within the medical record are allowed to stay. All guests must be referred through the Veteran's care team and approved by Fisher House staff.

Can I have food or drinks in my room?

All food and drink must remain in the kitchen or dining room, with the exception of water.


