#### **Commander's Call**



Fellow Legionnaire,

Let me ask you this... If a family member, friend, or even a stranger, asked you to describe The American Legion... How would you answer them? What's your "elevator speech"?

Now, you may be asking yourself, "What the heck is an elevator speech?" An elevator speech is a brief (think 30 seconds!) way of introducing yourself, getting across a key point or two, and making a connection with someone. It's called an elevator speech because it takes roughly the amount of time you'd spend riding an elevator with

someone. For example, if you happened to bump into someone you'd been dying to meet in an elevator, how would you introduce yourself, get your point across, and ask to stay connected—all before that person gets off the elevator?

Here's an example of one (that could be modified to better suit your own experiences) that I use (and modify continually based upon the situation):

Hi, I'm Bruce Gubser, and I'm a member of The American Legion Post 3 here in Lincoln. I'm an Army veteran and I continue to serve my community, state and nation by being a member of The American Legion. Have you ever served in the military? (wait for their answer and depending on their answer I might respond in a couple of ways) If they have, then I might say something like, "Great! Thank you for your service! What branch? What did you do in (that branch)? What I've found in The American Legion is a way to stay connected with people who have also served, and together we support programs in The American Legion like Boys and Girls State, Junior Law Cadet, American Legion Baseball, the American Legion Oratorical scholarship program, and many other programs that support and enhance the lives of veterans and their families. Have you ever considered joining The American Legion?"

Or, when asked if they ever served in the military, and they say they never served, I might say something like, "Has anyone in your family ever served?" Many times, this answer will be yes... Oh, my dad was in Vietnam, or my grandmother was a nurse in World War 2, or something like that. Then, I might say something about The American Legion Auxiliary or The Sons of The American Legion.

Bottom line, I always keep this statement in mind... "If you don't ask, the answer is always NO."

Tell them what they are missing and how they will enjoy our Legion and our Legion Family. Not long ago I made a list of what Post 3 worked to support. The list included charitable events, higher education scholarships, civic events, Honor Guard, Boys & Girls State, Junior Law Cadet and other veterans' causes. #### **Notes from the Adjutant's Desk**



It is hard to believe it has been 52 years since I returned from Southeast Asia, after spending 14 months in Thailand. I joined the American Legion a month after my return to Lincoln. Checking the membership roster, I see that the Vietnam Era veterans now make up the majority of our current membership.

I want to thank all my fellow Vietnam Veterans for their service. March 29, 1973, was the date that the last

combat troops left Vietnam, and is celebrated as Vietnam Memorial Day. As we get older, we need to stop and review our service there. Thanks again.

**2025 Renewals:** We are still running behind 2024. The current 2025 membership stands at 916, about 86 % of our 2025 goal. We should be at 95%. If you know a current or past member who has not paid their 2025 dues, please ask them to do so.

For those who have not yet renewed for 2025, your 2024 membership card expired as of 31 December 2024. As of January first, you were classified as expired, you will stop receiving The Legion magazine, and you could be denied entry into a Legion Club. Those who are in the Legion Insurance program, your coverage also ended as of 31st of December 2024. You must be a member in good standing to be covered. If you have not yet signed up for Legion Insurance, it is easy to do, just go to their website and enroll.

I want to thank those members who have renewed. If you happen to receive a notice and you KNOW that you have received your 2025 membership card, please just throw the notice away. No need to let us know. If you have paid and have not received your 2025 membership card, then call or drop us a note.

We are still receiving a few checks from those who have already paid their 2025 dues. I will try and contact those members and ask if they would like to apply this extra payment to pay their 2026 dues. Otherwise, I will return the checks or destroy them.

Post 3 membership for 2025 is now \$56.00 dollars, as the National and Nebraska Department both increased their dues by five dollars. Post 3 did not increase its dues for 2025, remaining at eleven dollars.

Post 3 has 50 Department Life members and 122 PUFL members. 57 members have participated and paid their dues for 3 years. For those who would like to renew for three years, you can do so by logging into Legion.Org and click the RENEWAL link. Once there, you will be given the opportunity to renew for three years. The rate for renewing will be at the current rate of \$56.00 dollars. The advantage of renewing for three years is that you will save on any new dues increases for the next three years.

**Nebraska Department Life members:** 2025 membership cards have been mailed to the address we had on file for you. If you have not received yours, or have moved during the past year, please let us know so we can get them to you.

<u>Member Information:</u> We would like to thank those who have provided the request for mailing address, phone numbers or email address information. We have many members who moved and we do not have correct contact information. The US Postal service returns mail that they do not have a forwarding address on. We try to track down those members who have moved, but many locations respond with, "no longing living here."

The same goes for those members who have passed on to Post Ever Lasting. If you know of a member who has died, please let us know. This saves National and Post postage on renewals which are returned to the Post.

This also goes for branch of service, or war era. National has been printing on the back of the renewal slips the data that is in the Legion database. Please check and add as needed so we can correct our database. Thanks, it makes it so much easier to reach out to you if needed.

<u>Department of Veterans Affairs, VFW, DAV, AMVETS web sites:</u> These web sites are a great place to find current and helpful information on what Congress is currently working on and how it could affect you as a veteran. The VA website has many tips on filling claims and links to other VA services to which you are entitled. The VFW, DAV, etc. do an excellent job of keeping track of Congressional activities that can or will affect veterans. VA News (veteransaffairs@messages.va.gov).

The Nebraska Department of Veterans Affairs and your local County Service Office are there to serve you. They can pull up your records of military service and help track your claims you may have filed.

The members of the most current conflicts are now the backbone of not only the American Legion, but also the VFW, DAV, AMV, etc. Without these younger veterans we will no longer have a strong voice in Congress. Without a strong voice in Congress, we will keep losing funding for the Department of Veterans Affairs and the VA Health Care System.

If you are a member of this group of veterans or know a veteran from these conflicts, please ask them if they are a member of a VSO (veteran service org) and if not, ask them to please join. They may not be using VA service now, and may wish to in the future, may find that VA services have been cut back due to a lack of a strong voice in Congress.

Again, Thanks for your Service and Thanks for being a member of Post 3. Also remember to thank your fellow Veterans for their service.

#### **Lincoln CBOC/VA News**



The Lincoln CBOC food drive to collect food items for our homeless veterans in the Lincoln area is ongoing. Items requested are shelf ready, power bars, easy to open items (pull tabs), etc. They will be collected during the week of 10 – 14 February. During this week, VSO groups are being asked to provide treats for our veterans.

Planning is in the works for a Health Information Fair to be held at the Lincoln CBOC. The hope is to draw in veterans in the Lincoln area that do not take advantage of the services available to them within the VA Health Care System.

If there is a hiring freeze, it should not affect the VA health care network. Lincoln has many staff positions that need to be filled. It just takes so long for a person to work through all the steps to be hired. If there is a hiring freeze, no new volunteers will be added in the Lincoln CBOC. The Lincoln CBOC clinic sees about 220 veterans a day.

Flu shots and Covid shots: Shots are available only to those enrolled in the VA Health system. Those who have an appointment can receive a shot during their visit with their provider. Walkins can request a shot by speaking to the staff at check in and waiting for a nurse to be free to give you the shot. There are no mask requirements at VA clinics and hospitals. Masks are available for those who wish to wear them at the front doors of the clinics.

Express Care is a walk-in service, for those who wish to have a nurse check out minor items. Times might be different at your local clinic, so give them a call and see if they offer Express Care (walk in) service. This care is available to those who might wish to see a VA nurse without an appointment during normal hours.

Want to serve your fellow Veterans? The VA can use more volunteers at your local clinic or hospital. You volunteer to help veterans in the clinic or hospital, or a veteran home. Or you can donate to your local clinic, hospital, or veteran's home. They can always use a monetary donation, or you can donate activities bags for younger kids to have when they come to the clinic or hospital with a parent for their appointments.

There is always a need for the younger kids who come with parents, grandparents or other trusted adults when they are too young to be left at home alone.

Clinics and hospitals can always use books, magazines, etc. for patients. You would need to check with your local hospital, clinic, or veteran's home volunteer office to see what items they need or allow. This would be a great project for your church, school, or youth group.

Hours given by the volunteers are credited with saving the VA Health at Omaha, Lincoln, and GI an equivalent of 25 full-time staff employees. This is based on an hour of service being credited at the rate of \$31.50 dollars per hour.

The only service animals that should be brought into a VA Health clinic or hospital are trained service dogs that quality under DAV requirements. Other pets / comfort dogs, etc., do not qualify and should be left at home.

With the signing of the PAC act, more veterans have become eligible for services, not only for those who serviced "Boots on the ground, but anyone who has served since the Gulf War. If you have any questions, call your local service officer, VSO, county, or state. It only takes a few minutes to see if you might qualify for an increase, or a new VA disability rating.

The Veteran Affairs web site is a great place to visit. You can find out the latest information affecting Veterans. You can track claim status, file for travel pay, view your VA account, payments received, or Copay owed. You can also make the Copay payments online.

Thanks for your service to your fellow Veterans and thanks for your service to this great country.

#### Arthur Raymond Jones - 1928 - 2025









Arthur Raymond Jones (Art) transferred to Post Everlasting on March 4, 2025. Upon graduation from High School in 1948, Art joined the United States Marine Corps. He served in the Korean War and survived the "Battle of the Chosin Reservoir". Art also served 18 months during the Vietnam War. After Vietnam he continued his service with the Marine Aviation Group in Japan. Art's final duty station was with the Marine Corps Reserve Unit in Lincoln, Nebraska. Art retired as a Gunnery Sergeant in 1970 after 22 years of service.

Art was active with The American Legion Post 3 and was a 56-year continuous member. Art was a 30-year member of the 40&8 Société (an independent honor society of American veterans and service members), and served on the Post 3 Honor Guard for 26 years.

Art's funeral was held on March 10<sup>th</sup> at St. Marks United Methodist Church with the Patriot Guard providing a Flag Line at the church and cemetery. Interment was at Lincoln Memorial Park, Lincoln, Nebraska where members of the Marine Military Honors Team folded the burial Flag and presented it to his Granddaughter. The Post 3 Honor Guard provided the 3-shot volley and the playing of Taps.

Director Gubser reported for the American Legion Riders. They are beginning to get active with the better weather and had made a good showing at the Art Jones funeral.


Commander Gubser indicated that the birthday card program continues.

#### **WWII Soldier Identified**





The Defense POW/MIA Accounting Agency announced today that U.S. Army Sgt. Norman H. Drewes, 24, of Hamler, Ohio, killed during World War II, was accounted for Sept. 13, 2024.

In June 1944, Drewes was a member of Company D, 708th Amphibious Tank Battalion. He was killed June 15 during Operation Forager on the island of Saipan, in the Northern Mariana Islands. Marines ashore on the island were under constant assault from Japanese mortars, which caused heavy casualties and impeded American's movements. The exact cause of Drewes's death is unknown, but it is believed his unit was providing armor support to the Marines' initial landing on the beaches. Drewes's remains were not known to have been accounted for during or after the war. The War Department declared him non-recoverable in September 1949.

The American Graves Registration Service (AGRS) searched for and disinterred remains throughout the Pacific theater in an effort to identify fallen service members after the end of the war. Remains identified as Unknown X-58 were first reported as buried in the 4th Marine Division Cemetery on Saipan. However, the AGRS was not able to identify X-58, and the remains were buried at the Manila American Cemetery and Memorial in the Philippines in 1950.

After thorough research, DPAA historians concluded X-58 was possibly associated with Drewes. In December 2022, Unknown X-58 was disinterred and sent to the DPAA Laboratory for analysis.

To identify Drewes's remains, scientists from DPAA used dental and anthropological analysis, as well as dental and circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA analysis.

Drewes's name is recorded on the Courts of the Missing at the National Memorial Cemetery of the Pacific in Honolulu, along with the others who are still missing from World War II. A rosette will be placed next to his name to indicate he has been accounted for.

Drewes will be buried in Hamler, Ohio, in May 2025.

#### **Army Soldier Awarded The Medal Of Honor**





Captain Paris D. Davis, Commander, Detachment A-321, 5th Special Forces Group (Airborne), 1st Special Forces, distinguished himself by acts of gallantry and intrepidity above and beyond the call of duty while serving as an advisor to the 883d Regional Force Company, Army of the Republic of Vietnam, during combat operations against an armed enemy in the vicinity of Bong Son, Republic of Vietnam, on June 17-18, 1965.

Captain Davis and three other U.S. Special Forces advisors accompanied the Vietnamese 883d Regional Force Company on its first combat mission, a daring nighttime raid against a Viet Cong Regional Headquarters housing a superior enemy force. Captain Davis' advice and leadership allowed the company to gain the tactical advantage, allowing it to surprise the unsuspecting enemy force and kill approximately 100 enemy soldiers.

While returning from the successful raid, the Regional Force Company was ambushed and sustained several casualties. Captain Davis constantly exposed himself to hostile small arms fire to rally the inexperienced and disorganized company. He expertly directed both artillery and small arms fire, enabling other elements of the company to reach his position. Although wounded in the leg, he aided in the evacuation of other wounded men of his unit, but refused medical evacuation himself.

Following the arrival of air support, Captain Davis directed artillery fire within 30 meters of his own position in an attempt to halt the enemy's advance. Then, with complete disregard for his own life, he braved intense enemy fire to cross an open field to rescue his seriously wounded and immobilized team sergeant. While carrying the sergeant up a hill to a position of relative safety, Captain Davis was again wounded by enemy fire. Despite two painful wounds, Captain Davis again refused medical evacuation, remained with the troops, fought bravely, and provided pivotal leadership and inspiration to the Regional Force Company as they repelled several Viet Cong assaults on their position over a period of several hours.

When friendly reinforcements finally arrived, Captain Davis again refused medical evacuation until he had recovered a U.S. advisor under his command who had been wounded during the initial ambush and presumed dead. While personally recovering the wounded soldier he found him severely wounded but still clinging to life. Captain Davis directed the helicopter extraction of his wounded colleague, not leaving the battlefield himself until after all friendly forces were recovered or medically evacuated.

Captain Davis' heroism and selflessness, above and beyond the call of duty at the risk of his own life, are in keeping with the highest traditions of military service and reflect great credit upon himself, his unit, and the United States Army.
