Ten (10) Session Commitment Agreement -Discounted Pricing Addendum 2026–2027 School Year

This Ten (10) Session Commitment Agreement ("Agreement") is entered into between SPS Tutor LLC ("Company") and the undersigned Client. This Agreement serves as an addendum to the SPS Tutor LLC 2026–2027 Tutoring Agreement and governs eligibility for discounted tutoring rates in exchange for a minimum ten (10) session commitment.

1. Eligibility for Discounted Rate

Clients are eligible for discounted tutoring rates only upon entering into this legally binding Agreement and committing to purchase a minimum of ten (10) tutoring sessions between August 1, 2026 and July 31, 2027.

2. Eligible Services

The discounted pricing offered under this Ten (10) Session Commitment Agreement applies **exclusively** to SPS Tutor LLC's **standard K–12 academic tutoring services**.

For purposes of this Agreement, standard K–12 academic tutoring includes subject-area instruction for students enrolled in grades Kindergarten through 12th grade in courses commonly offered through elementary, middle, or high school curricula.

The discounted pricing and ten (10) session commitment established under this Agreement shall NOT apply to:

- SAT preparation
- ACT preparation
- CLT preparation
- PSAT preparation
- GED preparation
- College coursework



- Dual Enrollment (DE) coursework
- Advanced Placement (AP) courses requiring specialized pricing
- College admissions consulting
- Educational advocacy services
- Private teaching services
- Homeschool instructional services
- Workshops, boot camps, crash courses, or group programs
- Any service specifically identified by SPS Tutor LLC as excluded from this Agreement

These services are billed according to their respective pricing schedules, package agreements, membership agreements, or service contracts and are not eligible for the discounted pricing provided under this Agreement unless SPS Tutor LLC expressly agrees otherwise in writing.

SPS Tutor LLC reserves the sole and exclusive right to determine whether a requested service qualifies as standard K–12 tutoring under this Agreement.

3. Billing Policy

Sessions shall be billed and paid in accordance with the SPS Tutor LLC 2026–2027 Tutoring Agreement. Clients remain financially responsible for the purchase of a minimum of ten (10) tutoring sessions regardless of attendance, scheduling conflicts, withdrawal from services, or failure to utilize purchased sessions. Payment is due at the time of booking unless otherwise approved in writing by SPS Tutor LLC. All payments are final and subject to the Company's No Refund Policy.

4. Timeframe for Completion

All ten (10) sessions must be completed and paid for no later than July 31, 2027. Sessions may be scheduled throughout the contract period, subject to tutor availability.

5 Minimum Payment Obligation

Should the Client fail to schedule, attend, or complete the required ten (10) tutoring sessions by July 31, 2027, the Client shall remain financially responsible for the remaining balance of all unfulfilled sessions at the discounted contract rate. SPS Tutor LLC may invoice the Client for any outstanding balance. Unused sessions expire July 31, 2027, are non-refundable, hold no cash value, and may not be transferred or redeemed after expiration.

6. Priority Booking

Clients participating in this Agreement are eligible for priority scheduling beginning on the 25th day of each month for appointments during the following month, subject to tutor availability. Priority scheduling is a courtesy and does not guarantee any specific tutor, day, time, instructional format, location, or recurring appointment. No refunds, credits,



discounts, or makeup sessions shall be issued due to limited availability resulting from delayed booking.

7. Discounted Pricing

Discounted pricing shall be based on the current SPS Tutor LLC 2026–2027 published pricing schedule. The pricing in effect at the time this Agreement is executed shall control.

8. Governing Law

This Agreement shall be governed exclusively by the laws of the State of Florida. Venue for any dispute shall be Sarasota County, Florida, as provided in the SPS Tutor LLC 2026–2027 Tutoring Agreement.

9. Cancellation, Rescheduling, and Attendance

All cancellations, rescheduling requests, late arrivals, no-shows, refunds, session credits, and attendance policies shall be governed exclusively by the SPS Tutor LLC 2026–2027 Tutoring Agreement.

10. Entire Agreement

This Agreement is an addendum to the SPS Tutor LLC 2026–2027 Tutoring Agreement. Except as expressly modified herein, all terms, conditions, payment obligations, scheduling requirements, cancellation provisions, and legal protections contained within the Tutoring Agreement remain in full force and effect. In the event of any conflict, the Tutoring Agreement shall control unless this Agreement expressly states otherwise.
