



Discounted Rate Commitment Contract 2025/2026 School Year

This agreement is made and entered into by and between **SPS Tutor LLC** ("Company"), with home offices in the states of Florida and Tennessee, and the undersigned client & student ("Client"), collectively referred to as "the Parties," for the purpose of securing discounted tutoring rates in exchange for a session purchase commitment.

This agreement is made between **SPS Tutor LLC** and the client named below for the purpose of outlining the terms and conditions associated with receiving the discounted tutoring rate as advertised on the pricing page of the SPS Tutor LLC website.

1. Eligibility for Discounted Rate

Client shall be eligible to receive the discounted tutoring rates outlined below only upon entering into this legally binding agreement and committing to the purchase of a **minimum of ten (10) sessions** between **August 1, 2025 and July 31, 2026**.

2. Billing Policy

- Sessions will be billed **monthly in advance**, based on the number of sessions the client schedules for that month.
- The discounted rate will be applied to each billed session, but the **client remains financially responsible for a minimum of 10 sessions**, regardless of actual attendance.

3. Timeframe for Completion

- All ten (10) sessions must be **completed and paid for** no later than **July 31, 2026**.

- The client may spread sessions across the contract period, but must fulfill the total by the deadline.

4. Minimum Payment Obligation

- Should the client fail to schedule or attend the required ten sessions by **July 31, 2026**, they will still be **invoiced for the remaining balance** of the unrendered sessions at the discounted rate.
 - Unused sessions after this period are **non-refundable, non-transferable, and may not be used after July 31, 2026**.

5. Priority Booking

- Clients under this agreement will receive **priority scheduling access**, with calendars released to them on the **25th of each month** for booking sessions in the upcoming month.
 - It is the responsibility of the client to book their appointments within the priority booking window on our website.
 - Failure to schedule in a timely manner may result in limited availability; **SPS Tutor LLC is not liable** for missed opportunities to book, and no refunds or credits will be issued for unbooked time.

7. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the **State of Florida and the State of Tennessee**. Any disputes arising out of this Agreement shall be resolved in the **state or federal courts of Collier County, Sarasota County, or Lee County in Florida, or Knox County in Tennessee**, as applicable based on the client's location or service delivery.

8. Cancellation and Rescheduling Policy

- A **minimum of 24 hours' notice** is required to cancel or reschedule any session without penalty.

- If 24 hours' notice is given, the **cost of the canceled session will be credited** and must be **re-booked within 30 calendar days** from the original session date.
 - If the client fails to re-book the session within that 30-day window, the **session will be forfeited**, and no credit or refund will be provided.
 - Cancellations or reschedule requests made **with less than 24 hours' notice** will be charged in full and are **not eligible for rescheduling or credit**.

9. Entire Agreement and Acknowledgment

By signing below, the Client agrees to the full terms and acknowledges that this document constitutes the **entire agreement** regarding discounted tutoring rates. Failure to comply with these terms will result in **enforced billing for the outstanding balance** owed, and **no refunds shall be issued**.
