1. Parking is available around the park; however, it is a first come basis. Vendors should be prepared to park a distance from their assigned vendor space. There is a driveway which will allow for loading and unloading but cars may not be left there.
2. Vendors are responsible for any sales tax permits or requirements and payments per Illinois Craft and Vendor Fair regulations.
3. Vendors are responsible for items and tending to booth the entire time.
4. All vendors selling food are required to have a Food Handlers Permit per Illinois regulations. Please be sure a copy is available as the Logan County Health Department will check.

**ATLANTA FALL FESTIVAL
RELEASE AND WAIVER OF LIABILITY for VENDORS**

This Release and Waiver of Liability is executed this day of _____, 2024, by _____ (the "Vendor") in favor of Atlanta Fall Festival and its directors, officers, employees, volunteers, and agents.

I, the Vendor, hereby freely and voluntarily, without duress, execute this Release under the following terms:

1. Waiver and Release. I hereby release and forever discharge and hold harmless the Atlanta Fall Festival and its successors and assigns from any and all liability, claims, demands, and causes of action, of whatever kind of nature, either in law or equity, which may hereafter arise from my participation with Atlanta Fall Festival. I understand and acknowledge this Release discharges Atlanta Fall Festival from any liability or claim I may have against Atlanta Fall Festival, with respect to any bodily or other injury, illness, death, or property damage which may result from my participation. I also understand Atlanta Fall Festival does not assume any responsibility or obligation to provide financial assistance or other assistance, including, but not limited to, medical, health, or disability insurance, in the event of injury, illness, death, or property damage.

2. Medical Treatment. Except as otherwise agreed to by Atlanta Fall Festival in writing, I hereby release and forever discharge Atlanta Fall Festival from any and all liability claims, demands, and causes of action whatsoever that may arise on account of any first aid or other medical treatment rendered during my participation with Atlanta Fall Festival.

3. Assumption of Risk. I hereby expressly and specifically assume the risk of injury or harm in the activities and release Atlanta Fall Festival from all liability for injury, illness, death, and/or property damage which may result.

4. Photography/Audio Release. I do hereby grant and convey unto Atlanta Fall Festival rights, titles, and interest in and to any and all photographic images and video or audio recordings made by or on behalf Atlanta Fall Festival, or made with its consent, during my participation in Atlanta Fall Festival.

5. Other. I expressly understand and agree that this Release is intended to be as broad and inclusive as permitted by law, and that this Release shall be governed by and interpreted in accordance with the laws of this state, county, city and/or township. I agree in the event any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.
