

### **Horizon Motor Reservation Agreement**

## **Background**

Horizon Motor is a Battery Electric Truck manufacturer whose offices are in Atlanta Georgia, and production in Athens Ohio. Horizon builds a variety of class 3 to class 8 trucks both as cab and chassis and as complete vehicles.

# **Purpose**

This form is for a reservation of a Horizon Motor truck; this is a reservation agreement and not a purchase contract. The purpose of this agreement is to reserve a truck in Horizon Motor's production queue and in any government voucher programs which will be available at the time of sale.

#### Vehicle

The Vehicle is as outlined in the attached sales brochure. More details will be included in a sales contract. The specifications outlined in the sales brochure are subject to change. Customization will be outlined in a purchase order and may well require additional deposit or delays in production.

By making your Reservation, you secure the priority for delivery of your Horizon Truck. The timing of your order may depend on development, manufacturing, and production schedules, among other factors. It is currently anticipated that delivery will be 180 days from time of receipt of deposit. This in no way is a guarantee of delivery schedules as currently world trade is disrupted.

#### **Effective Date**

Your Reservation becomes effective when we receive your Reservation Payment. By submitting your Reservation Payment, you agree that these Terms & Conditions apply to your Reservation.

### **Order Process**

While this Reservation secures your order priority, it does not constitute the purchase or order of a vehicle. When the start of production for your Reservation nears, we will ask you to place your order and you will receive a Purchase Agreement indicating the purchase price of the vehicle(s), plus estimates of any applicable taxes, duties, transport and delivery charges, and any other applicable fees. If you proceed with the order, we will apply your Reservation Payment towards the order payment. **Until you enter into a Purchase Agreement, your Reservation may be cancelled at any time prior to entry into a purchase agreement,** in which case you will receive a full refund of your Reservation Payment. On entry into a purchase agreement this reservation is superseded.

# **Acknowledgements: Non-Transferable**

You understand that we will not hold your Reservation Payment separately or in an escrow or trust fund or pay any interest on your Reservation Payment. Your Reservation is not transferable or assignable to another party without the prior written approval of Horizon.
