## Interpretation:

Molecular genetic analysis was performed for three specific mutations reported to be associated with disease in dogs. We identified two normal copies of the DNA sequences in the mutations tested.

Because this dog is "clear" of these mutations, this dog will only pass the normal genes on to its offspring.
