### A letter from our Board Chair & Executive Director



Dear Friends,

We are so pleased to share with you our first Annual Report, which covers the time period from July 1, 2018 to June 30, 2019. We could not be more proud of all that Women & Family Life Center has accomplished this year because of you and your support.



Thanks to our generous community, our total revenue this year totaled \$395,994.79, the highest amount on record outside of a capital campaign! This increase in new donations and grants has ignited fresh energy, ideas, partnerships and growth over the past year that have helped us provide and expand programs and services to meet the needs of women and families across the Connecticut Shoreline.

We were busy this year! After undergoing and adopting a new strategic plan that will guide us through 2023, here are just a few highlights of our past year's accomplishments:

- Our Guided Assistance Program (GAP) grows by 53 percent! As a result, we
  hired an additional full-time Referral Navigator; now we have two social workers
  ready to meet the needs of women and families.
- 2. Men Who Cook reaches record highs! Our annual fundraiser in October achieved the highest attendance and donations to date, all to help support women and families. Thank you to the chefs, sponsors and attendees that made it happen!
- 3. Girls for Girls: A Limelite Project launches legacy of empowerment to benefit women and families! Tracy Tolisano and her dance team created an event that celebrates girls in our community for their kindness, bravery and all the qualities that make them uniquely who they are. It is now an annual event that we are excited to be a part of. This year they donated \$18,000 to Women & Family Life Center
- Financial Consults expands to Branford site! In partnership with Branford Counseling Center (BCC), we now offer financial education appointments at BCC.
- 5. Girls Coach Girls Run celebrates 10 years of building community & confidence in the next generation of young women! 70 girls, grades 4-12, from Madison & Guilford, participated in our innovative after-school leadership program that promotes self-esteem, self-care, healthy relationships, and community.

This report also details Women & Family Life Center's updated mission, vision, and core outcomes, as well as our new tagline: 'Support. Empower. Grow.' On behalf of all of us at Women & Family Life Center, thank you for your passion, dedication and belief in helping women and families overcome life's challenges in order to reach their goals and achieve their full potential.




