

## **Coventry Scouting Showcase Player Waiver of Liability**

#### PLEASE READ CAREFULLY BEFORE SIGNING

This waiver of liability, assumption of risk, and indemnity agreement ("Agreement") is entered into by and between the undersigned participant ("Player") and ZSPORTS Academy, its officers, agents, employees, volunteers, affiliates, and all other parties associated with organizing the Coventry Scouting Showcase ("Organizer").

By signing this document, the Player acknowledges and agrees to the following:

## 1. Assumption of Risk

The Player understands and acknowledges that participation in soccer activities involves inherent risks, including but not limited to:

- Physical injury (e.g., bruises, sprains, fractures, or concussions).
- Serious injury or death.
- Property damage or loss.

The Player voluntarily assumes all risks associated with participation in the Coventry Scouting Showcase.

#### 2. Release and Waiver of Liability

To the fullest extent permitted by law, the Player agrees to release, discharge, and hold harmless the Organizer from and against any and all claims, liabilities, damages, or losses arising directly or indirectly out of participation in the event, including but not limited to claims related to:

- Negligence by the Organizer or other participants.
- Equipment failure or defects.
- Weather conditions.

#### 3. Medical Treatment

The Player authorizes the Organizer to secure medical treatment deemed necessary in case of an emergency and agrees to bear any costs associated with such treatment.

#### 4. Code of Conduct

The Player agrees to adhere to all event rules and regulations, respect staff and fellow participants, and refrain from any behavior that may endanger themselves or others.

#### 5. Media Release

The Player grants the Organizer permission to use photographs, videos, or other media taken during the event for promotional purposes without compensation.

#### 6. Indemnification

The Player agrees to indemnify and hold harmless the Organizer from any and all claims, liabilities, or expenses resulting from participation in the event.

## 7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United Kingdom.
