### PLEASE READ CAREFULLY BEFORE SIGNING

#### 3. Medical Treatment

The Player authorizes the Organizer to secure emergency medical treatment if necessary and agrees to bear any associated costs.

#### 4. Code of Conduct

The Player agrees to adhere to all event rules and regulations, respect staff and fellow participants, and avoid behavior that may endanger themselves or others.

#### 5. Media Release

The Player grants permission for photographs, videos, or other media taken during the event to be used for promotional purposes without compensation.

#### 6. Indemnification

The Player agrees to indemnify and hold harmless the Organizer from any claims, liabilities, or expenses resulting from participation in the event.

## 7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United Kingdom.
