**1. Agreement to Participate**

**2. Assumption of Risk**

I understand and acknowledge that football is a physical sport involving running, tackling, jumping, and contact that may result in injuries such as bruises, sprains, fractures, concussions, or more serious injuries. Activities may take place outdoors and involve environmental risks including weather conditions, uneven surfaces, and field conditions. There may also be exposure to contagious illnesses.

I voluntarily and knowingly assume all risks associated with participation, whether such risks are known or unknown.

**3. Waiver and Release of Liability**

To the fullest extent permitted by law, I, on behalf of myself and/or my child, hereby waive, release, and discharge ZSPORTS Academy, its founders, directors, officers, coaches, employees, volunteers, agents, and representatives from any and all claims, liabilities, demands, actions, or causes of action arising out of or related to participation in academy activities, including those caused by ordinary negligence.

**4. Medical Authorization**

I authorize ZSPORTS Academy to obtain emergency medical treatment for me/my child in the event of injury or illness during academy activities. I understand that all medical expenses are my responsibility and that ZSPORTS Academy assumes no financial liability for such costs.

**5. Indemnification**

I agree to indemnify and hold harmless ZSPORTS Academy and its representatives from any claims, damages, losses, or expenses, including legal fees, arising from participation in academy activities.

**6. Code of Conduct & Compliance**

I agree to comply with all rules, codes of conduct, safety guidelines, and instructions set by ZSPORTS Academy. Failure to comply may result in disciplinary action, suspension, or removal from the program without refund.
