CITB FUNDED NVQ'S

The CITB Grant Scheme caters for Level 2 to Level 7 NVQ's and funding is between £600 - £1500 dependent on the NVQ.

We offer the following qualifications whether you are CITB registered or not.

CUSTOMER SERVICE NVQ

These NVQs could be suited to anyone that is in a Customer Service role, inside or outside of the Construction Industry. In the Construction Industry it could be for Sales representatives in House Builder organisations, call centre staff, Customer Care Services/Aftercare services.

GRANDFATHER RIGHTS AND CSCS CARDS



WHAT DOES THIS MEAN?

Approx. 60,000 industry skills cards (CSCS) issued under the Grandfather Rights process expired on 31st December 2024 and cannot be renewed.

All CSCS Industry Accreditation cards issued from 1st Jan 2020 are no longer valid and is part of the Construction Leadership Council's drive for a fully trained and competent workforce.

Industry Accreditation allowed card holders to gain certification on the strength of an employers' recommendation rather than the achievement of a recognised qualification.

The easiest way to find out if you or an employee has an industry accredited course is to look at the back of the card and see if the words 'industry accreditation' are printed on the card.

Going forward, the easiest way to demonstrate your competence to obtain a new CSCS card is via an NVQ.

With our help, completing an NVQ has never been simpler and with funding and enhanced grants from CITB, now is the time to do it.

CITB FUNDING AVAILABLE

CITB offers all CITB registered customers access to their Grants and funding, to businesses in England, Wales, Northern Ireland, and Scotland as long as they are Levy paying and meet the Governments list of Construction activities in their 'Scope Order'.

There are two pots of money available from them:

- Grants Scheme which covers this like 'Short Period Qualifications' (NVQ'S) as well as a range of specific 'Short courses' (E.g. Asbestos Awareness)
- Skills and Training Fund
- Employer Network

We have tried to demystify what these are and how they can be accessed. However, we would always encourage you to speak to your CITB regional advisor for specific guidance.

CITB – GRANTS SCHEME

The CITB supports a range of qualifications and specific courses that are eligible for grants.

The following categories for grant are available:

- **Apprenticeships**

- **Long Qualifications**

Achievement of higher-level qualifications, such as degrees, HNCs and HNDs that take more than a year to complete.

- **Short qualifications**

CITB pays grants for the achievement of approved short-period qualifications focussed on the core construction skills needed across the industry. Examples includes NVQ's.

- **Advanced Craft (Scotland only)**

- **Short Courses**

You can apply for a grant for the achievement of short courses which last from 3 hours to 29 days and are focused on teaching core construction skills.

CITB – GRANTS SCHEME

What NVQ's will the Grant pay for?

CITB provides grants for Level 2 NVQ's, right through to Level 7 (under the Short Period Qualifications) as well as a range of specific 'Short courses'.

These grants are designed to aid the gap in the construction industry however most companies are not aware of this 'pot' of money' which is available.

Using a Grant to pay for an NVQ.

Here are examples of these CITB Grants per candidate:

- Trade NVQ Level 2 & 3- £600
- NVQ Level 3 & 4- Supervisory roles- £1,250- reducing from January 2026
- NVQ Level 6 & 7- Management roles- £1,500- £1,250- reducing from January 2026

If your NVQ qualification costs more than the CITB grant, the remainder of the costs can be topped up from Skills and Training Fund, meaning you claim back the full cost of your qualification once completed.

CITB – GRANTS SCHEME

Using the Grant to pay for a 'Short Course' (3hrs to 29 days)

The Grant can also be used on short courses which align to approved construction-related standards and are paid for on successful completion and certificate provided as evidence.

The scope within this grant is huge and covers a lot of training courses so it is best to check the CITB's comprehensive list on their website.

These are examples of courses and the grants available.

- Asbestos Awareness- £60
- Site Supervisor Safety Training Scheme - £140
- Site Management Safety Training Scheme- £240



CITB – GRANTS SCHEME

Topping up your 'Grant' from your 'Skills and Training Fund'.

If a short course costs more than the "Grant" available, you can then use the "Skills and Training Fund" to top up your money, to pay for the rest of the course.

E.g. A course costs £65 per person. The grant is £60 per person, leaving £5 remaining.

The remainder could then be allocated from the Skills and Training Fund.

We would always recommend checking with your local CITB rep before booking on any training as they can help you get the best from both pots of money.

The “Skills and Training Fund” is only available to micro, small and medium sized companies.

Short Period Qualification Grants

There are now also higher amounts paid out to support employers who have supervisors and managers that need to train for a qualification (such as an NVQ) because the 'Industry Accredited' CSCS card will cease to exist by the end of next year.

CITB – SKILLS AND TRAINING FUND

Who is it available to?

As above, all CITB registered business across the UK and who are levy paying can access this funding.

The Skills and training fund is designed for you to invest in training and equipment for your workforce and mainly used as a 'top up' fund from the Grant, as long as the below criteria is satisfied:

- The training must improve the business, address challenges, or start new opportunities.
- Introduce new ways of developing the workforce.
- Introduce new skills into the business or address skills gaps.

Please note: CITB announced on 19th August that this will be closing from October 2025. Therefore any applications need to be applied for before the end of September 2025.

CITB – SKILLS AND TRAINING FUND

What are the funding levels?

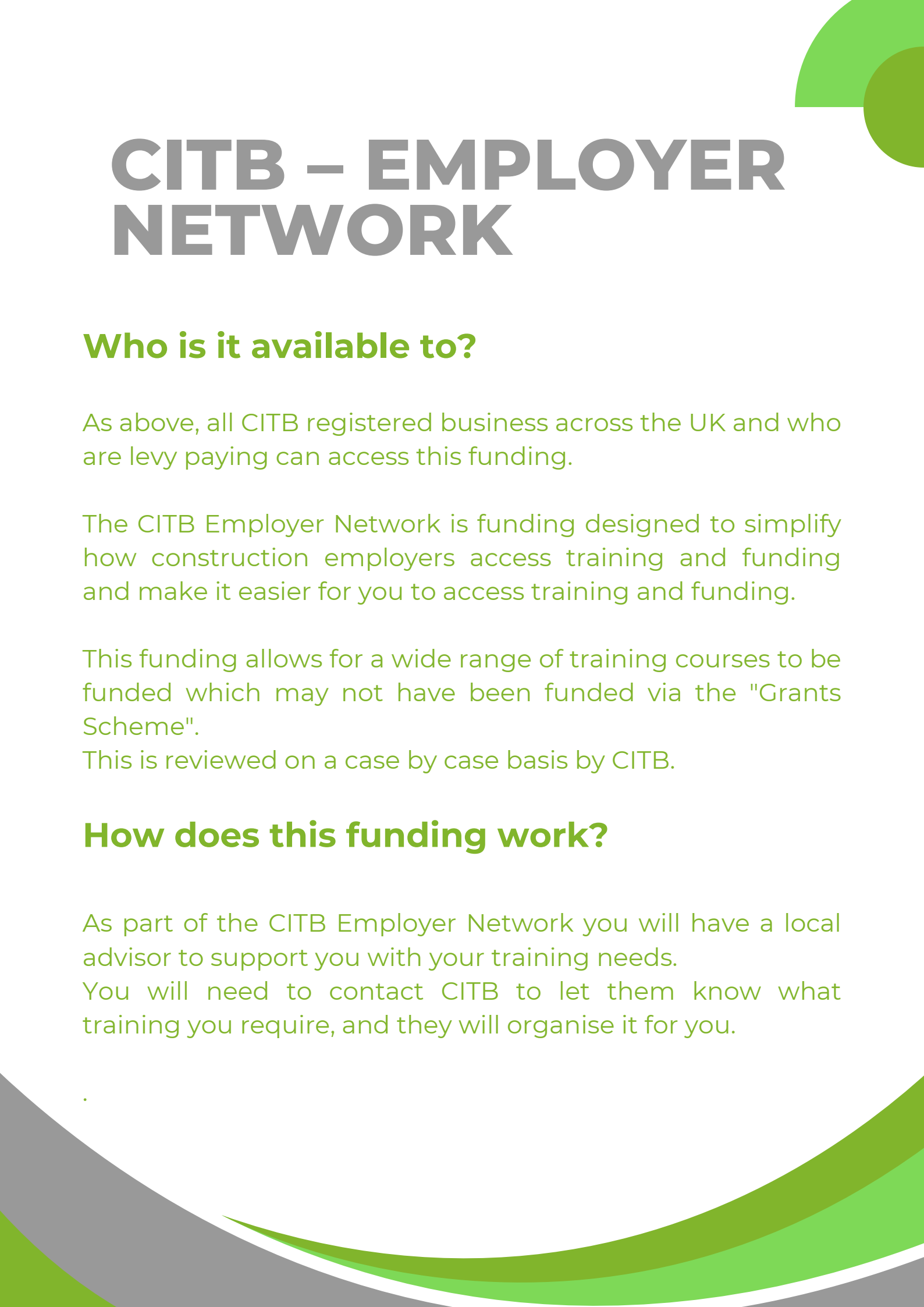
Below is the funding that is available, depending on the number of directly employed employees your company has:

- 1- 49 - £5,000
- 50- 74 - £7,500
- 75- 99 - £10,000
- 100- 149 - £15,000
- 150- 199 - £20,000
- 200- 250 - £25,000

The funding can be applied for twice in 12 months but you can only have 1 live project (claim) at a time.

It may be possible to claim for courses that have already commenced.

CITB – EMPLOYER NETWORK

Who is it available to?

As above, all CITB registered business across the UK and who are levy paying can access this funding.

The CITB Employer Network is funding designed to simplify how construction employers access training and funding and make it easier for you to access training and funding.

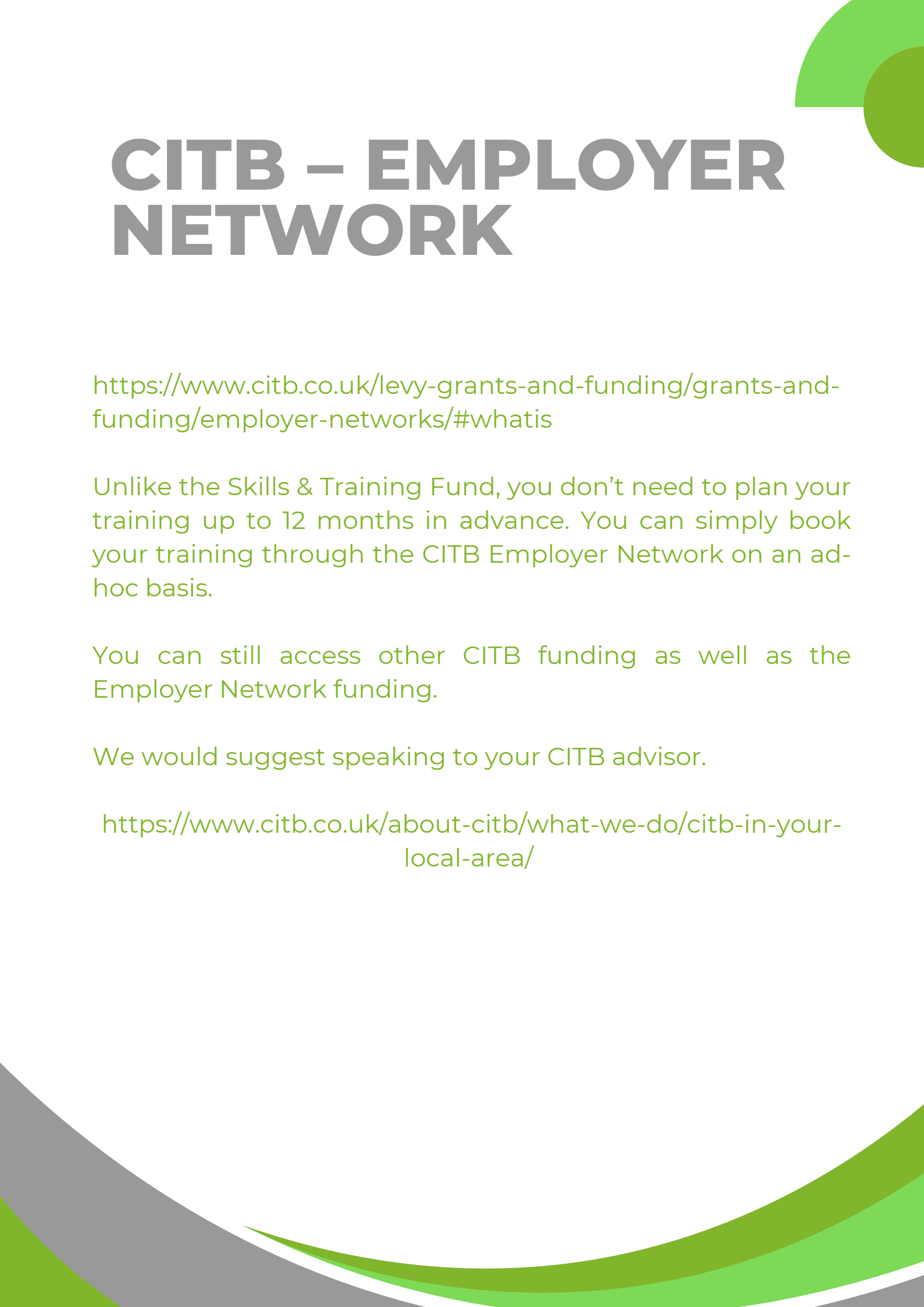
This funding allows for a wide range of training courses to be funded which may not have been funded via the "Grants Scheme".

This is reviewed on a case by case basis by CITB.

How does this funding work?

As part of the CITB Employer Network you will have a local advisor to support you with your training needs.

You will need to contact CITB to let them know what training you require, and they will organise it for you.



CITB – EMPLOYER NETWORK

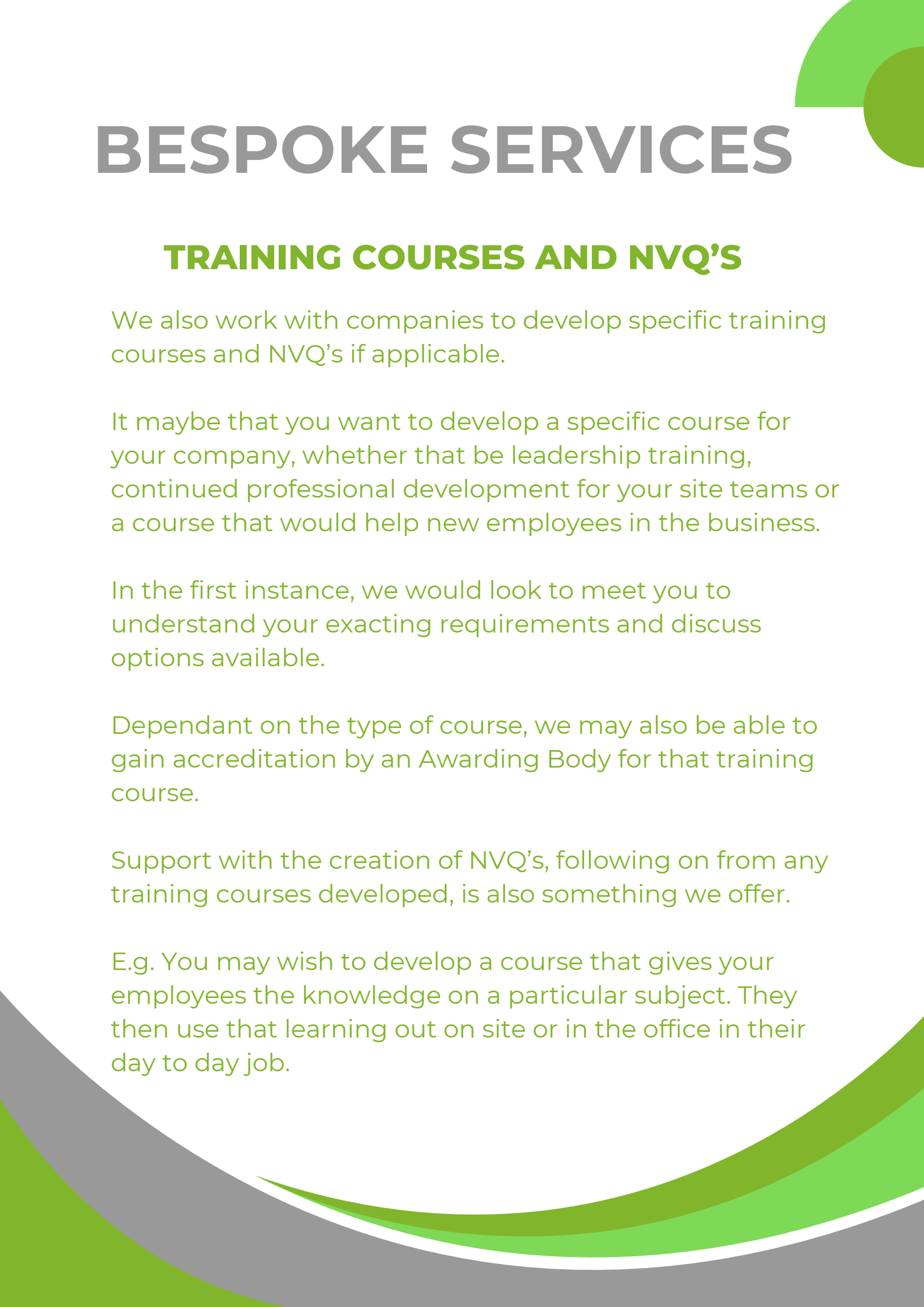

Unlike the Skills & Training Fund, you don't need to plan your training up to 12 months in advance. You can simply book your training through the CITB Employer Network on an ad-hoc basis.

You can still access other CITB funding as well as the Employer Network funding.

TRAINING COURSES AND NVQ'S

We also work with companies to develop specific training courses and NVQ's if applicable.

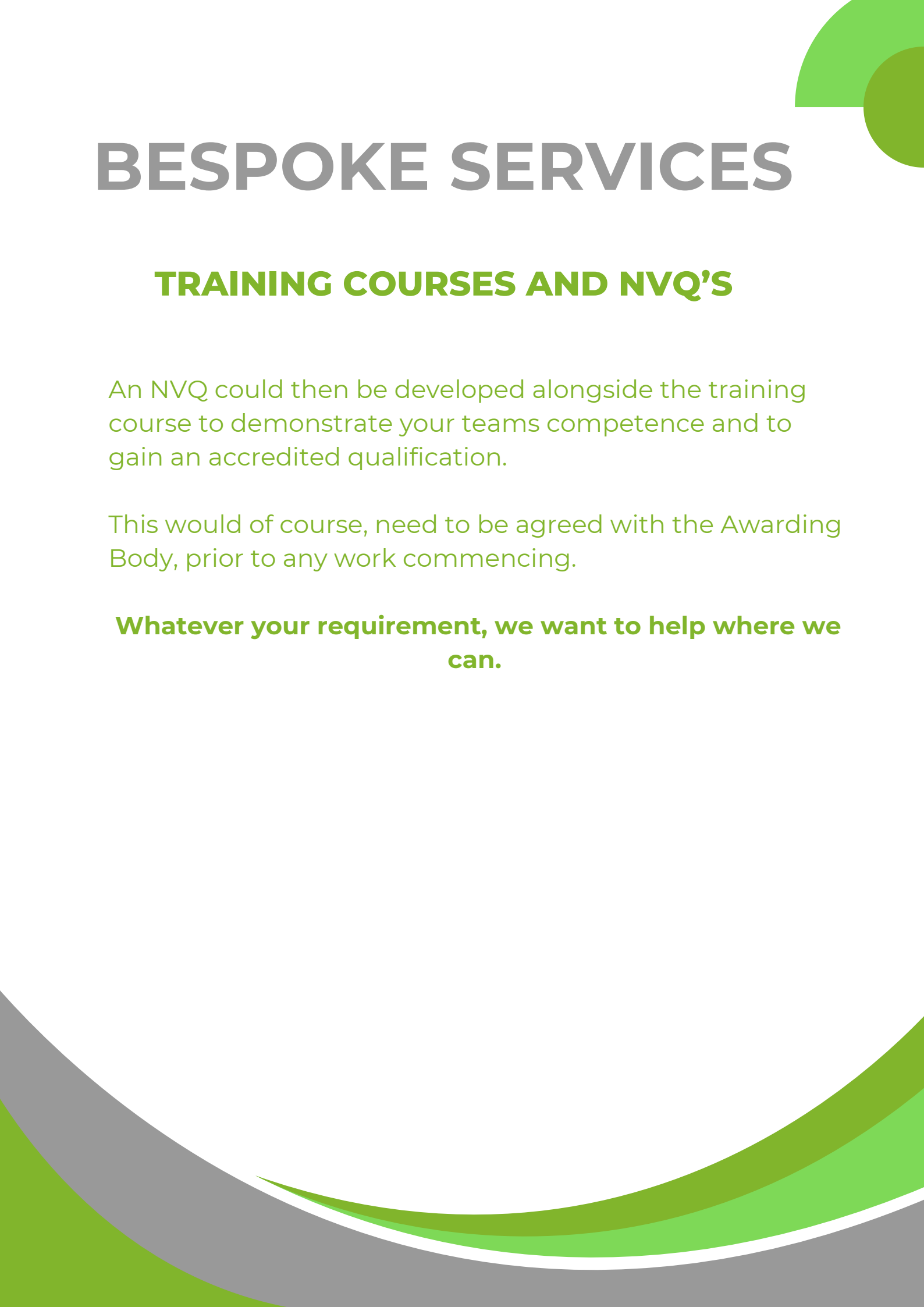
It maybe that you want to develop a specific course for your company, whether that be leadership training, continued professional development for your site teams or a course that would help new employees in the business.

AM I ELIGIBLE TO REGISTER WITH CITB?

In order to be eligible to register with CITB, your company must undertake work activity related to construction and it be listed on the Government's "Scope Order".

You will find a list of all the eligible construction activities on the CITB website.

Once registered, you will be registered for life so, please ensure you read their T&Cs before committing.

FAQ'S

WHERE CAN I GET HELP UNDERSTANDING AND APPLYING FOR FUNDING AND GRANTS?

In each area CITB have a regional advisor who will support you with understanding the following:

- What it means to be registered with CITB
- Understand more about the CITB Levy
- How to apply for Grant funding
- How best to utilise the Skills and Training Fund
- How to utilise the Employer Network funding

FAQ'S

THE GRANTS AND FUNDING SEEMS SIMILAR, WHAT IS THE DIFFERENCE?

The Grants are paid based upon completion of an NVQ or Short Course, and you may be able to claim back qualifications or courses already completed within the past 52 weeks.

There is no cap on the Grants Scheme other than for Plant related courses.

The Skills and Training Fund is to 'top up' your Grant if a short course or NVQ costs more than the Grant. It is also based upon you producing a plan of the qualifications and training you want to complete within the next 12 months.

This will be assessed by CITB and if approved, payment will likely come through fairly quickly.

There is, however a cap on the Skills and Training Fund available.

Due to the complexities of the two pots of money, we recommend you speak to your CITB regional advisor as they will be able to guide you on getting the most of out of both 'pots of money'.

FAQ'S

I AM SELF EMPLOYED, CAN I CLAIM THE GRANTS AND FUNDING?

As a self employed person, you cannot directly claim for the Grants and/or Skills and Training Fund.

However if you subcontract to a CITB registered company, they could, in agreement claim on your behalf.

They must, however be able to evidence that they have been paying you for works completed. E.g. Provide invoice evidence.

Please ensure you speak to your CITB representative for further guidance.
