**COVID-19 Information** – As the state begins to allow larger group gatherings, please be mindful, cautious, and smart. Wash your hands, face, and clothing while continuing to practice social distancing efforts. The city park will remain closed until further notice.

**Commissioner Interest** – If you are interested in running for a commissioner position, the filing for the election deadline is June 2, 2020. I do have a couple of extra Application for Candidacy Packets you can obtain and return to the Rowan County Clerk.

**Yard Sale Permit Reminder** – *Due to the circumstances, we have not authorized yard sales yet.* Perhaps we will be able to schedule on in June or July. When we do, each address may only have two per calendar year. That number excludes the city-sponsored yard sales (one spring & one fall), allowing resident address to have a total of 4-yard sales. The permits will be located in a box at the city building (385 Circle Drive).

**Census Reporting** – Judge Executive Harry Clark has reported that the City of Lakeview Heights has an 86.5% response rate to Census 2020. This is exciting for us, as well as beneficial, for a couple of reasons. 1) Reports numbers to help increase the City, County and State numbers for future funding for education, fire/police/EMS, assistance programs, highways, school lunch programs, plus more and 2) It is a record for genealogy purposes if you or a loved one is looking to reconstruct their family tree/history. **Dog Feces** – I have had several complaints of dog excrement left either on the road or in various residents' yards who do not have dogs. Please be considerate and pick up after your animal when you walk. Residents are watching.

**Parking in the Street** –Reminder: There shall be NO overnight parking in the street, on the edge of the street or half in the ditch and the street. This poses a risk for night traveling traffic, walkers and emergency vehicles. If you have overnight guests, have them park in the driveway or at the City building overnight.

**City Commissioner Meetings** – We will resume City Commissioner meetings on June 4 on the deck of the city building and maintaining our 6ft distance. All residents are welcome to attend but as a reminder, we will be practicing social distancing.

**Your Lakeview Neighbors Care** – If you need basic yardwork, housework, errands ran or other types of assistance during this difficult time, we have residents who have reached out and are willing to donate their time in order to help you meet these types of needs.
