

Riverbank Outlaws Corporation

Youth Tackle Football Liability Waiver, Release Agreement, and Parent Code of Conduct

IMPORTANT: THIS IS A LEGAL DOCUMENT. READ CAREFULLY BEFORE SIGNING. BY SIGNING THIS AGREEMENT, YOU WAIVE CERTAIN LEGAL RIGHTS.

1. Assumption of Risk

I, the undersigned Parent/Guardian, acknowledge and understand that participation in tackle football involves numerous inherent risks and dangers, including but not limited to: serious bodily injury, head and neck injuries (including concussion and traumatic brain injury), paralysis, disability, illness, and death. I voluntarily and knowingly assume all such risks, whether known or unknown, associated with my child's participation in the Program.

2. Waiver and Release of Liability

I hereby waive, release, and forever discharge Riverbank Outlaws Corporation, its directors, officers, employees, coaches, volunteers, affiliates, sponsors, insurers, and agents (collectively, the "Released Parties") from any and all claims, causes of action, demands, damages, losses, or liabilities (including attorneys' fees and costs) arising from or related to any injury, illness, accident, death, or property damage incurred by the Participant in connection with participation in any Program activities, whether caused by the negligence of the Released Parties or otherwise, to the fullest extent permitted by law.

3. Indemnification

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, demands, suits, actions, or liabilities (including reasonable attorneys' fees) arising out of or related to the Participant's involvement in the Program, including claims brought by or on behalf of the Participant or any third party.

4. Medical Authorization

In the event of an emergency, I authorize Riverbank Outlaws Corporation to obtain emergency medical treatment for the Participant, including transportation by ambulance if necessary. I agree to be solely responsible for any and all medical expenses incurred.

5. Photography and Media Release

I grant permission to Riverbank Outlaws Corporation to use photographs, video, or other media of the Participant for promotional, social media, or educational purposes without compensation or prior notice.

6. Binding Effect

This agreement shall be binding upon me, my child/ward, and our respective heirs, executors, administrators, successors, and assigns. If any portion of this agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

7. California Law Applies

This agreement shall be governed by and construed in accordance with the laws of the State of California. Any legal action or proceeding arising under this agreement shall be brought exclusively in a court of competent jurisdiction in California.

8. Parent Code of Conduct

As a parent/guardian of a participant in the Riverbank Outlaws Corporation Youth Tackle Football Program, I acknowledge that I play a critical role in fostering a positive, safe, and respectful environment. I agree to the following Code of Conduct:

- I will be responsible for my own behavior and that of my guests attending games or practices.
- I will provide positive support, care, and encouragement for my child and all other participants.
- I will encourage good sportsmanship by demonstrating respect for all players, coaches, officials, and spectators at every event.
- I will place the emotional and physical well-being of my child ahead of any personal desire to win.
- I will not bring outside food or drinks to games, whether home or away.
- I will remain in the designated spectator areas during practices and games.
- I will support safe play and advocate for trained, responsible coaching.
- I will not interfere with or attempt to coach my child or other participants during practices or games.
- I will refrain from using or bringing drugs, tobacco, or alcohol to any event. I will not attend under the influence of drugs or alcohol.
- I will remember that youth sports are for the children, not the adults.
- I will refrain from using profanity, abusive language, physical threats, or inappropriate gestures.
- I will not direct negative or insulting comments toward players, coaches, referees, or other spectators.
- I will ensure that my child treats others with respect, regardless of race, sex, ability, or background.
- I will make every effort to keep the youth sports experience enjoyable for my child and others.
- I will remain at (or designate a responsible adult to remain at) practices and games in case of emergency.

I understand that failure to adhere to this Code of Conduct may result in disciplinary action, including suspension or removal from team activities, at the discretion of Riverbank Outlaws Corporation staff.
