

## Nor'easter Solar Collector Limited Warranty

INroof.solar Inc. extends the following limited warranty to the owner of INroof.solar Nor'easter solar thermal collectors. The warranty is provided to the owner on the condition that the collectors remain installed at their original place of installation and are installed, used, and maintained in accordance to the operating manual.

### What Does This Warranty Cover?

INroof.solar warrants its Nor'easter solar thermal collectors will be free of defects in workmanship and material for a period of 10 years from the date of purchase.

### What Does This Warranty Not Cover?

This warranty shall remain valid for its term only in the case that the solar thermal collectors are installed in accordance with local plumbing and building codes, ordinances and regulations, and industry best practices.

Subject to applicable law, this limited warranty does not cover the following circumstances:

1. If the Nor'easter solar thermal collectors were reinstalled in a location other than the original site of installation.
2. If the claim for warranty coverage arises from damage caused by misuse, abuse, improper maintenance, alteration, accident, flooding, fire, settling of the house, acts of God or other circumstances beyond INroof.solar's control.
3. If the claim for warranty coverage arises from damage caused by additional components of your solar thermal heating system including, but not limited to roof framing, storage tank(s), heat pumps and management software.

Other than the obligations to the limited warranty herein, INroof.solar **DISCLAIMS, TO THE EXTENT PERMITTED BY APPLICABLE LAW, ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.**

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Please make sure to check your state's laws for additional rights.

### What Will We Do to Correct Problems?

If an INroof.solar Nor'easter solar thermal collector is found to have a defect, malfunction or other failure of the product in accordance with the coverage of this warranty, INroof.solar, in its sole discretion, will repair or replace the defective component part or collector.

In the case that INroof.solar determines the parts are defective and will be replaced, the defective parts must be returned to INroof.solar for the purpose of inspection determining the cause of failure.

### What Will We Not Do?

Unless originally installed by INroof.solar, we will not cover labor costs for any installation or reinstallation required to repair or replace a defective component part or collector.

All shipping costs associated with the repair or replacement of defective component parts or collectors shall be borne by the person claiming the warranty.

### How Do You Get Service?

If you have a warranty claim, you should contact the contractor who installed your collectors and ask that the contractor notify the distributor. If this action is not possible or you do not receive a response, you should contact:

The enclosed registration form must be filed within 90 days of purchase.

Do not allow the label bearing the serial number or other identifying information to be defaced or removed.

Purchase the Nor'easter from INroof.solar or an authorized reseller. Please contact INroof.solar to confirm authorized resellers.
