OVERVIEW

Terms of Use, also known as Terms of Service or Terms and Conditions, are legal agreements that govern the users of a service. These Terms often appear as disclaimers that must be agreed to in order to use a service.

For purposes of this agreement, "Site" refers to the Company's website and physical services, which can be accessed at jrocksrockinranch.com. "Service" refers to the Company's services, in which users can read and review about us, the events we cater and the different package options we offer. The terms "we", "us", and "our" refer to the Company. "you" refers to you as a user of our Site and/or our Service. "Company" refers to J-Rock's Rockin' Ranch.

(1) I and/or my child is participating voluntarily in a class, construction, preparation, and/or other activities sponsored by and/or coordinated at J-ROCK'S ROCKIN' RANCH site, its surrounding grounds or designated operating sites.

(2) I understand, accept, and assume the risks associated with my/or my child's participation in any and all activities. Our programs are designed to introduce you/ your child to the world of horses, livestock, and farming. Though we are committed to providing a safe environment for both humans and animals, these activities can be dangerous and accidents can happen. Under Arkansas Law, AR SECTION 16-120-201, 202 the Arkansas statute provides that an equine activity sponsor or an employee of an equine activity sponsor shall not be liable for an injury and or the death of a participant resulting from the inherent risk of equine activities.

RELEASE OF LIABILITY

Despite all known and unknown risks including but not limited to serious bodily injury, permanent disability, paralysis and loss of life, I, on behalf of myself, and/or on behalf of my spouse, minor child(ren)/ward(s) hereby expressly and voluntarily remise, release, acquit, satisfy and forever discharge and agree not to sue J-ROCK'S ROCKIN' RANCH, including its suppliers, designers, installers, manufacturers of any equipment or material in J-ROCK'S ROCKIN' RANCH facility (all hereinafter referred to as "EQUIPMENT SUPPLIERS") and agree to hold said parties harmless of and from any and all manner of actions or omission(s), causes of action, suits, sums of money, controversies, damages, judgments, executions, claims and demands whatsoever, in law or in equity, including, but not limited to, any and all claims which allege negligent acts and/or omissions committed by J-ROCK'S ROCKIN' RANCH or any EQUIPMENT SUPPLIERS, whether the action arises out of any damage, loss, personal injury, or death to me or my spouse, minor child(ren)/ward(s), while participating in or as a result of participating in any of the ACTIVITIES in or about the premises. This Release of Liability is effective and valid regardless of whether the damage, loss or death is a result of any act or omission on the part of J-ROCK'S ROCKIN' RANCH and/or any EQUIPMENT SUPPLIERS.

RULES FOR USER CONDUCT AND USE OF THE SERVICE

As a parent/guardian of a child under the age of 18, You are responsible for your child and his/her actions while interacting or participating with J-
