**\*\*\*VACCINATIONS\*\*\*** Owner is required to provide veterinary proof of current and updated **Rabies, Distemper, and Bordetella**. If for any reason your pet does not have proof of all vaccines a discussion will be made prior to the grooming appointment about next steps.

Due to this being a small salon with little to no overlapping dogs, a few exceptions at Barkin Bandits discretion may be made for the Bordetella vaccine.

**Barkin Bandit Grooming Client Agreement:**

This is an agreement made between the client and the grooming crew of Barkin Bandit. When signed all of the rules and stipulations are expected to be followed as written. Failure to do this could result in fees or banishment from the establishment. Barkin Bandit reserves the right to refuse service to a client's pet for any reason at any time.

## **Cancellation/Rescheduling**

Barkin Bandit requires a 24hr notice of any cancellations/reschedulings. Failure to provide this will result in a \$15 fee that is to be paid before your next grooming appointment is booked. If a client is a no-show they will be expected to pay the full price of the appointment that was missed. We understand there are emergency situations and will work with you, but not on a continued basis. Please be respectful of our time as we are a by-appointment business, and another client could have taken your appointment if we knew.

## **Flea & Tick**

If fleas or ticks are present on your pet during their groom Barkin Bandit has the right to provide a flea and tick bath. This is a veterinary shampoo that is used to kill fleas and ticks promptly to prevent them from spreading through the salon. The owner will be informed if this situation is to arise and it will be an additional \$15 added to the grooming appointment. Ticks found will be removed and an additional charge may be applied. If ticks are found, Barkin Bandit strongly suggests you have your pet tested for Lyme Disease or other tick borne illnesses. Please note that parasites are a health hazard to your pet as well as to humans.

## **Pick Up/Drop Off**

For everyone's safety, including your pets, every dog is required to be leashed during pick-up and drop-off.

Pet parents will receive a call/text 30min. before their pet is finished. Clients will then be expected to pick up their pet promptly, however must ensure that the groomer is completely finished with their pet beforehand. There is always the possibility an accident could occur. Grooming equipment is sharp, even though my groomer uses extreme caution and care in all situations, possible problems could occur including cuts, nicks, scratches, quicking of nails, etc. In most cases this can happen when a pet is wiggling or moving around. If you arrive to pick up your pet and they are still being groomed, please do NOT talk to them or allow him/her to see you. Every effort will be made to insure your pet is groomed as safely as possible, but an excited pet can be dangerous to continue to work on. If you insist on talking to your pet, or the groomer, Barkin Bandit reserves the right to end the grooming session, even if the groom is not completed, and the full grooming price will be charged.

## **Health of Pet**

Barkin Bandit is not responsible for any underlying health conditions that may be found during the grooming process, nor is Barkin Bandit reliable for health conditions that may arise after a grooming appointment. However, Barkin Bandit will inform you of anything that may look concerning and advise you to seek a vet if needed.

Many common health conditions may arise due to grooming such as skin irritation, rash, or infection especially if your pet was heavily matted or had fleas/ticks. Barkin Bandit will not be responsible for ANY medical issues/bills.

## Aggressive or Dangerous Pets

I agree that I MUST inform my groomer if my pet(s) bites, has bitten, or is aggressive to people, other pets or specific grooming procedures. Muzzles may be used if necessary. Muzzling will not harm your pet(s), and protects both the pet and the groomer. The groomer reserves the right to refuse/stop services for such pet(s) at any time before or during the grooming process, and charge a handling fee for aggressive pets in addition to the regular grooming charge.

If the pet should bite, I agree to be responsible for any and all related medical bills, recovery costs, loss of income and equipment damage.

## Mat Removal

Pets with matted coats need extra attention during their grooming session. Mats left in a pet's coat only grow tighter, and can strangle the pet's skin, or eventually tear it open. Barkin Bandit does not wish to cause serious or undue stress to my pet, and will not continually de-mat my pet for me. Mats can be very difficult to remove, and may require the pet to be shaved. By signing this contract I agree that Barkin Bandit can shave my pet if deemed necessary due to excessive matting. There is an extra charge for dematting.

I have read and agree to the policies of Barkin Bandit Grooming and It is also further understood and agreed the terms of this agreement can change at any time, without notice, and will overwrite any and all prior signed contracts or releases.
