The organizers reserve the right to select vendors and assign tables based on the items to be sold so the best variety can be offered to the visitors. You will receive confirmation of your reservation or, in the event we cannot accommodate you, your payment will be returned.

Only wall tables have an electrical hook up (120V). Vendor space is limited and pre-registration is required. Vendors agree to abide by all sales tax laws of West Virginia and are solely responsible for the collection and payment of these taxes. Vendor set up on Saturday 7:30 am – 9:00 am. Bring your own table covers and extension cords when needed.

Space will not be guaranteed until payment is received. A forfeit of payment will occur for no shows.

All vendors and their assistant(s) are required to sign the liability waiver (see back).

Upon arrival, vendors will receive a ticket for one (1) bratwurst or one (1) bowl of soup and a glass of complimentary glüweïn or spiced tea per purchased table. Coffee is available to vendors free of charge.
