

FULTON FINDINGS LLC SOFTWARE LICENSE AGREEMENT READ THIS LICENSE CAREFULLY BEFORE USING THIS PACKAGE

FULTON FINDINGS IS WILLING TO LICENSE THE SuperSMITH® SOFTWARE (“THE SOFTWARE”, “The software”, or “the software”) TO YOU ONLY UPON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS CONTAINED IN THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, DO NOT PURCHASE THE SOFTWARE. BY INSTALLING AND ACTIVATING (OR CONVERTING FROM DEMO TO FULL) THE SOFTWARE, YOU ACKNOWLEDGE THAT YOU HAVE READ THIS AGREEMENT AND UNDERSTAND IT AND YOU AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THIS LICENSE DO NOT PURCHASE THE SOFTWARE. INSTALLING AND ACTIVATING THE SOFTWARE INDICATES YOUR ACCEPTANCE OF THE TERMS OF THIS LICENSE.

The software is licensed, not sold, to you by Fulton Findings for use only under the terms of this License, and Fulton Findings reserves any right not expressly granted to you. As Licensee, you own the media upon which the software is fixed, but Fulton Findings retains title and ownership of the software recorded on the original media and all subsequent copies of the software regardless of the form or media in which or on which the original and other copies may exist. This License is not for a sale of the software or any copy.

In return for acquiring a license to use the software and related documentation, you agree to the following terms and conditions:

1. **License.** This agreement grants you, the Licensee, a License to:
 - a) If you have purchased a single copy of the software, you may use it on a single computer at a time. If you have multiple computers (e.g. a desktop and a laptop), you may install the software on both computers PROVIDED that no one other than the licensed user is using the software at any given time.
 - b) If you have purchased a quantity of licenses (less than 50), you may install them on single computers up to the number of licenses purchased. Or you may load the software on a server used by the purchaser’s workers for purchaser’s activities by limiting the number of simultaneous users to the quantity purchased.

4. **Limited Warranty:** Fulton Findings warrants only that the media upon which the software is delivered will be free from defects in material or workmanship under normal use and service for a period of thirty (30) days from your date of purchase. FULTON FINDINGS DOES NOT AND CANNOT WARRANT THE PERFORMANCE OR RESULTS YOU MAY OBTAIN BY USING THE SOFTWARE OR DOCUMENTATION.
