UTRSOL RESEARCH ACTION COMMITTEE (URAC)

1. As a civilian component that is not attached to the legislature, this committee would be the alternate side of the Sex Offense Management Advisory Committee (SOMAC), interacting and collaborating with them to provide research, facts, statistics, and experience in their role to provide the legislature with better approaches to the registry. As a civilian arm of this movement, we could interact with the public in a way that SOMAC, as part of the legislature, required to be non-partisan, cannot.
2. With the number of bills pushed out during the January-March legislative sessions, the committee would function as a check and balance against bills that may be pushed out that would greatly affect the registry population and its collateral victims. As a body of professionals, this committee would have more weight with the legislatures and the public as well as with the news media when the case arises that they pursue an emotional based argument.
3. As a body of professionals that does not have a criminal background, it would give UTRSOL additional legitimacy with the public and legislative bodies we intend to engage with. Having mental health professionals either on our board, working with our support group, or on this committee establishes us in an additional way as legitimate after we have incorporated as an official entity in Utah.

UTRSOL LEGAL WORKING GROUP (ULWG)

1. UTRSOL needs the involvement of attorneys within our organization to execute one part of our goals and objectives.
2. Our organization also needs attorneys to sit in on our Board of Directors to establish more legitimacy and credibility with the public and legislative bodies we intend to engage with. At the current moment, UTRSOL will be pursuing incorporation within the next few weeks to become a legal entity in the state of Utah. We intend to move forward with nonprofit 501(c)(3) status in the near term and then 501(c)(4) status later this year or early part of next (for the purpose of lobbying the legislature).
3. When UTRSOL becomes a 501(c)(4) nonprofit, we intend that members of the Working Group also stand in as the Board of Directors for the future organization which will retain the Utah for Rational Sex Offense Laws (UTRSOL) organization name. The 501(c)(3) will form it's own Board of Directors and will hold the name of it's support Group, AfterMath Alliance Foundation.
4. This involvement will allow for the coalescence of attorneys throughout the state of Utah to organization to form a more cohesive voice in the desire and attempt to change the registry laws across the state.

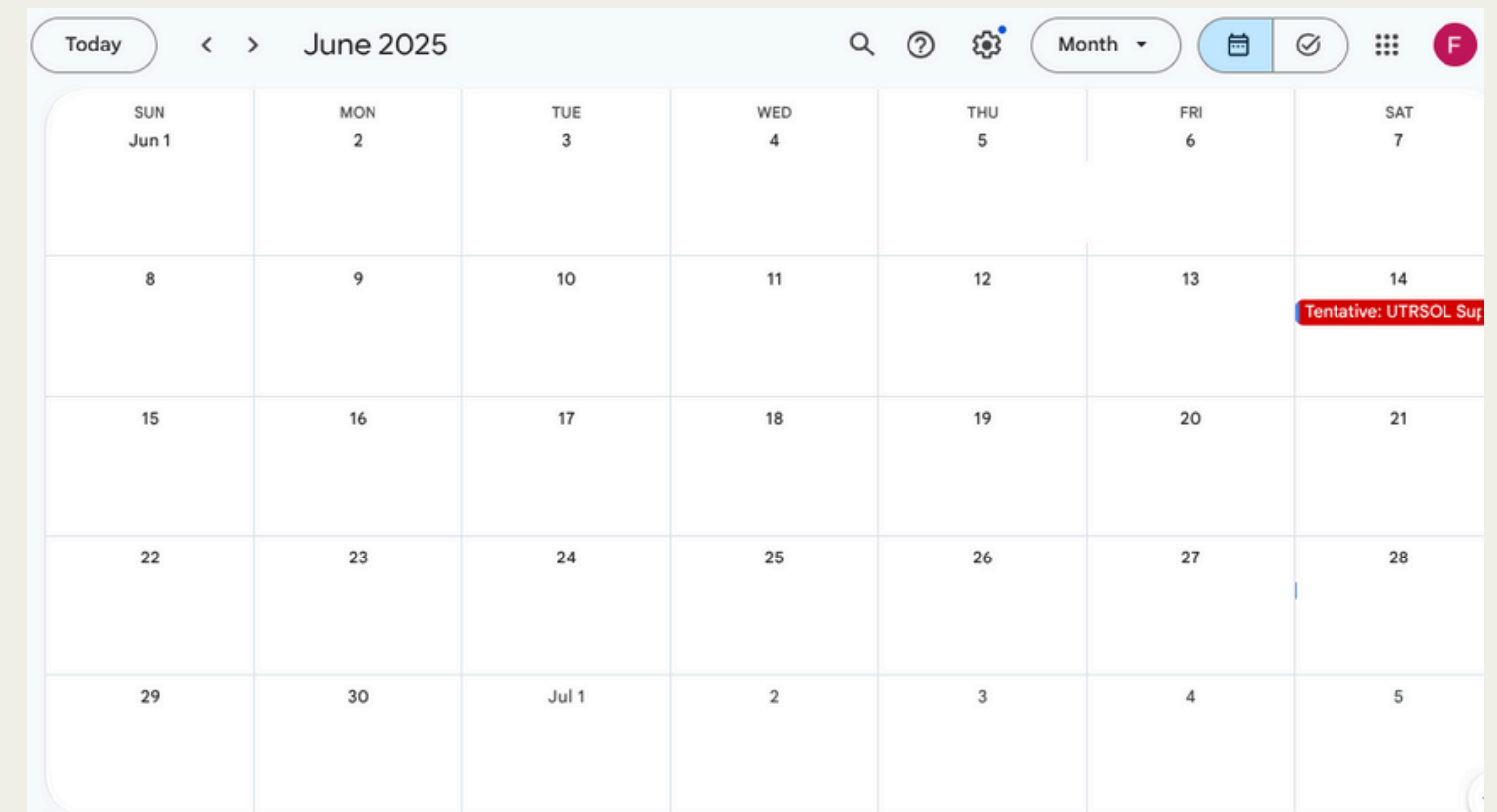

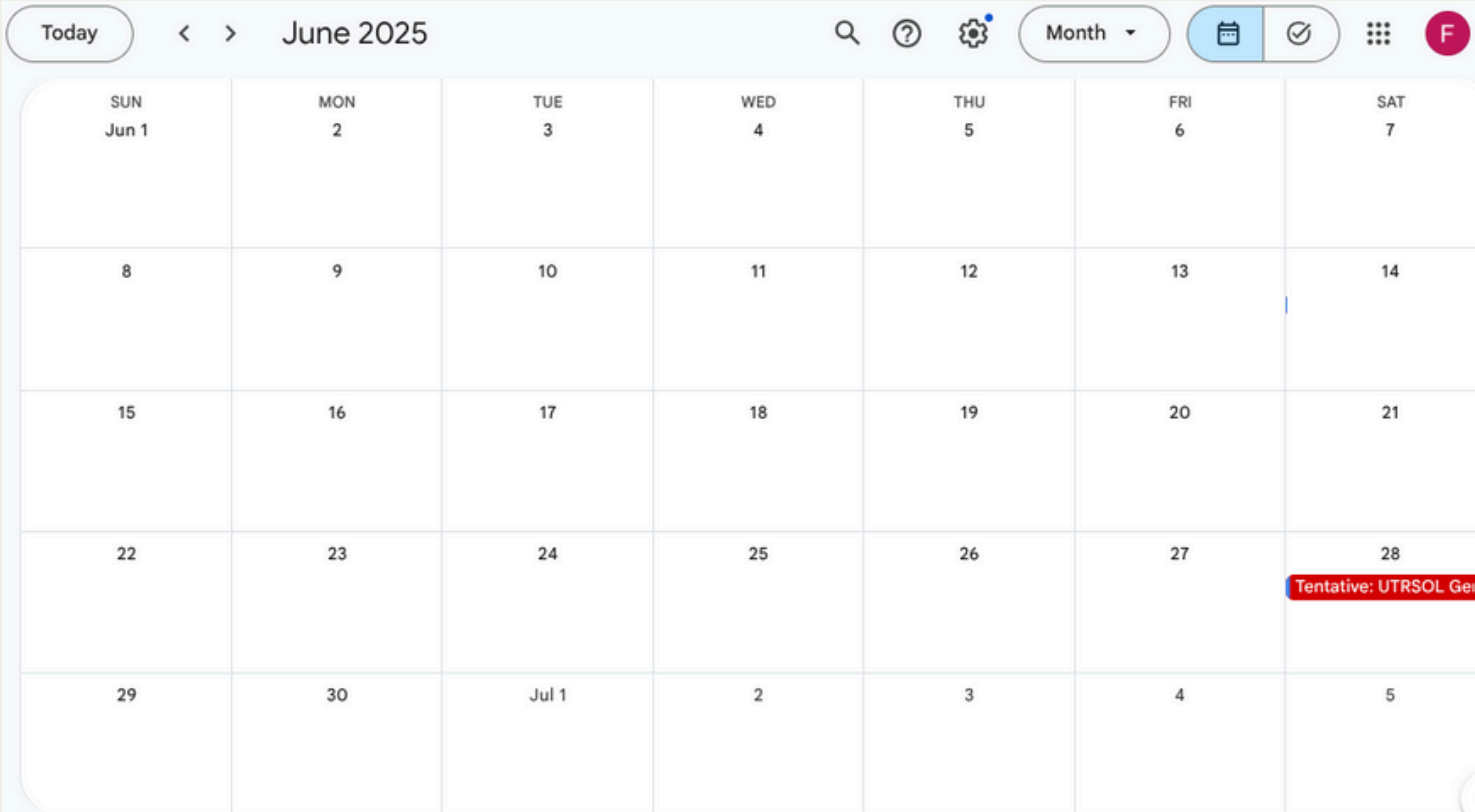
