## A. Treasurer's Report

We have spent a lot of money on the Arborvitaes, so Betsi wanted to wait to see if we had the money to do it. We could ask Don Harkins if he will come in with his loader to remove the wooden bed first, and then we could ask for neighborhood volunteers to help dig it up. Lanice will take a look and report back. Also, March or April might be an easier month to tackle this project.

The board also discussed possibly changing the name of the form to, "Project Approval Application" or similar. It is hoped that this will help clarify the intent behind the need for the form.
