 - -Fenced in grass is really long. Lawn people did mow it the last time. There was an arrangement made when Betsy was on the board. Until recently, the lawn people were mowing the lawn. No other fenced in areas are getting mowed. Sonya is going to talk to Amy Farley about the lawn care.
 - -Should bylaws be changed?
 - -Some changes were made but were never reported to the state
