# Mammoth Hollow Board Meeting Minutes- Thursday August 11, 2011

### I. Old Business:

#### A. Status on the Website:

The board is in the process of re-establishing the Mammorth Hollow website. Content will be purchased for <a href="www.mammothhollow.com">www.mammothhollow.com</a> website for \$250. We would still have to pay a service such as GoDaddy.com \$9.00 a year to register the domain name. Dan Daddieco is no longer creating or supporting websites. He is just selling us the old content that was on the website.

B. Repair of roads, driveways, curbs, removing weeds from sidewalks etc. We are getting quotes for repair. We have been taking quotes for crack sealing the whole association found that areas where the asphalt is cracked like a spider web is not sealable. It is better to repair these areas. During hot weather the sealer can stick to tires and be peeled up. We are taking quotes to repair 2 man holes. One is a sere man hole in front of #33; the other is a drain man hole in front of #30. Also being quote are three storm drains that need repairs now. One is in front of #28 and the next two are opposite each other between #14 and #26. We also are getting quotes to replace or repair two very bad sections of pavement. The first is the short access to #12 and #10. The other is in the intersection of the main road and the access to units #16, 18, 20 and 24.
