New Business

A review of the Band Booster Bylaws has been completed by a committee of volunteer booster members. The committee members are Kristy Swaim, Cory Newby and Brittany Sapien-Vance.

Presented by Kristy Swaim, the following changes to the Bylaws are recommended by the committee.

- Article II, Purpose
 - Line item A. Recommended change: correct grammar by adding a space.
 - Vote passed unanimously.
- Article III, Membership
 - Line Item H. Recommended change: correct grammar by deleting "a"
 - Vote passed unanimously.
 - Line Item H. Recommended change: band director to be an automatic fifth executive board member Or Band director will act as tie breaking vote.
 - Table discussion- Mr. Doyle to confirm this is within the district guidelines.
- Article IV, Executive Board and Their Election
 - Line Item F Recommended change: add wording "Nominees for treasurer must have a background in finance or previous experiences with Quickbooks or other accounting software.".
 - Line Item F Recommended change: correct typographical error. Replace word "possessions" with "positions"
 - Line Item G Recommended change: add Line Item G to remove term limits from Executive Board positions.
 - Vote passed unanimously.
- Article VI, Executive Board Committees
 - Line Item B. Recommended change: add sentence "Each committee will have a Chairman and the option for an assistant."
 - Line Item E./F. Recommended change: correct grammatical errors and wording to read "All branches of the Ranger Regiment must work cooperatively with the committee chair for all Fundraising, Concession, and Merchandising activities, with final approval by the executive committee within appropriate regulatory guidelines."

Bylaws discussion completed through Article VI and for the sake of time, further discussion of Bylaws is tabled. At the next meeting (April 8, 2024), resume with a vote on Article VI proposed changes and continue discussion beginning with Article VII proposed changes.

2024-2025 Budget Proposal presented by Julie Reed, President

Items of note:

- Budget for student leadership in 2023-2024 was \$2000. Increase student leadership budget amount to \$4000 for 2024-2025.
- Per Mr. Doyle, Percussion Tech salaries are funded by percussion fees and fundraising. They are not included in total band fees.
- Ranger Regiment fundraising goal for 2024-2025 will be \$55,000.

- 2024-2025 returning student band fee is \$835. (The total actual cost per returning student without the fundraising contribution is \$1200.)
 - Motion to accept 2024-2025 proposed budget by Cory Newby
 - Tina Winchestered seconded

Vote passed unanimously 21 yeas, 0 nays

Floor discussion:

Is the \$50 paid in full discount given at registration equitable? Should the band continue to offer the discount?

- The band typically incurs large expenses during summer band and early marching season. As a result of full payments made at registration, the band benefits by having more money available early in the year.
- If the paid in full discount was not offered, would the number of families utilizing a payment plan increase? If that happens, would it adversely affect the funds available to the band?
- The discount may be viewed as a "poor tax" on those who do not have the option to pay in full.
 - Miranda Kneisel motions to eliminate a paid in full discount
 - Kristy Swaim seconded

Vote passed 14 yeas, 7 nays
